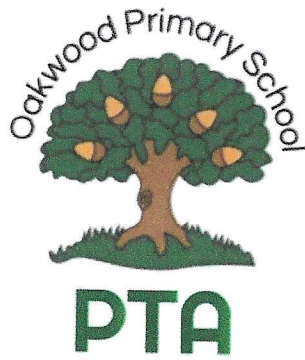

Structure, Governance and Management

Oakwood Association, trading name Oakwood Primary School PTA, is an unincorporated association governed by its constitution, adopted on 19 March 2003, updated on 6 March 2012. It is registered as charity 1102222 with the Charity Commission.

This annual report and accounts of Oakwood Association cover the period of 1 August 2024 to 31 July 2025.

Organisation

The Board of Trustees administers Oakwood Association along with the members. There must be at least two trustees. In the 2024-2025 financial year, the Trustees included: Clare Seldon (Chair, appointed at the AGM on 22 October 2024), Amy Wright (Treasurer), Laura Fyfe (Co-Secretary) and Samantha Bonfield (Co-Secretary, resigned on 22 October 2024).

The Board is committed to meet at least three times a year.

The organisation employed no permanent members of staff.

Appointment of Trustees

Trustees are appointed from its membership, by a majority vote, usually at the AGM.

Objectives and Activities

Objects

In setting our objectives and planning our activities the Trustees have given careful consideration to the Charity Commission's public benefit guidance.

The objects of the Association are to advance the education of pupils at Oakwood Primary School in particular

1. Developing effective relationships between the staff, parents and others associated with the school, including the local community and the public;
2. Engaging in activities or providing facilities or equipment which support the school and advance the education of the pupils.

Events

The charity carries out a wide range of activities in pursuance of its charitable aims. The trustees consider that these activities provide benefit both to those who attend Oakwood Primary School and the wider community.

Most events were old favourites like the Christmas events, Easter Hunt and Oakfest. But we also had our first Sip & Glass painting event and Postbox Topper at Easter. Overall we had fewer parent and larger events and many events have ceased to be run (Olympics, Quiz&Pizza, Karaoke, Burns night, hair braiding, coffee mornings, cake sales). Also match funding individuals have been unable to apply to their employers this year, which did reduce our income. Many of the events we were able to run exceeded previous costs (especially Oakfest) and to keep tickets reasonable for families during costof living impacts, we were then not able to make as much profit.

The PTA ran 27 events over the year (compared to over 30 events the year before), from regular second hand uniform and lolly sales, disco's and cinema nights to our larger events at Christmas, Easter, and the Summer. Most were fundraising ones but also ones with an emphasis on the environment. Our clothing re-sales have reached a significant landmark saving many clothes from landfill/recycling and making around £750 in total. We also continue to raise money via external sales with the likes of easyfundraising, Christmas Treeeasy and the Verulam School fireworks event which together added around £500.

We have continued to make a concerted effort to help encourage both the school and wider communities to reduce the use of single use plastic.

Financial Review

Spending

We were pleased to continue to receive a good number of requests over the year from teachers and noted a there remained a high number of requests for outdoor play equipment and lunchtime clubs which ties into our decision to continue to support the school in their Opal scheme.

When reviewing funding forms we continue to record and look back at what type of curriculum activity and across which Key Stages we have spent against to aim for a fair balance to all areas. We also report back on why funds were not allocated and encourage them to try again next term if we think relevant.

The MUGA (multi-use games arena) was installed in October half term 2024. Overall, The PTA have contributed £21,544, which equates to just over a third of the total cost.

Most of our funds were allocated towards the MUGA, but we were very pleased to welcome Gladiator Steel, aka Zack George, who shared a great morning with the children engaging them in a memorable fitness talk and meet and greet sessions.

Funding

Following our policy of spending money raised in the following financial year, our year end position is extremely positive, with our reserves sitting at £23,117 (2023: £42,589). Some of these funds have been requested by the school to be spent on expected future projects, related to the Opal (Outdoor Play and Learning) scheme. As such, we have no uncertainties about the charity continuing as a going concern as we have no fixed outgoings.

No funds are held as custodian trustees on behalf of others.

The future plans of the charity are to continue their activities in line with their objectives and continue to fundraise for the school, repeating many of the events of this year.

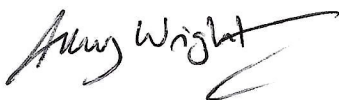

1 Accounting Policies

a) Basis of Accounting

The Oakwood Association is a Charity registered in England and Wales. It's registered address is Oakwood School, Oakwood Drive, St Albans, Hertsfordshire, AL4 0XA and it is a Public Benefit Entity.

The financial statements have been prepared in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102), published on 16 July 2014. The charity is a public benefit entity for the purposes of FRS 102 and therefore the charity also prepared its financial statements in accordance with the Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (The FRS 102 Charities SORP) and the Charities Act 2011.

The financial statements have been prepared to give a 'true and fair view' and have departed from the Charities (Accounts and Reports) Regulations 2008 only to the extent required to provide a 'true and fair view'. This departure has involved following Accounting and Reporting by Charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) issued on 16 July 2014 rather than the Accounting and Reporting by Charities: Statement of Recommended Practice effective from 1 April 2005 which has since been withdrawn.

The financial statements are prepared in sterling, which is the functional currency of the charity. Monetary amounts in these financial statements are rounded to the nearest pound.

The principal accounting policies, which are applied consistently, are set out below.

b) Going Concern Basis

The financial statements have been prepared on a going concern basis.

Having carried out a detailed review of the Charity's resources and the current economic challenges facing both the Charity and its members the Trustees are satisfied that the Charity has sufficient cash flows to meet its liabilities as they fall due for at least one year from the date of approval of the financial statements and that it is appropriate for the accounts to be prepared on the going concern basis.

c) Accounting Estimates

In the view of the trustees in applying the accounting policies adopted, no judgements were required that have a significant effect on the amounts recognised in the financial statements, nor do any estimates or assumptions made carry a significant risk of material adjustment in the next financial year.

d) Income

All income is accounted for when there is evidence of entitlement, the receipt is probable and the amount can be measured reliably.

e) Expenditure

All expenditure is included on an accruals basis and is recognised when there is a legal or constructive obligation for payment to be made.

f) Cash and Cash Equivalents

Cash and cash equivalents include cash at banks and in hand and short term deposits with a maturity date of three months or less.

1 Accounting Policies (continued)

g) Financial Instruments

The charity only holds basic financial instruments as defined by FRS 102. Financial instruments receivable or payable within one year of the reporting date are recognised at their transaction value and subsequently measured at their settlement price.

With the exceptions of prepayments and deferred income all other debtor and creditor balances are considered to be basic financial instruments under FRS 102.

h) Critical Accounting Estimates and Areas of Judgement

In the view of the trustees in applying the accounting policies adopted, no judgements were required that have a significant effect on the amounts recognised in the financial statements nor do any estimates or assumptions made carry a significant risk of material adjustment in the next financial year.

i) Volunteers

All our events are run and supported by parent volunteers who are members of the PTA and the trustees.

j) Trustees

No trustees were paid any remuneration or received any other benefit from the charity.
No trustees expenses have been incurred or reimbursed.

Events

The charity carries out a wide range of activities in pursuance of its charitable aims. The trustees consider that these activities provide benefit both to those who attend Oakwood Primary School and the wider community.

We had a relatively strong year, our summer fundraising was higher than last year due to extra lolly sales put on in the second half of the summer term. Our busiest time, Christmas, was not as profitable as the previous year with the Parents Xmas Party taking place in a new venue which reduced its profit by over £1,000. OAKFEST was its usual triumph in July and we appreciated the extra support from the school staff attending.

The PTA ran over 30 events last year, from regular second hand uniform and lolly sales, cinema nights, quizzes to our larger events at Christmas, Easter, and the Summer. We were lucky enough to have 2 (2023: 3) events match funded by parents employers which raised an extra £1,623 (2023: £2,700) to what the school & wider community donated!

We have continued to make a concerted effort to help encourage both the school and wider communities to reduce the use of single use plastic.

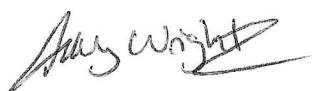

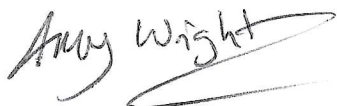

The financial statements are prepared in sterling, which is the functional currency of the charity. Monetary amounts in these financial statements are rounded to the nearest pound.

The objects of the Association are to advance the education of pupils at Oakwood Primary School in particular

1. Developing effective relationships between the staff, parents and others associated with the school, including the local community and the public;
2. Engaging in activities or providing facilities or equipment which support the school and advance the education of the pupils.

Events

The charity carries out a wide range of activities in pursuance of its charitable aims. The trustees consider that these activities provide benefit both to those who attend Oakwood Primary School and the wider community.

We had a strong year, managing to surpass our previous fundraising efforts. Our busiest time, Christmas, did well, exceeding previous records in the £2 Room thanks to enthusiastic organisation, and the Parents Xmas Party was its usual triumph. The move to bring the Christmas Fair back onto the school site seemed to suit our local community better, and to have all the stalls in one place was a welcome return towards normality. OAKFEST was its usual triumph in July and this year the rain held off to ensure a full day of fun and fundraising.

The PTA ran over 30 events last year, from regular second hand uniform and lolly sales, cinema nights, quizzes to our larger events at Christmas, Easter, and the Summer. We were lucky enough to have 3 events match funded by parents employers which raised an extra £2,700 to what the school & wider community donated!

We have continued to make a concerted effort to help encourage both the school and wider communities to reduce the use of single use plastic.

Financial Review

Spending

We were pleased to gain more requests over the year from teachers and noted a particular increase in requests for outdoor play equipment which ties into our decision to support the school in their Opal scheme.

When reviewing funding forms we continue to record and look back at what type of curriculum activity and across which Key Stages we have spent against to aim for a fair balance to all areas. We also report back on why funds were not allocated and encourage them to try again next term if we think relevant.

Our funding has enabled the school to purchase this year:

Several workshops and trips across all year groups, outdoor play equipment including space hoppers, cricket bats and play sand and a wide selection of books.

Funding

Following our policy of spending money raised in the following financial year, our year end position is extremely positive, with our reserves sitting at £41,578 (2022: £28,327). Some of these funds have been requested by the school to be spent on expected future projects, including the MUGA (multi surface games arena) and Opal (Outdoor Play and Learning) scheme. As such, we have no uncertainties about the charity continuing as a going concern as we have no fixed outgoings.

No funds are held as custodian trustees on behalf of others.

The future plans of the charity are to continue their activities in line with their objectives and continue to fundraise for the school, repeating many of the events of this year.

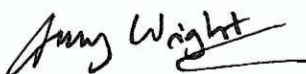

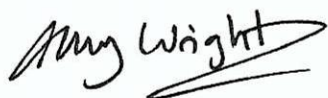

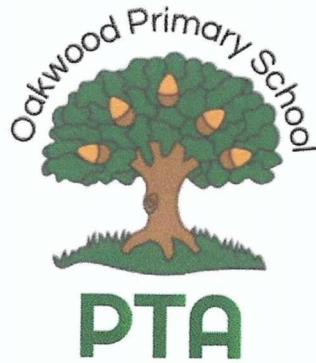

The adjustment to a Walking Fair at Christmas seemed to suit our local community well, although the organisation was challenging with stalls spread out so far. Easter was a major turning point, where we were allowed back onto the school grounds, and starting to have access to some indoor space. We were very pleased to have OAKFEST back in July with a new organiser to revamp it and to round up the school year.

The PTA ran over 30 events last year, from regular book, uniform and lolly sales, cinema nights, quizzes to our larger events at Christmas, Easter, and Summer. But we also encouraged new organisers to come forward with their own ideas, which led to a Karaoke Night, Sip & Paint art night, and Burns Night celebrations. We also had our first match funding event where Marie walked 100 miles and raised double the amount that the school & wider community donated!

We have made a concerted effort to help encourage both the school and wider communities to reduce the use of single use plastic.

Financial Review

Spending

We were pleased to gain more requests over the year from teachers and noted a particular increase in requests from parents who volunteer in school, once they were able to get back in once restrictions lifted. It allowed them to see what was really needed in the classroom – which was great to feed that back to school too.

When reviewing funding forms we are now able to record and look back at what type of curriculum activity and across which Key Stages we have spent against to aim for a fair balance to all areas. We also report back on why funds were not allocated and encourage them to try again next term if we think relevant.

Our funding has enabled the school to purchase this year:

Mini Trampoline, Diversity books, sports equipment, Library books, Maths and Science Equipment, Chromebooks, Defibrillator, Laughology workshop, Productive Behaviours workshop, SEN Equipment, New Hall Projector and trips.

Funding

Following our policy of spending money raised in the following financial year, our year end position is extremely positive, with our reserves sitting at £28,327 (2021: £20,430). As such, we have no uncertainties about the charity continuing as a going concern as we have no fixed outgoings.

No funds are held as custodian trustees on behalf of others.

The future plans of the charity are to continue their activities in line with their objectives and continue to fundraise for the school, repeating many of the events of this year.

1 Accounting Policies

a) Basis of Accounting

The Oakwood Association is a Charity registered in England and Wales. Its registered address is Oakwood School, Oakwood Drive, St Albans, Hertsfordshire, AL4 0XA and it is a Public Benefit Entity.

The financial statements have been prepared in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102), published on 16 July 2014. The charity is a public benefit entity for the purposes of FRS 102 and therefore the charity also prepared its financial statements in accordance with the Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (The FRS 102 Charities SORP) and the Charities Act 2011.

The financial statements have been prepared to give a 'true and fair view' and have departed from the Charities (Accounts and Reports) Regulations 2008 only to the extent required to provide a 'true and fair view'. This departure has involved following Accounting and Reporting by Charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) issued on 16 July 2014 rather than the Accounting and Reporting by Charities: Statement of Recommended Practice effective from 1 April 2005 which has since been withdrawn.

The financial statements are prepared in sterling, which is the functional currency of the charity. Monetary amounts in these financial statements are rounded to the nearest pound.

The principal accounting policies, which are applied consistently, are set out below.

b) Going Concern Basis

The financial statements have been prepared on a going concern basis.

Having carried out a detailed review of the Charity's resources and the current economic challenges facing both the Charity and its members the Trustees are satisfied that the Charity has sufficient cash flows to meet its liabilities as they fall due for at least one year from the date of approval of the financial statements and that it is appropriate for the accounts to be prepared on the going concern basis.

c) Accounting Estimates

In the view of the trustees in applying the accounting policies adopted, no judgements were required that have a significant effect on the amounts recognised in the financial statements, nor do any estimates or assumptions made carry a significant risk of material adjustment in the next financial year.

d) Income

All income is accounted for when there is evidence of entitlement, the receipt is probable and the amount can be measured reliably.

e) Expenditure

All expenditure is included on an accruals basis and is recognised when there is a legal or constructive obligation for payment to be made.

f) Cash and Cash Equivalents

Cash and cash equivalents include cash at banks and in hand and short term deposits with a maturity date of three months or less.

1 Accounting Policies (continued)

g) Financial Instruments

The charity only holds basic financial instruments as defined by FRS 102. Financial instruments receivable or payable within one year of the reporting date are carried at their at transaction price and subsequently at amortised cost.

With the exceptions of prepayments and deferred income all other debtor and creditor balances are considered to be basic financial instruments under FRS 102.

h) Critical Accounting Estimates and Areas of Judgement

In the view of the trustees in applying the accounting policies adopted, no judgements were required that have a significant effect on the amounts recognised in the financial statements nor do any estimates or assumptions made carry a significant risk of material adjustment in the next financial year.

i) Volunteers

All our events are run and supported by parent volunteers who are members of the PTA and the trustees.

j) Trustees

No trustees were paid any remuneration or received any other benefit from the charity. No trustees expenses have been incurred or reimbursed.

k) Related Party Transactions

There were no related party transactions in the year, or previous year.
