The Charity is controlled by its governing document, a deed of trust, and constitutes an unincorporated charity.

Organisational structure

The Charity is governed by its constitution and is constituted as a charitable trust.

The trustees are responsible for the overall management and control of the Charity and meet regularly to manage its affairs.

Risk management

The trustees have a duty to identify and review the risks to which the Charity is exposed and to ensure appropriate controls are in place to provide reasonable assurance against fraud and error.

The managing trustees have assessed the major risks to which the Charity is exposed, in particular the risk that lack of funds will prevent the Charity from achieving its aims and objectives. Since introducing more fundraising events, including schemes such as that of £1,000 donations from members who can afford it, the Charity has taken appropriate steps in order to ensure that sufficient funds are in place and thereby ensuring the Charity is able to continue its present activities.

- c) Informing members of training and education opportunities in the city to improve their knowledge and skills.
- d) Having a Religious School in order to teach children.
- e) Running religious programs in the holy Islamic months of Muharram, Safar, Ramadhan etc

FINANCIAL REVIEW

Principal funding sources

The association receives subscriptions as well as raising funds at different events. Since November 2007 a membership fee of £40 per month has been collected. There are over 90 members who pay regular membership fees.

The association also raises funds of £1,000 per member or family for those who can afford it.
