TO RELIEVE SIERRA LEONEAN WOMEN IN LONDON WHO ARE IN CONDITIONS OF NEED, HARDSHIP OR DISTRESS THROUGH THE PROVISION OF EMOTIONAL SUPPORT AND FINANCIAL ASSISTANCE WHEN POSSIBLE.
