(II) THE ADVANCEMENT OF EDUCATION BY THE PROVISION OF FINANCIAL ASSISTANCE TO FURTHER THE CHARITABLE WORKS OF THE TECHNION IN HAIFA AND THE HEBREW UNIVERSITY IN JERUSALEM, ISRAEL. (III) THE RELIEF OF FINANCIAL HARDSHIP, EITHER GENERALLY OR INDIVIDUALLY, OF PEOPLE LIVING IN THE UK OR ISRAEL BY MAKING GRANTS OF MONEY FOR PROVIDING OR PAYING FOR ITEMS, SERVICES OR FACILITIES, THE RELIEF OF THE SICK-POOR, LIVING IN THE UK OR ISRAEL EITHER GENERALLY OR INDIVIDUALLY THROUGH THE PROVISION OF GRANTS, GOODS OR SERVICES. (IV) SUCH OTHER CHARITABLE DONATIONS TO ORGANISATIONS WHICH ARE CHARITABLE IN NATURE AS THE TRUSTEES IN THEIR ABSOLUTE DISCRETION SEE FIT.
