Objects: 1. TO PROMOTE OR UNDERTAKE RESEARCH FOR THE BENEFIT OF THE PUBLIC IN THE FIELD OF HEAD AND NECK TREATMENTS AND TO DISSEMINATE THE USEFUL RESULTS OF SUCH RESEARCH.

This includes ear and hearing problems, nose problems, cataract and eye problems, mouth and throat problems as well as major head and neck cancers.
