It is also used for social gatherings and available for private functions for residents of The Lee & Lee Common community. The Lee Parish Hall charity also includes a tarmac fenced single tennis court which is available for hire to local residents, the owned land also includes a small car park and small recreation space containing baseball hoop/football goal
Summary of the main activities in relation to those purposes for the public benefit, in particular, the activities, projects or services identified in the accounts.	Para 1.17 and 1.19	Main activities: The first half of the reporting period was affected by Covid-19 restrictions resulting in decreased activity in accordance with government defined restrictions. The activities that have taken place during the reporting period include a weekly upholstering class, community meetings, use of the hall as a polling station, hire by local scouts, community social fundraising event (Roving Supper) and multiple private hire events.
Statement confirming whether the trustees have had regard to the guidance issued by the Charity Commission on public benefit	Para 1.18	When considering our objectives for the year and planning our activities, the trustees have considered the Charity Commission's guidance on public benefit and fee charging. In setting the level of fees the trustees give careful consideration to ensure accessibility of the hall facilities to the community it serves. The fees are set at a level which covers costs and ensures sufficient funds remain available for maintenance and upkeep of the hall, tennis courts and grounds without generating excessive reserves.

Para 1.20	<p>At the start of the reporting period some COVID-19 restrictions were still in place and restrictions were gradually eased in accordance with government guidelines. As restrictions were eased more activities could take place in the hall and the tennis court was reopened. During the COVID restrictions a covid grant was received from Bucks CC and in return the Lee Parish Hall was able to make a donation of £2, 500 to the local Infant school serving local residents to help with ICT requirements to facilitate teaching continuity during COVID restrictions. This donation is an example of the Lee Parish Hall meeting one of the objectives to help educate young people in the local community.</p> <p>The Lee Parish Hall was able to hold its annual fundraising 'Roving Supper' with some Covid 19 adaptations and on a smaller scale having been cancelled completely in 2020.</p> <p>The annual bonfire night and fireworks also took place. These are examples of the Lee</p>

		Parish Hall meeting its objective of providing social and leisure time for the wider community. Regular bookings for upholstery classes provide adult education opportunities. Once Covid restrictions allowed, the hall was used on a regular basis for community meetings, and multiple private hire social gatherings thereby meeting the objectives of The Lee Parish Hall Charity.

A description of the principal risks facing the charity	Para 1.46	During this reporting period the Covid-19 pandemic posed a significant event affecting the financial performance and financial position of the Lee Parish Hall. The Income was higher than in previous years due to receipt of Covid grant payments from the local council. The easing of Covid-19 restrictions during the second half of the reporting period enabled the usual income channels of The Lee Parish Hall to resume. As a result, the charity exceeded the Charity Commission threshold for submitting an additional annual report to accompany the annual accounts


