Report of the trustees for the year ended 31st March 2022

The Trustees are pleased to present their Annual Report together with the Consolidated Financial Statements of the charity for the year ended 31st March 2022, which are also prepared to meet the requirements for a Directors' Report and accounts for Companies Act purposes.

The Financial Statements comply with the Charities Act 2011, the Companies Act 2006, the Memorandum and Articles of Association, and Accounting and Reporting by Charities; Statement of Recommended Practice 2015, applicable to charities preparing their accounts in accordance with the Financial Reporting Statements for Smaller Entities.

The Trustees report a busy year with Hall income going up post the COVID-19 pandemic, and significant external works undertaken to develop the outside garden space. This work was ongoing at the year end with expected completion in 2022/23.

Community Hall refurbishments:

Our significant refurbishment plan continued in the year to redesign our outside space for community use and we recognised significant grant received in our income to help us fund this work.

The Community Hall is owned by the Swansea and Brecon Diocesan Trust and leased to the Community Hall Trust on a 30 year term, which this year has been extended to 35 years. Although the Hall trust is responsible for all external and internal repairs, it will not benefit from any increase in value to the property, does not hold the lease for the substantial part of the property's life and is subject to some restrictions in use. On this basis the lease is treated as an operating lease.

Chair's Report

I am delighted to see the near completion of the significant external works started last year. This along with property improvements made over recent years will benefit future generations. It is also pleasing to see the Hall use increasing again as we came out of the COVID-19 pandemic.

In closing, I would like to thank our sponsors and our volunteer supporters for their valuable contributions.

Structure, Governance and Management

The organisation is a charitable company limited by guarantee, incorporated on 5th March 2003 and registered as a charity on 6th June 2004. The company was established under a Memorandum of Association, which established the objects and powers of the charitable company and is governed under its Articles of Association. In the event of the company being wound up, members are required to contribute an amount not exceeding £10.

Recruitment and Appointment of the Management Committee

The directors of the charity are also the trustees for the purposes of charity law and also under the company's Articles. Under the requirements of the Memorandum and Articles of Association, one third of the directors, or if their number is not three or a multiple of three, the number nearest to one third must retire from office. If there is only one director, he or she must retire.

The directors to retire by rotation shall be those who have been longest in office since their last appointment. If any directors became or were appointed directors on the same day, those to retire (unless they otherwise agree amongst themselves) be determined by lot.

The directors seek to ensure an appropriate combination of diverse and community representation within a trustee body and amongst the directors. In the event of the need for a particular skill or community representation resulting from retirement/s/resignations or changed circumstances, individuals are approached to offer themselves for trusteeship and/ or directorship.

Trustee induction and Training

Most trustees are already familiar with the weight of their responsibilities as trustees, including the charity's Memorandum and Articles of Association, legal obligations, written policies, governance and management.

Newly appointed trustees are provided with a document containing comprehensive information about the charity and its aims and objectives; which also underlines their obligations and legal responsibilities as trustees and explains the charity's written policies and procedures covering good governance and management.

Risk Management

The trustees have conducted their own review of major risks to which the charity is exposed and systems have been established to mitigate those risks. Significant external risks to funding have led to the charity to develop a strategic plan, which will allow for the diversification of funding and activities. Internal risks are minimised by the implementation of procedures for authorisation for all transactions and projects and to ensure consistent quality of delivery for all operational aspects of the charitable company. These procedures are periodically reviewed to ensure that they still meet the needs of the charity.

Our objectives and activities

The purposes of the charity are to renovate and operate the former Church Hall in Llanrhidian, which is now run as a Community Hall. To further the provision of accommodation for social meetings, entertainment and activities which enhance the welfare of the community.

The charity relies on hire fees, charges and fund raising activities to cover its operating costs. The trustees have had regard to the Charity Commission's guidance on public benefit.

Achievements and Performance

The hall is used regularly by a wide variety of user groups, bringing in a regular income. However, fund raising is still a fundamental part of the charity's business. The strategies employed to achieve the charity's aims and objectives are to:

- * Present a broad range of activities
- * Offer opportunities for a wide range of people to get involved
- * Provide hall, stage and kitchen facilities
- * Concentrate on involving both young and senior age groups

Our volunteers

The Trust is very involved in the community and relies heavily on voluntary help. The trustees wish to thank their friends for their loyal support and service through out the year.

Accounting policies

Policy for the recognition of any capitalised development expenditure

The Community Hall is owned by the Swansea and Brecon Diocesan Trust and leased to the Community Hall Trust on a 30 year term, which this year has been extended to 35 years.. Although the Hall trust is responsible for all external and internal repairs, it will not benefit from any increase in value to the property, does not hold the lease for the substantial part of the property's life and is subject to some restrictions in use. On this basis the lease is treated as an operating lease.

Any significant expenditure on the hall or external space which creates a fixed asset (an item expected to provide future benefits to users of the Hall over a number of years) will be capitalised and depreciated (written off to expenditure) on a straight line basis over the lesser of the expected useful life of that asset and the remaining years of the Hall lease. This accounting policy ensures the costs of any fixed assets are properly reflected over the years of use / benefit.

Going concern

The financial statements have been prepared on a going concern basis.

1 Accounting Policies

The principal accounting policies are summarised below. The accounting policies have been applied consistently throughout the year and in the preceding year.

Basis of accounting

The financial statements have been prepared under the historical cost convention and in accordance with the Companies Act 2006 and the Charity Commission's Statement of Recommended Practice, (SORP) 2015; Financial Reporting Standards for Smaller Entities.

Fund Accounting

Unrestricted funds are available for use at the discretion of the trustees in furtherance of the general objectives of the charity.

Designated funds are unrestricted funds earmarked by the trustees for a particular purpose.

Restricted funds are subjected to restrictions on their expenditure imposed by the donor or through the terms of an appeal.

Incoming resources

All incoming resources are included on the statement of financial activities, when the charity is entitled to the income and the amount can be quantified with reasonable accuracy. The following specific policies are applied to particular categories of income:

Voluntary income is received by way of grants, donations and gifts and is included in full in the statement of financial activities when receivable. Grants, where entitlement is not conditional on the delivery of a specific performance by the charity, are recognised when the charity becomes unconditionally entitled to the grant.

Investment income is included when receivable.

Incoming resources from charitable trading activities are accounted for when earned.

Incoming resources from grants, where related to performance and specific deliverables, are accounted for, as the charity earns the right to consideration by its performance.

Resources expended

Expenditure is recognised on an accrual basis as a liability is incurred. Expenditure includes any VAT, which cannot be fully recovered, and is reported as part of the expenditure to which it relates.

Charitable expenditure comprises those costs incurred by the charity in the delivery of its activities and services for its beneficiaries. It includes both costs that can be allocated directly to such activities and to support them.

Governance costs include those costs associated with meeting the constitutional and statutory requirements of the charity and include accountancy fees and costs linked to the strategic management of the charity.

All costs are allocated between the expenditure categories of the SORP on a basis designed to reflect the use of the resource. Costs relating to a particular activity are allocated directly; others are apportioned on a suitable basis.
