




The band performed at the Royal Alert Hall in October and finished 19<sup>th</sup> . It also performed at Brass in Concert for the third time



The Band were not able to rehearse during the lockdown period and as the band hall was too small to social distance, when rehearsals were allowed again. A project was initiated to redesign the rehearsal space by taking down 2 walls and putting in some structural steelwork. Architect drawing were also commissioned and planning permission obtained to extend the band hall and create additional storage space for instruments music etc.
