Method of appointment of Trustees

There must be at least five Trustees, each appointed for a maximum of four years by a resolution of the Trustees.

Objects of the Charity

The Trustees must apply the income of the charity in furthering the following Objects: the maintenance, repair, restoration, conservation, preservation, improvement, beautification and reconstruction, for the benefit of the public, of the fabric of the Church of St Margaret of Antioch, Hemingford Abbots, its monuments, fixtures, fittings, stained and etched glass, ornaments and other chattels and its churchyard and contents.

Activities of the Charity in 2023

Chairman's Report

The Friends of St Margaret's 2023

Throughout 2023 The Friends of St Margaret's has continued to raise funds for the repair and conservation of the fabric of St Margaret's Church. 2023 was a particularly successful year as the Friends boosted its income by £29,054 with its biennial Flower Festival held on 29th and 30th June.

This was the first Flower Festival since June 2019 following the various lockdowns of the Covid pandemic in 2020 and 2021.

Nearly 3,000 visitors attended the traditional Festival. It was a wonderful village event where almost all the community participated to welcome visitors to the open gardens and decorated church. Sincere thanks are given to the Flower Festival organising committee led by Chairman Jo Wills. A Flower Festival of this size demands months of careful preparation and attention to detail – as well as enlisting of an army of helpers and volunteers.

The Friends were extremely saddened to hear of the passing of Lord Hemingford at the start of 2023. He had chaired The Friends of St Margaret's since it began as an independent charity in 2004 until 2019. On behalf of all the Trustees I pay warm tribute to Nick's guidance and wisdom during his long leadership.

Charles Beresford resigned in January 2023 after many years as a highly valued Trustee and there were two new Trustee appointments. Margaret Cloke was re-appointed in January and took on the Treasurer role. JoAnne Rutter was appointed in November, and as a member of the Parochial Church Council of St Margaret's she will act as the liaison between The Friends and the PCC in place of Charles Beresford. I would like to record thanks to all my fellow Trustees for their commitment and efforts for the Charity. The Friends of St Margaret's has an effective working relationship with the PCC of St Margaret's and has made significant contributions to the upkeep of the building and will continue to do so.

Financial Review

The Flower Festival was a great success with £41,369 income, mainly from programme sales and refreshments. Costs in general were higher following the pandemic and amounted to £16,198 including £5,455 on equipment hire and £2,420 on publicity and printing. An additional £3,838 in Gift Aid was claimed.

Although no grants to the PCC were made during the year, there are several maintenance projects planned for 2024 which will be financed by The Friends.

Trustees' Responsibilities Statement



The trustees are responsible for keeping proper accounting records that disclose with reasonable accuracy at any time the financial position of the charity and enable them to ensure that the financial statements comply with the Charities Act 2011, the Charities (Accounts and Reports) Regulations 2008, the provisions of the trust deed. They are also responsible for safeguarding the assets of the charity and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

Note

1 ACCOUNTING POLICIES

Basis of preparing the financial statements

The financial statements of the charity, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2015)', Financial Reporting Standard 102 'The Financial Reporting Standard' applicable in the UK and Republic of Ireland' and the Charities Act 2011. The financial statements have been prepared under the historical cost convention.

The financial statements have been prepared to give a 'true and fair' view and have departed from the Charities (Accounts and Reports) Regulations 2008 only to the extent required to provide a 'true and fair view'. This departure has involved following the Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) issued on 16 July 2014 rather than the Accounting and Reporting by Charities: Statement of Recommended Practice effective from 1 April 2005 which has since been withdrawn.

The financial statements are prepared on a going concern basis under the historical cost convention, modified to include certain items at fair value. The financial statements are presented in sterling which is the functional currency of the charity and rounded to the nearest pound.

Income

All income is recognised in the Statement of Financial Activities once the charity has entitlement to the funds, it is probable that the income will be received and the amount can be measured reliably.

Expenditure

Liabilities are recognised as expenditure as soon as there is a legal or constructive obligation committing the charity to that expenditure, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all cost related to the category. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of resources.

Fund accounting

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees.

Restricted funds can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.
