Report of the trustees

Tishie Yong Foundation for the Disabled has pleasure in presenting the trustees' report and the financial statements for the year ended 31 December 2025.

The charity was constituted by a Trust Deed dated 17 June 2004 and is registered with the Charity Commission number 1104927. The address is Redfield Way, Lenton, Nottingham, NG7 2UW.

Aim and objective

The objective of the charity is to raise funds to assist those with physical or mental disabilities.

Review of developments, activities and achievements

The charity received donations principally from employees of Dusk Till Dawn Limited, DTD Live Limited and those companies during the year together with one off donations from other organisations. Donations made by the charity in accordance with its aims and objectives have continued during the year ended 31 December 2025.

Finances

The attached financial statements show the current finances. All funds are restricted.

Reserves

As all the funds are restricted, they are held to further the aims and objectives of the charity outlined above.

Risk management

The trustees have examined the major risks that the charity faces. In the opinion of the trustees the charity has established resources and review systems which, under normal conditions, should allow the risks identified by them to be mitigated to an acceptable level in the day to day workings of the charity.

Investment policy

The trustees' investment policy is to ensure sufficient liquidity is available to meet the aims of the charity. Therefore, cash is held in a current account to meet short term donations and any excess is invested in the money market with three months' notice.

Trustees' responsibilities for the financial statements

The law applicable to charities in England and Wales requires the trustees to prepare financial statements for each financial period which give a true and fair view of the charity's financial activities during the period and of its financial position at the end of the period.

In preparing financial statements giving a true and fair view, the trustees should follow best practice and:

- select suitable accounting policies and then apply them consistently;
- make judgements and estimates that are reasonable and prudent; and
- prepare the financial statements on the going concern basis unless it is inappropriate to presume that the charity will continue in operation.

The trustees are responsible for keeping accounting records which disclose with reasonable accuracy the financial position of the charity and which enable them to ascertain the financial position of the charity and to ensure that the financial statements comply with applicable law. They are also responsible for safeguarding the assets of the charity and for taking reasonable steps for the prevention and detection of fraud and other irregularities.

Independent examiner's report to the trustees of Tishie Yong Foundation for the Disabled

I report to the trustees on my examination of the financial statements of Tishie Yong Foundation for the Disabled ("the charity") for the year ended 31 December 2025.

Respective responsibilities of trustees and examiner

The charity's trustees are responsible for preparation of the accounts. The charity's trustees consider that an audit is not required for this year under section 144 (2) of the Charities Act 2011 (the 2011 Act), and that an independent examination is needed.

Notes to financial statements

1 Principal accounting policies

(a) Basis of preparation of financial statements

The financial statements have been prepared under the historical cost convention.

The charity has prepared its accounts in accordance with the requirements of the Charities Act 2011 and the Statement of Recommended Practice applicable to charities preparing their accounts in accordance with FRS102.

(b) Donations

Donations (including gift aid recovery) are recognised in the financial statements when receivable or when there is a firm commitment to pay monies to the charity in respect of expenditure already incurred.

(c) Investment income

All investment income, including deposit interest, is shown on the basis of amounts received in the year and includes any tax credit or income tax which is recoverable by the charity.

(d) Direct charitable expenditure

All expenditure is accounted for on an accruals basis.

(e) Funds

Restricted funds are funds subject to conditions imposed by the donor or by the specific terms of the appeal under which the funds are raised. The restrictive conditions are binding upon the trustees of the charity.

2 Donations received

The donations received principally relate to amounts received from the employees of Dusk Till Dawn Limited and DTD Live Limited together with donations from those companies, together with other donations received.

3 Donations in kind and management and administration expenses

Donors from 30 June 2025 pay all of the administration costs of the charity.

6 Debtors

Debtors relates to amounts receivable from DTD Leisure Limited, and Dusk Till Dawn Limited which were committed to be paid but not paid over at 31 December 2025 and 2024. Interest on the balance due is paid by the donors at a rate of 1.5% above SONIA.
