TO SET UP, RUN, SUPERVISE AND CO-OPERATE IN THE OPERATION OF PROGRAMMES FOR THE EDUCATION OF YOUNG PERSONS PARTICULARLY THOSE WHO MAY HAVE COME INTO CONTACT WITH THE CRIMINAL JUSTICE SYSTEM AND/OR WHO MAY BE IN DANGER OF EXCLUSION OR HAVE BEEN EXCLUDED FROM SCHOOL WITH A VIEW TO FACILITATING THE PHYSICAL, MENTAL AND SPIRITUAL DEVELOPMENT AND THE DEVELOPMENT OF THEIR POTENTIAL CAPACITIES SO THAT THEY MAY PLAY A FULL ROLE AS INDIVIDUALS AND MEMBERS OF SOCIETY.2. TO ESTABLISH OR SECURE ESTABLISHMENT OF A TRAINING CENTRE AND TO MAINTAIN AND MANAGE THE SAME WHETHER ALONE OR IN CO-OPERATION WITH ANY LOCAL AUTHORITY OR OTHER PERSON OR BODY AND TO OFFER EDUCATIONAL AND TRAINING PROGRAMMES IN CONNECTION WITH THE FOREGOING.
