**REPORT OF THE TRUSTEES
for the Year Ended 31 March 2024**

The trustees who are also directors of the charity for the purposes of the Companies Act 2006, present their report with the financial statements of the charity for the year ended 31 March 2024. The trustees have adopted the provisions of Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019).

OBJECTIVES AND ACTIVITIES

Objectives and aims

Dance Art Foundation is an independent arts charity working at the intersections of dance, visual art, social engagement and artist advocacy. It incubates new ideas and developments in dance that it takes out into the world and engaged the public in fresh and imaginative ways. Performances are daring, often in dialogue with other disciplines and extending the boundaries of dance, choreography and performance. Our advocacy work centres independent artists and collective action for systemic change with dance and beyond, and our discourse projects foster generative dialogues and widen access to critical thinking in dance. In participation and social engagement, Dance Art Foundation is a recognised UK leader in dance-in-health and inclusive dance. The charity is led by trustees Robyn Cabaret (producer), Martin Richard Coppel (curator) and Dr Martin Hargreaves (dramaturge and writer) with Artistic Director Joe Moran directing, curating and producing all of the charity's activities, in collaboration with a dynamic network of independent artists and project staff.

Dance Art Foundation dedicated time this year to review its organisational resources, with particular focus on the producing and project management of productions and projects, following a very busy year of international touring and UK projects in 2022-23. The charity worked with independent arts producer Laura Sweeney of Uncultured (who previously worked with Dance Art Foundation as a freelance producer) in a consultancy capacity to review the charities producing needs and to support the development of a revised producing framework and recruitment strategy, in tandem with the work of the board of trustees. This has been enormously impactful in identifying, devising and implementing an action plan towards a new, more sustainable producing structure.

Dance Art Foundation's charitable activities this year focused on two key projects: the first live performances of Artistic Director Joe Moran's work *Materiality Will Be Rethought* at Musée Transitoire in Paris (Nov 2023), accompanied by a simultaneous presentation of the film version of the work (Oct 2023-Mar 2024), and the beginning of a yearlong, inclusive dance residency at Hexham Priory Special School in Northumberland, led by Associate Artist Susie Tate and funded by the Postcode Neighbourhood Trust.

ACHIEVEMENT AND PERFORMANCE

Participation

This year, we successfully began Breathing Space Dances, a yearlong inclusive dance residency working with disabled children and their families at Hexham Priory Special School led by local dance artist and inclusive dance leader, Associate Artist Susie Tate and funded by the Postcode Neighbourhood Trust. The project is part of our celebrated Breathing Space participatory dance programme delivered across the UK. Enabling participation in the arts in a rural area with limited provision, the project offers our specialist, well-evidenced, inclusive dance approach across all groups at the school to foster children's creative learning and to support physical and emotional health and wellbeing. Staff training sessions offer the opportunity for teaching and support staff to learn new skills and diversify their work; enhancing their work and relationships with children and expanding the reach of the project. The project will culminate in the creation of our third film collaboration with filmmaker Alice Underwood. The short dance film, co-created by Susie, Alice and the students at the school, that will feature and celebrate children's ideas, stories and achievements from across the yearlong project.

ACHIEVEMENT AND PERFORMANCE

Advocacy, production and performance

This year, we developed the first live performances of Artistic Director Joe Moran's work *Materiality Will Be Rethought*. The work was originally commissioned Whitechapel Gallery in London as a live performance in dialogue with Carlos Bunga's exhibition *Something Necessary and Useful* but was never shown publicly and rather was re-imagined as a 30-min film due to the cancellation of the performance during Covid. The resulting film was screened widely at a number of international festivals in Paris, Berlin, Mexico City and London, and was awarded the Best Choreography Prize at Mexico City International Video Dance Festival 2022. This first live iteration was performed this year in November 2024 by three dancers in a disused car park in Paris as part of the Musée Transitoire 2023-24 public exhibition and performance programme. The production was very well received by audiences and has inspired the development of work and a commitment to further live performances next year. The production was also an opportunity to successfully realise our strategic aim to increase international touring and co-production and was a first step in increasing our investment in producing support for our production work to enable more sustainable practice.

FINANCIAL REVIEW

Financial position

Dance Art Foundation is in a stable financial position. It has maintained reserves and is committed to growing these further. The charity is project funded with core costs, such as insurance, accountancy fees and administration (webhosting, filing costs, subscriptions), incorporated into project grants or funded by unrestricted project income, donations or income from HMRC's Gift Aid scheme. During this financial year, the charity completed a Gift Aid claim (following its re-registration last year), which represented the final income for recent production and closed outstanding project budgets carried over from the last financial year.

Income this year comprised production fees, charitable grants and production income (including costume refunds and insurance claims resulting from travel disruption). The breakdown of income this year is: public funding and donations (78%), commissions and presentation fees (15%), and earned and other project income (8%), which included funding from the Postcode Neighbourhood Trust and FABRIC, and performance fees from Musée Transitoire. As the charity continues its recovery from the impacts of Covid and streamlined its activities whilst focusing on longer term organisational sustainability, its annual turnover rose to a modest £30,600.

Reserves policy

Dance Art Foundation is not in receipt of core funding. It receives restricted, project-based or unrestricted income from grants, commissions, workshops, performances and donations that is spent in accordance with its charitable objectives. The charity retains reserves required to complete committed projects and is now building up a financial reserve to cover future overheads and ensure its viability should income levels over certain periods fall.

Funds in deficit and project surpluses

The accounts at year end show all project budgets in surplus, or drawn to close. Most years, Dance Art Foundation's projects and programmes will cross financial years and therefore budget surpluses are retained in order to continue or complete projects in the following year.

Two small project budget deficits from the last financial year were cleared by an outstanding gift aid claim completed in this financial year.

The Trustees express their sincere thanks to Dance Art Foundation's artists, project staff and production teams, funders, supporters and partners, and the participants and audiences who have engaged with its work.

STRUCTURE, GOVERNANCE AND MANAGEMENT

Governing document

The charity is controlled by its governing document, a deed of trust, and constitutes a limited company, limited by guarantee, as defined by the Companies Act 2006.

Recruitment and appointment of new trustees

The Board of Trustees is ethically and financially responsible for the charity. The position of Trustee is voluntary, and one for which none of the Trustees or those closely related to them may receive financial remuneration. Trustees are recruited and appointed on the basis of necessary skills sets at board level and their under-representation. Candidates are sought through pertinent networks decided upon by the Trustees. Appointments are made by proposal to the board which are considered and voted upon by all board members.

Risk management

The trustees have a duty to identify and review the risks to which the charity is exposed and to ensure appropriate controls are in place to provide reasonable assurance against fraud and error.

Independent examiner's report to the trustees of Dance Art Foundation ('the Company')

1. ACCOUNTING POLICIES**Basis of preparing the financial statements**

The financial statements of the charitable company, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Companies Act 2006. The financial statements have been prepared under the historical cost convention.

Income

All income is recognised in the Statement of Financial Activities once the charity has entitlement to the funds, it is probable that the income will be received and the amount can be measured reliably.

Expenditure

Liabilities are recognised as expenditure as soon as there is a legal or constructive obligation committing the charity to that expenditure, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all cost related to the category. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of resources.

Taxation

The charity is exempt from corporation tax on its charitable activities.

Fund accounting

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees.

Restricted funds can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.

Further explanation of the nature and purpose of each fund is included in the notes to the financial statements.

**REPORT OF THE TRUSTEES
for the Year Ended 31 March 2023**

The trustees who are also directors of the charity for the purposes of the Companies Act 2006, present their report with the financial statements of the charity for the year ended 31 March 2023. The trustees have adopted the provisions of Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019).

OBJECTIVES AND ACTIVITIES

Objectives and aims

Dance Art Foundation is an independent arts charity working at the intersections of dance, visual art, social engagement and artist advocacy. It incubates new ideas and developments in dance that it takes out into the world in fresh and imaginative ways, strongly focused on public engagement. Performances are daring, often transgressing artforms and in dialogue with other disciplines, extending the boundaries of dance, choreography and performance. Our advocacy work centres independent artists and collective action for systemic change. Our discourse projects foster generative dialogues and widen access to critical thinking in dance. In participation and social engagement, Dance Art Foundation is a recognised UK leader in dance-in-health. The charity is led by trustees Robyn Cabaret (producer), Martin Richard Coppell (curator) and Dr Martin Hargreaves (dramaturge and writer) with Artistic Director Joe Moran directing, curating and producing all of the charity's activities, working in collaboration with a dynamic network of independent artists and project staff.

This year saw the charity resume its production work, following a steady emergence from the impacts of the Covid-19 pandemic, with international performance in Germany and Switzerland, and also in London, and touring the film work *Materiality Will Be Rethought* to international film festivals. In participation, we continued to share films from our participatory projects led by Associate Artists Susie Tate and Louise Klarnett, and are delighted to have been awarded a generous grant from Postcode Community Foundation for year-long project with Priory Special School in Cumbria. We are also excited to have entered the final phase of our three-year *Artist-Curator-Leader* advocacy project.

ACHIEVEMENT AND PERFORMANCE

Participation

In 2021-22, Dance Art Foundation completed two major participatory projects as part of its nationally recognised *Breathing Space* dance-in-health programme led by Associate Artists Susannah Tate (North and North East) and Louise Klarnett (London and South East). This year, we have been delighted to continue to share the wonderful dance films that arose from those two projects:

- *Swimming Upstream* is an inspiring dance film created by Associate Artist Susannah Tate with filmmaker Alice Underwood and Susie's *About Being Dance* for Stroke Survivors' Group. The project was undertaken in partnership with Cumbria Wildlife Trust and the University of Cumbria Institute of Arts dance students and Institute of Health occupational therapy students. *Swimming Upstream* was launched at the University of Cumbria and has been shown in a variety of contexts since, including at Prism Arts summer event and the Cumbria Stroke Association. It has been celebrated as a powerful and moving art work and also as a valuable teaching tool for Occupational Therapy and Physiotherapy students. The film nurtures the understanding of creative movement and dance as a means of support and rehabilitation for stroke survivors and the wider value of dance in health.
- We were delighted to also launch a dedicated website as the culmination our collaboration with The Magpie Project in East London. In the context, dance artist Louise Klarnett's work supported child development and improves children's developmental delays through creative dance, movement and touch, whilst nurturing emotional wellbeing, bonding and meaningful embodied interactions between Mums and children in a safe and playful environment. Sessions were suspended during the pandemic and instead a series of short films were created and shared weekly to act as reminders of in-person workshops. The films are now publicly available offering wider groups the opportunity to delve into the project, which have been tremendously well received and featured at number of professional development events.

In 2023, we dedicated time to developing a new long-term project in Cumbria with the staff, children and families at Priory Special School to be led by local Associate Artist Susannah Tate. We successfully applied for £21,400 from the Postcode Community Foundation for a year-long programme that will feature weekly sessions for children across the school and will lead to the creation of a second film collaboration with Alice Underwood. Funds will be awarded in May 2023 and we are delighted and very grateful for this generous support to continue our participatory work in the North East of England.

ACHIEVEMENT AND PERFORMANCE

Advocacy, production and performance

The main focus of our work over the past year has been the realisation of international touring ambitions, including plans halted due to the pandemic. We were delighted to present Artistic Director Joe Moran's popular stage work *Arrangement* (last shown at Sadler's Wells in London prior to the pandemic at the end of 2019) in Germany and Switzerland. The production of six dancers, accompanied by a Production Manager and the Artistic Director, was performed at Tanzwerkstatt Europa festival in Munich in August upon the invitation of dance organisation Joint Adventures and its director Walter Heun, and then later in September as the only UK-based company in the main performance programme of Tanzmesse 2022, hosted at Tanzhaus NRW in Dusseldorf, with the support of the British Council. Tanzmesse provided opportunities to meet a range of international colleagues and we hope to utilise these introductions and to realise further opportunities by appointing a new freelance producer with international experience to work alongside the Artistic Director. We were also delighted to be invited to perform *Arrangement* at Switzerland's Tanzfestival Winterthur in November where we were met by a very positive response. We completed 2022 with the presentation of the choreographic exhibition *Its Contours, Its Movements* as part of Fest en Fest festival of expanded choreography in London. The exhibition brought together the full range of Artistic Director Joe Moran's practice in performance, film and drawing and was accompanied by a specially commissioned exhibition text by Dr. Tom Hastings.

We were also very pleased to tour internationally with another project by Artistic Director Joe Moran, the 30-min film *Materiality Will Be Rethought*. The work was originally commissioned Whitechapel Gallery as a live performance in dialogue with Carlos Bunga's exhibition *Something Necessary and Useful*. It was re-imagined as a film due to Covid with the support of Arts Council England and private patrons. The film was screened at a number of international film festivals in Paris, Berlin, Mexico City and in London, and we were thrilled that it was awarded the Best Choreography Prize at Mexico City International Video Dance Festival 2022.

We continued our work in artist advocacy with the final phase of our *Artist-Curator-Leader* programme. This work has been generously supported by Arts Council England, Surf The Wave, Dance4, Yorkshire Dance, The Place, Chisenhale Dance Space and Sadler's Wells. The project will culminate in a guidance publication on increasing artist leadership and artists representation in the UK dance sector. This will be presented in two parts: a summary and recommendations from roundtable discussions and, secondly, responses to these findings from invited artists, arts workers, programmers and funders, curated by Artist Council member Dr 'Funmi Adewole, Project Working Group member Freddie Opoku-Addaie and Artistic Director Joe Moran.

FINANCIAL REVIEW

Financial position

Dance Art Foundation is in a stable financial position. It has maintained a healthy reserve and is working within a clear policy to grow this reserve further. The charity is project funded with core costs, such as insurance, accountancy fees and administration (webhosting, filing costs, subscriptions), incorporated into project grants or funded by unrestricted project income or gift aid income from donations. The charity has re-registered with HMRC for Gift Aid claims and a new claim has been submitted to be received in the coming financial year, representing outstanding income for recent productions.

Income in this financial year was heavy weighted to commissions and presentation fees reflecting our focus on international and UK touring and production. This income included support from British Council Germany, Joint Adventures in Munich, Tanzmesse in Dusseldorf, Tanzfestival Winterthur in Switzerland, and Fest en Fest, festival of expanded choreography in London. As is usual for Dance Art Foundation, activities included programmes that crossed over from the last financial year, which were either spent down or are in completion. This funding included final payments from our recent Arts Council England emergency response award, as well as support from partners Dance4 (now named FABRIC) and Yorkshire Dance for the final stage of the *Artist-Curator-Leader* programme.

The breakdown of income this financial year is: commissions and presentation fees (83%), public funding and donations (12%) and earned and other project income (5%). As the charity steadily recovers from the impact of Covid, its annual turnover rose to £29,500.

Reserves policy

Dance Art Foundation is not in receipt of core funding. It receives restricted, project-based or unrestricted income from grants, commissions, workshops, performances and donations that is spent in accordance with its charitable objectives. The charity retains reserves required to complete committed projects and is now building up a financial reserve to cover future overheads and ensure its viability should income levels over certain periods fall.

FINANCIAL REVIEW

Funds in deficit

The accounts at year end show small project budget deficits in two areas, which have been carried over from last financial year (Whitechapel Gallery commission; *Arrangement* performances at Sadler's Wells). These deficits will be cleared by an outstanding gift aid claim, which was delayed due to the need to re-register the charity for online gift aid claims. The charity's online registration had lapsed as a result of not making a claim for some years. The trustees note that the unrestricted funds to hand exceed the total of these project deficits. Registration is now complete and the claim submitted.

STRUCTURE, GOVERNANCE AND MANAGEMENT

Governing document

The charity is controlled by its governing document, a deed of trust, and constitutes a limited company, limited by guarantee, as defined by the Companies Act 2006.

Recruitment and appointment of new trustees

The Board of Trustees is ethically and financially responsible for the charity. The position of Trustee is voluntary, and one for which none of the Trustees or those closely related to them may receive financial remuneration. Trustees are recruited and appointed on the basis of necessary skills sets at board level and their under-representation. Candidates are sought through pertinent networks decided upon by the Trustees. Appointments are made by proposal to the board which are considered and voted upon by all board members.

Risk management

The trustees have a duty to identify and review the risks to which the charity is exposed and to ensure appropriate controls are in place to provide reasonable assurance against fraud and error.

1. ACCOUNTING POLICIES**Basis of preparing the financial statements**

The financial statements have been prepared under the historical cost convention.

Income

All income is recognised in the Statement of Financial Activities once the charity has entitlement to the funds, it is probable that the income will be received and the amount can be measured reliably.

Expenditure

Liabilities are recognised as expenditure as soon as there is a legal or constructive obligation committing the charity to that expenditure, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all cost related to the category. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of resources.

Taxation

The charity is exempt from corporation tax on its charitable activities.

Fund accounting

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees.

Restricted funds can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.

Further explanation of the nature and purpose of each fund is included in the notes to the financial statements.

**REPORT OF THE TRUSTEES
for the Year Ended 31 March 2021**

The trustees who are also directors of the charity for the purposes of the Companies Act 2006, present their report with the financial statements of the charity for the year ended 31 March 2021. The trustees have adopted the provisions of Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019).

OBJECTIVES AND ACTIVITIES

Objectives and aims

Dance Art Foundation is an independent arts charity working at the intersections of dance, visual art, social engagement and artist advocacy. It incubates new ideas and developments in dance that it takes out into the world in fresh and imaginative ways, strongly focused on public engagement. Performances are daring, often transgressing artforms and in dialogue with other disciplines, extending the boundaries of dance, choreography and performance. Our advocacy work centres independent artists and collective action for systemic change. Our discourse projects foster generative dialogues and widen access to critical thinking in dance. In participation and social engagement, Dance Art Foundation is a recognised UK leader in dance-in-health. The charity is led by trustees Robyn Cabaret (producer), Martin Richard Coppel (curator) and Dr Martin Hargreaves (dramaturge and writer) with Artistic Director Joe Moran directing, curating and producing all of the charity's activities, working in collaboration with a dynamic network of independent artists and project staff.

This year coincided with the Covid-19 pandemic which had inevitable impact on Dance Art Foundation's work seeing the suspension of its performance and participation programmes and a move to remote and online working. The charity received generous emergency support from Arts Council England, the Community Fund and through partnership funding, whilst BBC Children in Need agreed an extension of existing projects.

ACHIEVEMENT AND PERFORMANCE

Participation

We developed new formats and ways of working as part of our nationally recognised Breathing Space dance-in-health programme and also through our partnership with The Magpie Project in Newham, East London. These projects were delivered by Dance Art Foundation Associate Artists Susannah Tate (North and North East) and Louise Klarnett (London and South East). Funding from Arts Council England supported research and development into working online with the vulnerable groups with whom we work. Intermittent in person delivery took place as Covid restrictions allowed, alongside online and remote work with our hospice partners. In some cases, online sessions have been transformative, particularly for vulnerable and isolated young people. One child came to value and look forward to sessions in such a way that: 'The sessions have been the highlight of the lockdown for us' (family member).

The Magpie Project ensures that children living in temporary accommodation are given every opportunity to thrive socially, emotionally, and developmentally, and that Mums are supported to parent their children positively under very stressful circumstances. In this context, dance artist Louise Klarnett's work supports child development and improves children's developmental delays through creative dance, movement and touch, whilst nurturing emotional wellbeing and bonding and meaningful embodied interactions between Mums and children in a safe and playful environment. In place of in person sessions this year, Louise, Dance Art Foundation and The Magpie Project worked together to create a series of short films that acted as reminders of live, in person workshops that were shared weekly with Mums and minis from the project, augmented by Zoom sessions. Data, tablets and laptops were distributed as part of the project to address digital poverty. The films were subsequently collated on a dedicated website and a detailed project evaluation was undertaken by Dr Sara Reed.

We were delighted to also receive funding from the Community Fund this year to support our participation programmes and to receive funding from the Postcode Community Trust for *Swimming Upstream*, an inspiring film project lead by Associate Artist Susannah Tate working in Cumbria with her About Being Dance for Stroke Survivors' Group, in partnership with Cumbria Wildlife Trust and the University of Cumbria Institute of Arts dance students and Institute of Health occupational therapy students.

'This project came at just the right time. I, we would not have got through the 2nd lockdown mentally or physically without our weekly meets on the computer. Then coming back together in the summer and working towards a film has been brilliant. Something we could look forward to and we knew it would happen even with Covid because we are such a committed bunch!' - Participant, member of the About Being Dance for Stroke Survivors' Group

ACHIEVEMENT AND PERFORMANCE

Advocacy, production and performance

We continued our impactful and highly regarded *Artist-Curator-Leader* project that focuses on increasing artist leadership and artist representation in the dance sector. Having completed a series of public and invited roundtables, the project moved onto phase two: writing up research findings into a Guidance Publication. The Working Group gave particular attention to how the publication may have achieved a 'poly-vocal' structure, in order to reflect the diversity of voices and perspectives that made up the roundtables. This planning has led to a two-part structure for next year's publication that will summarise the research to date and commission a diverse range of new contributors to respond to findings and to look forward.

We were very pleased to extend our advocacy work to 'walk the talk' of increasing artist leadership and artist representation. This saw the creation of a six-member, paid Artist Council working as a senior leadership team and who lead the distribution of artist bursaries during the pandemic. We were also very happy to invite a number of artists and community organisers to deliver a series of online talks and workshops on the theme of '*Organising for Change*' that offered resources and skills for navigating the challenges faced by artists as a result of the pandemic, as well as challenges made apparent during the crisis.

The public presentation of our performance commission from Whitechapel Gallery, *Materiality Will Be Rethought* by Artist Director and choreographer Joe Moran, was cancelled due to Covid restrictions on Monday 16 March 2020, the evening of its dress rehearsal. The work was commissioned as a site-specific performance in dialogue with visual artist Carlos Bunga's exhibition *Something Necessary and Useful* and developed as a three-part commission set to be presented in March, May and July 2020. With the support of Arts Council England, as well as private patrons and additional funds from Whitechapel Gallery, the work was reimagined as 30-minute film that was presented online on the gallery website and a dedicated project site for two weeks in December 2020 watched by over 2000 viewers. It is hoped a live version of the work may be presented to public audience in the future.

FINANCIAL REVIEW

Financial position

Dance Art Foundation completed the year in a stable financial position. The charity has reduced its overheads over the past several years which included moving to remote working and letting go of its office space to secure financial stability. Current core costs are insurance, accountancy and basic administration such as webhosting, which are incorporated into project grants and also funded by gift aid income from donations.

The charity has maintained a mixed financial economy with a stronger emphasis on charitable grants and public funding and marked reduction in commissions and presentation fees as a result of the pandemic and consequent reduction in production activities. Income this financial year was received from charitable grants and public funding (73%), earned, projects and other income (15%), commissioning and presentation fees (9%) and private donations (3%). The annual turnover was £85,282. As usual for Dance Art Foundation, activities across the year included programmes that crossed over from last year that were completed in this financial year, as well as new projects and those that bridge into next year.

Emergency support from Arts Council England this year made a significant difference for Dance Art Foundation. It enabled an ambitious programme of organizational development and successful adaptation of public facing activities for online delivery (Jun-Dec 2020). It also enabled Dance Art Foundation to use its organisational position to support freelancers during the pandemic: 97% of its grant (£32,300) was paid to 37 freelance artists and creative practitioners. Organisational development focused upon implementation of a paid Artist Council operating as a new senior leadership group, Covid-responsive modelling, development of a Communications Strategy, and Equity, Dignity and Anti-discrimination policy development. The grant was instrumental in enabling us to research and learn how to move activities online and helped us to repurpose existing funding agreements and to attract additional funding.

Commercial projects

Over the several years, Dance Art Foundation has developed working in commercial contexts to increase earned income in order to fund core expenditure and furthering its charitable objectives. Dance Art Foundation did not undertake any activities in this area over the past year.

FINANCIAL REVIEW

Reserves policy

Dance Art Foundation is not in receipt of core funding. It receives restricted, project-based or unrestricted income from grants, commissions, workshops, performances and donations that is spent in accordance with its charitable objectives. The charity retains reserves required to complete committed projects.

Funds in deficit

At the year end, the accounts show small project budget deficits in two areas. These deficits however represent confirmed outstanding project income that will balance each budget (£325 - Whitechapel Gallery commission; (1,175 - Sadler's Wells performances). We additionally note that the unrestricted funds to hand exceed the total of these project deficits.

The Trustees express their sincere thanks to Dance Art Foundation's artists, project staff and production teams, its funders, supporters and project partners, and the participants and audiences who have engaged with its work. We are particularly indebted to Arts Council England for its generous emergency support this year and to the flexibility and understanding of all our project funders during this most challenging year.

STRUCTURE, GOVERNANCE AND MANAGEMENT

Governing document

The charity is controlled by its governing document, a deed of trust, and constitutes a limited company, limited by guarantee, as defined by the Companies Act 2006.

Recruitment and appointment of new trustees

The Board of Trustees is ethically and financially responsible for the charity. The position of Trustee is voluntary, and one for which none of the Trustees or those closely related to them may receive financial remuneration. Trustees are recruited and appointed on the basis of necessary skills sets at board level and their under-representation. Candidates are sought through pertinent networks decided up on the Trustees. Appointments are made by proposal to the board which are considered and voted upon by all board members.

Risk management

The trustees have a duty to identify and review the risks to which the charity is exposed and to ensure appropriate controls are in place to provide reasonable assurance against fraud and error.
