TO PROMOTE, FOR THE PUBLIC BENEFIT, THE RURAL REGENERATION OF AREA OF SOCIAL AND ECONOMIC DEPRIVATION WITHIN THE CONTIGUOUS MOUNTAINOUS AREAS OF MONTENEGRO, ALBANIA AND KOSOVO/A BY ALL OR ANY OF THE FOLLOWING MEANS:(A) THE RELIEF OF POVERTY AND ECONOMIC HARDSHIP IN SUCH WAYS AS MAY BE THOUGHT FIT AND COMPATIBLE WITH THE OTHER OBJECTS OF THE CHARITY;(B) THE PROVISION OF FINANCIAL AND OTHER ASSISTANCE TO PROMOTE TRAINING AND EDUCATION OPPORTUNITIES;(C) THE PROVISION OF FINANCIAL AND OTHER ASSISTANCE TO PROMOTE NEW AND EXISTING BUSINESS OPPORTUNITIES AND THE CONSEQUENT CREATION OF NEW EMPLOYMENT;(D) THE PROTECTION OR CONSERVATION OF THE ENVIRONMENT;(E) THE PROVISION OF FINANCIAL AND OTHER ASSISTANCE FOR THE MAINTENANCE, IMPROVEMENT OR PROVISION OF PUBLIC AMENITIES; AND(F) THE PROVISION OF FINANCIAL AND OTHER ASSISTANCE FOR THE PRESERVATION OF BUILDINGS OR SITES OF HISTORIC, CULTURAL, ARCHAEOLOGICAL OR ARCHITECTURAL IMPORTANCE.3.
