Objects: THE PROVISION OF THE SUPPLY OF WATER TO THE INHABITANTS OF THE PARISH OF MELMERBY IN COVERDALE (AND IN THIS DOCUMENT IT IS CALLED "MELMERBY") THE OBTAINING MAINTENANCE AND RENEWAL (AS REQUIRED) OF A WATER ABSTRACTION LICENCE TO PERMIT WATER TO BE TAKEN FROM A SPRING SERVING MELMERBY THE TAKING AND HOLDING OF A LEASE FROM MELMERBY PARISH MEETING OR OTHER THE OWNER THEREOF OF THIS SYSTEM OF PIPES AND VALVES THROUGH WHICH WATER IS DELIVERED TO DWELLINGS IN MELMERBY THE ACQUISITION OF THE APPARATUS FROM WHICH THE WATER SUPPLY OF MELMERBY IS PRESENTLY DERIVED THE MAINTENANCE REPAIR AND RENEWAL OF THE SYSTEM OF WATER SUPPLY TO THE PROPERTIES LOCATED IN MELMERBY AND THE PROVISION MAINTENANCE AND REPAIR AND RENEWAL OF SUCH NEW PIPES VALVES AND APPARATUS AS MY BE NECESSARY TO SUPPLY PRESENT AND FUTURE PROPERTIES IN MELMERBY NOT PRESENTLY SERVED BY A WATER SUPPLY (EXCLUDING ALL PIPES VALVES AND APPARATUS WITHIN THE CURTILAGE OF INDIVIDUAL PROPERTIES).
