**Objects:** TO ADVANCE THE EDUCATION AND TO BRING RELIEF TO THE POOR PEOPLES OF THE COUNTRY OF NEPAL, IN THE CONTINENT OF ASIA. BY: CLOTHES AND BLANKET DISTRIBUTION 6 MONTH ADULT EDUCATION CLASSES FLOOD RELIEF BUILDING OF SCHOOLS AND PROVIDING CONTINUING FUNDING OF CHILDRENS EDUCATION. PROVIDING VEHICLES TO DISTRIBUTE CLOTHING AND AID TO REMOTE VILLAGES. BUILDING OF ORPHANAGE AND THE CONTINUED FUNDING OF THE RUNNING COSTS.
