**Objects:** (I) TO PROMOTE FOR THE BENEFIT OF THE INHABITANTS OF LLANGWNNADL AND THE SURROUNDING AREA THE PROVISION OF FACILITIES FOR RECREATION OR OTHER LEISURE TIME OCCUPATION OF INDIVIDUALS WHO HAVE NEED OF SUCH FACILITIES BY REASON OF THEIR YOUTH, AGE, INFIRMITY OR DISABLEMENT, FINANCIAL HARDSHIP OR SOCIAL AND ECONOMIC CIRCUMSTANCES OR FOR THE PUBLIC AT LARGE IN THE INTERESTS OF SOCIAL WELFARE AND WITH THE OBJECT OF IMPROVING THE CONDITION OF LIFE OF THE SAID INHABITANTS;(II) TO ESTABLISH A COMMUNITY CENTRE IN THE BUILDING KNOWN AS HEN YSGOL, LLANGWNNADL AND TO MANAGE THE SAME FOR THE BENEFIT OF THE SAID INHABITANTS; AND(III) TO FURTHER SUCH OTHER CHARITABLE PURPOSES FOR THE BENEFIT OF THE SAID INHABITANTS AS THE DIRECTORS SEE FIT FROM TIME TO TIME.

**Activities:** To create and organize a Community Center for the use and benefit of the inhabitants of Llangwnadl and district in the building known as Llangwnadl Old School, and to enable the use of this facility by any interested parties regardless of race colour or creed.
