Activities: The principal activity of the company is the provision of early years education. The main activities undertaken are the operation of a Nursery and Pre-school; providing a secure, safe and welcoming environment for children from the age of 6 months until 4 years old; enhancing development and education in a "Learning through Play" situation, and encouraging the involvement of parents/carers.
