**REPORT OF THE TRUSTEES 理事會報告**

The Board (the trustees and directors of the charitable company) presents the combined directors' report and trustees' annual report, as required by company law, together with the audited financial statements of Chinese Church in London for the year ended 31 December 2022. The financial statements have been prepared in accordance with the accounting policies set out in Note 1 and comply with the charity's trust deed, applicable law, relevant accounting standards including the requirements of the Statement of Recommended Practice, Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102), "Accounting and Reporting by Charities".

**2. STRUCTURE, GOVERNANCE AND MANAGEMENT 結構、治理和管理層****Governing Document 治理文件**

The Church is a charitable company limited by guarantee, incorporated on 12 November 2004 and registered as a charity on 11 January 2005. The company's Articles of Association was updated in 2019 according to the Companies Act 2006 and the Charities Act 2011 with the help of the solicitors of Lawson Lewis Blakers Ltd.

教會是一家慈善擔保有限公司，成立於 2004 年 11 月 12 日，並於 2005 年 1 月 11 日註冊為慈善機構。在 Lawson Lewis Blakers Ltd. 律師的幫助下，公司章程於 2019 年根據《2006 年公司法》和《2011 年慈善法》進行了更新。

The updated Articles of Association (2019) were approved by Church members by voting at the 2019 AGM on 21st September 2019, filed with Companies House on 9 October 2019 and registered with the Charity Commission.

2019 年 9 月 21 日，教會會友在 2019 年度會友大會上投票通過了更新後的《公司章程 2019》，並於 2019 年 10 月 9 日在公司註冊處備案，並在慈善委員會註冊。

In the event of the company being wound up members are required to contribute an amount not exceeding £1.

在公司清盤的情況下，會友須繳納不超過 1 英鎊的金額。

The Chinese Church in London Bye Laws (2012) have also been updated according to the Articles of Association of Chinese Church in London (2019), reflecting the structure and practices of the Church. The updated Bye Laws were circulated to Church members for information and presented at the 2020 AGM on 26 September 2020.

《倫敦中華基督教會規章》(2012) 亦已根據《倫敦中華基督教會公司章程》(2019)更新，以反映本教會的結構和慣例。更新後的規章已分發給教會會友參考，並在 2020 年 9 月 26 日舉行的 2020 年度會友大會上提交。



## **Governing Body 治理機構**

The directors of the company are also charity trustees for the purposes of charity law and under the company's Articles are known as members of the Board. The Board is the governing body of the Church. It has overall responsibility for strategy and decision-making, directing the affairs of the Church, and for the efficient running of its operations. The Board meets every 2 months.

根據慈善法，公司理事也是慈善受託人，根據公司章程，他們被稱為理事會成員。理事會是教會的管理機構。理事會全面負責教會的戰略和決策，指導教會事務，並負責教會的有效運作。理事會每兩個月召開一次會議。

The Board consists of the following spiritually matured leaders:

The Head of Operations provides an Operations report and the Head of Finance assists the Treasurer to provide the Financial update to inform the Board at each Board meeting. Both heads may be invited to attend the Board meeting where required. They do not have voting rights in the Board's decision-making process.

- Other attendee(s) invited to attend Board meetings from time to time do not have voting rights in the Board's decision-making process.

The Board is supported by the following committees:

理事會由以下委員會提供支持：

- Senior Pastor's Office (SPO) 主任牧師辦公室– A full time management body consisting of the Senior Pastor (SP) and selected members to assist the SP, together with the staff team, to execute decisions made by the Board (Church Board). It also has the

responsibility of looking after the pastoral staff in the areas of deployment and responsibilities.

由主任牧師和經挑選的成員組成的全職管理機構，協助主任牧師和同工團隊執行理事會的決策。它還負責照顧教牧人員的部署和職責。

- Ministries and Congregation Committee (MaC) 事工和堂會委員會 - consisting of heads of all Church-wide ministries and representatives from all Congregation Councils. The MaC had not been meeting due to practical, time-related difficulties getting everyone involved attending a single, large meeting, and communication with the ministries and congregations has been performed via the staff team. The Board will be considering holding MaC meetings in a different format to facilitate more direct communications with congregation leaders, Church-wide ministry heads and pastoral staff.

由全教會所有事工的負責人和所有堂會的代表組成。由於讓所有相關人員參加一次大型會議有時間上的實際困難，事工委員會一直沒有召開會議，與各部和堂會的溝通一直通過同工團隊進行。理事會將考慮以不同的形式舉行會務委員會會議，以便與會眾領袖、全教會的事工負責人和教牧同工進行更直接的溝通。

- Administration & Finance Committee (A&F) 行政與財務委員會 - A&F consists of members who are experienced in at least one or more administration or finance functions.

行政與財務委員會由至少具有一項或多項行政或財務職能。

### **Trustee Appointment, Induction and Training 受託人的任命、上崗和培訓**

All new trustees of the Church shall be nominated by the existing Board and their appointments shall be approved by a General Meeting. All new trustees will be given information about the responsibilities of being a trustee when they first join the Board. New trustees are provided with

- a copy of the Church's Articles of Association
- a copy of the Church's Bye Laws,
- guidance on the responsibilities of trustees.

The Church has ongoing training programme for the Trustees to enhance governance skills.

## **Organisational Structure 組織結構**

As of the end of 2022, the Church has 13 Sunday Services across 7 locations: Hammersmith, Soho and Seven-Dials Club (in Soho), Colindale, Croydon, Hounslow and Stratford. These services are run by 6 Congregation Councils. Each Congregation Council consists of at least a pastor and/or pastoral worker, Elders, Deacons, Congregation officers (Secretary, Treasurer, Carelinks Representative and Mission Representative) and heads of various departments. A Working Committee may be formed in each congregation to lead various departments and fellowships. Each congregation is given the responsibility to decide the best strategy and methodology to outreach, and to provide pastoral care, teaching and training to their members and worshippers.

截至 2022 年底，每主日教會在 7 個地點共舉辦 13 場主日禮拜：Hammersmith、Soho 和 Seven-Dials 俱樂部（位於 Soho）、Colindale、Croydon、Hounslow 和 Stratford。這些禮拜由 6 個堂會負責管理。每個堂會理事會至少由一名牧師和/或教牧同工、長老、執事、堂會官員（秘書、司庫、愛心聯繫代表和差傳代表）以及各部門負責人組成。每個堂會可成立一個工作委員會，負責領導各部門和團契。每個堂會有責任決定最佳的外展策略和方法，並為會友和信徒提供牧養、教導和培訓。

The Administration and Finance Committee meets every 3 months. It consists of members who are competent in one or more of the following disciplines: finance, legal, human resources, information technology (IT), audio visual (AV), building management and communications. The committee is given the responsibility for supporting the Church ministries with the above functions. It also sets up policies to monitor and approve expenses for the Church.

行政與財務委員會每三個月召開一次會議。委員會由精通以下一個或多個領域的成員組成：財務、法律、人力資源、信息技術（IT）、影音視聽（AV）、建築管理和通信。該委員會負責支持教會事工履行上述職能。委員會還制定政策，監督和批准教會的開支。

The Carelinks Committee and the Mission Concern Team (MCT) are headed by the Carelinks Secretary and Mission Secretary respectively. Each team consists of representatives from various congregations and is normally supported by a pastoral staff as an ex-officio. The Carelinks Committee helps the Church focus on social concerns, initiates and recommends social projects, and determines the level of financial support for supported organizations. The MCT helps the Church raise awareness of world mission, send, and support missionaries in different parts of the world.

愛心聯繫委員會和差傳關懷小組分別由愛心聯繫秘書和差傳秘書領導。每個小組由來自不同堂會的代表組成，通常由一名教牧人員作為當然成員提供支持。愛心聯繫委員會幫助教會關注社會問題，發起和推薦社會項目，並決定對受支持機構的財政支持水平。差傳關懷部幫助教會提高對世界宣教的認識，派遣和支持宣教士到世界各地宣教。

As of the end of 2022, the Church employed 20 full time, 7 part time and 2 volunteer staff comprising the pastoral and administrative staff, and interns. The staff team is headed by the Senior Pastor and assisted by other Pastors, Elders and the Head of Operations and the Head of Finance. In the absence of a Senior Pastor, the role is fulfilled by the Acting Senior Pastor (in the case of 2022, a Church Elder), appointed by the Board and supported by other Church Elder(s). The Senior Pastor's Office (SPO), which consists of pastor(s) and mature spiritual leaders appointed by the Senior Pastor or the Board, supports the Senior Pastor, together with the staff team, in ministry-related matters and staff care. The pastoral staff support the wellbeing of the congregations by providing pastoral care, visitation, preaching, teaching and training to the members and attendees. The Director of Operations and the Director of Finance, and the administration and finance teams are responsible for the day-to-day running of the Church Office, for building management and for supporting the ministries of the Church.

截至 2022 年底，教會共僱用了 20 名全職員工、7 名兼職員工和 2 名志願員工，包括教牧人員、行政人員和實習生。教職員團隊由主任牧師領導，其他牧師、長老、執行主管和財務主管協助其工作。主任牧師缺席時，由理事會任命的代理主任牧師（在 2022 年的情況下，由教會長老擔任）履行這一職責，並由其他教會長老提供支持。主任牧師辦公室（SPO）由主任牧師或理事會任命的牧師和成熟的屬靈領袖組成，與同工團隊一起支持主任牧師處理與事工有關的事務和照顧同工。教牧同工通過為會友和與會者提供教牧關懷、探訪、講道、教導和培訓，支持會眾的福祉。執行主管和財務主管，以及行政和財務團隊負責教會辦公室的日常運作、建築管理和支持教會的各項事工。

### **Risk Management 風險管理**

Being aware of their responsibilities for risk assessment, trustees periodically review the procedures for evaluating the risks associated with the Church's operating activities, review annually all insurances (including office, fire and general safety), as well as the terms and conditions of the employment of staff. A comprehensive review of the Risk Management policy and practice was conducted and approved by the Church Board in January 2022. The intention is to develop a comprehensive risk assessment manual which will identify all the significant risks which the charity faces and the measures in place to mitigate these risks. Two of which are the impact of Brexit, and the COVID-19 pandemic in 2020/2021 which, in particular, has been a major risk that the church needs to manage. As a charity, we are committed to maintain the level of services in our community but at the same time monitor expenditure and human resources in order to fulfil the Church's vision and objectives.

受託人意識到他們在風險評估方面的責任，定期審查與教會運營活動相關的風險評估程序，每年審查所有保險（包括辦公室保險、火災保險和一般安全保險），以及僱用員工的條款和條件。2022 年 1 月，教會理事會對風險管理政策和實踐進行了全面審查，並批准了這項審查。目的是製定一份全面的風險評估手冊，確定慈善機構面臨的所有重大風險，以及為減輕這些風險而採取的措施。其中兩項是英國脫歐的影響，以及 2020/2021 年的 COVID-19 大流行病，這尤其是教會需要管理的重大風險。作為一個慈善機構，我們致力於維持社區服務水平，但同時也要監控支出和人力資源，以實現教會的願景和目標。

### 3. PUBLIC BENEFITS 公共利益

The Church provides a spiritual home to Christians in London, from other parts of the U.K., and from abroad. The Church preaches the Gospel of Jesus Christ and teaches the Doctrines of the Christian faith in three different languages, though not exclusively to the Chinese in and around London. Local communities can benefit from the Church's activities, such as the activities mentioned above, as well as education conferences and efforts for social concerns. The Church also provides care, friendship and community lives to students, families and those who are in need.

教會為倫敦、英國其他地區和國外的基督徒提供了一個屬靈的家園。教會用三種不同的語言向倫敦及周邊地區的華人傳講耶穌基督的福音和基督教教義。當地社區可以從教會的活動中受益，如上述活動、教育會議和社會關注活動。教會還為學生、家庭和有需要的人提供關懷、友誼和社區生活。

The Board confirms that it has taken into account the Charity Commission's general guidance on public benefit when reviewing the Church's objectives and has considered how the planned activities contribute to the achievement of these objectives.

理事會確認，在審查教會的目標時，已考慮到慈善委員會關於公共利益的一般指導，並審議了計劃中的活動如何有助於實現這些目標。

The church has raised the awareness of our members in social justice by hosting a "Justice Month" in June 2022. Most of the short-term mission (STM) has gradually re-started in 2022 following the relaxation of COVID restrictions.

教會在 2022 年 6 月舉辦了「公義月」活動，提高了信徒對社會公義的認識。2022 年，隨著 COVID19 疫情限制的放寬，大部分短期宣教活動 (STM) 已逐步重新開始。

### 4. OBJECTIVES AND ACTIVITIES 目標和活動

The Chinese Church in London was founded as an unincorporated charity in 1951 by the late Pastor Stephen Y. T. Wang. Chinese Church in London, an incorporated charity presumed the activities and net assets of this unincorporated charity on 1 January 2011. The mission of the Church is to become an "Intentional Disciple-Making Church". Therefore since 2017 we set our Church vision as: "We exist to make disciples of Jesus to transform London and the world." The objects of the Church are as follows:

倫敦中華基督教會於 1951 年由已故王又得牧師創立，是一家非法人慈善機構。2011 年 1 月 1 日，倫敦中華基督教會作為一家註冊慈善機構，接管了該非法人慈善機構的活動和淨資產。教會的使命是成為「銳意建立主門徒的教會」。因此，自 2017 年起，我們將教會的異象設定為「我們的存在是使多人成為耶穌的門徒，轉化倫敦這個城市和整個世界。」。教會的目標如下：

- i. to preach the Gospel of Jesus Christ and to teach the Doctrines of the Christian Faith as set forth in the Holy Scriptures, primarily but not exclusively, to the Chinese in and around London;  
主要（但不限於）向倫敦及周邊地區的華人傳講耶穌基督的福音，並教授《聖經》中闡述的基督教教義；
- ii. to provide spiritual homes primarily but not exclusively for Chinese Christians in and around London;  
主要但不限於為倫敦及其周邊地區的華人基督徒提供屬靈家園；
- iii. to cooperate (when appropriate) with Christian churches and Christian organisations who share the same doctrines of faith;  
（在適當的時候）與信仰相同的基督教會和基督教組織合作；
- iv. to further the cause of Christ on the mission field worldwide;  
在全球宣教禾場推動基督的事工；
- v. to provide facilities for the use of the Chinese and English languages in worship and in the work of the Church;  
在崇拜和教會事工中，提供中英文並用的設施；
- vi. to promote the welfare primarily though not exclusively of Chinese in and around London, recognizing that the Gospel of Jesus Christ ministers to the whole person.  
促進倫敦及周邊地區華人的福利，但不限於此，因為耶穌基督的福音是全人的福音。

In supporting the above objectives, the longer-term objectives of the Church are as follows:  
為支持上述目標，教會的長期目標如下：

- a. to build up the believers in faith and send them out to serve the local communities and others at home and abroad;  
建立信徒的信心，差遣他們出去服侍當地社區和國內外的其他人；
- b. to equip the believers so they would multiply by making disciples of Jesus wherever they may go;  
裝備信徒，使他們無論到哪裡都能倍增，使人作耶穌的門徒；
- c. to adopt and implement the Intentional Disciple Making Church (IDMC) model in all congregations.
- d. 在所有會眾中採用並實施「銳意建立主門徒的教會」（IDMC）模式。

In the short term, the objectives of the Church are as follows:  
教會的短期目標如下：

- a. to increase regular Sunday worshippers to 2,000 including adults and children;  
將固定的主日崇拜者（包括成人和兒童）增加到 2,000 人；
- b. to increase the number of believers being baptised in the Church to 150;  
將教會中受洗的信徒人數增加到 150 人；
- c. to plant a church in East London. 在東倫敦建立一所教會。



In achieving these objectives, the Church encourages volunteers to serve, participate and lead in the various ministries including fellowship, worship, Bible studies, teaching and to support the activities organised, training, etc. They also provide leadership in committees such as the Board, Congregation Councils, Working Committees, in the areas of Administration & Finance, Carelinks, Mission Concern Team, The Next Generation Ministry as well as being volunteers in the pastoral team. Serving in the Church is part of Christian life and is one of the ways to demonstrate our love for God. The volunteers are essential and are integral to the development of the Church's ministries.

為實現這些目標，教會鼓勵義工在團契、敬拜、查經、教導等各項事工中服事、參與和帶領，並支持所組織的活動和培訓等。他們也在理事會、堂會委員會、工作委員會等委員會中發揮領導作用，在行政與財務、愛心聯繫、差傳關懷小組、下一代事工等領域發揮領導作用，同時也是教牧團隊中的義工。在教會中服侍是基督徒生活的一部分，也是彰顯我們對神的愛的方式之一。義工是教會事工發展不可或缺的重要力量。

The Church offers grants from the Theological Education Fund and the Mission Fund to certain individuals or organisations to contribute to the success of our objectives. We have set procedures and policies to ensure that grant receivers are committed to the work of Christ and in line with the Church objectives. Moreover, mentoring and/or prayer support are also given to these individuals or organisations.

教會從神學教育基金和差傳基金中撥款給某些個人或組織，以幫助他們成功實現我們的目標。我們有既定的程序和政策，確保接受資助的人致力於基督的工作，並符合教會的目標。此外，我們也為這些個人或機構提供輔導和/或禱告支持。

The Church employs full- and part-time pastoral and administrative staff to provide care, to outreach, to serve in community projects, to conduct services and manage the Church's properties and finances. This year we have spent a total of £1,577,321 on staff, activities, maintenance and events.

教會聘用了全職和兼職的教牧和行政人員，負責提供關懷、外展活動、社區項目服務、開展禮拜以及管理教會的財產和財務。今年，我們在員工、活動、維護和特會活動方面的總支出為 1,577,321 英鎊。

## **5. ACHIEVEMENTS, PERFORMANCE AND HOW THE CHARITY HAS DELIVERED PUBLIC BENEFITS** **成就、績效以及慈善機構如何實現公共利益**

As of 2022, close to 150,000 immigrants from Hong Kong were said to have arrived in the U.K. since the Hong Kong British National (Overseas) visa programme was launched on 31 January 2021. About 23% of them landed in London. As evidenced by Sunday service attendance, the Church has recovered from COVID and has grown in 2022 with an average attendance of close to 1,400 in 2022 (including adults, teens and children).

自 2021 年 1 月 31 日推出香港英國國民（海外）簽證計劃以來，截至 2022 年，據說已有近 15 萬香港移民抵達英國。其中約 23% 抵達倫敦。從主日崇拜的出席率來看，教會已經從 COVID 疫情恢復過來，並在 2022 年有所增長，2022 年的平均出席人數接近 1,400 人（包括成人、青少年和兒童）。

In view of the large number of Chinese residing in the East London area (over 28% of residents in London reside in the five boroughs of Tower Hamlets, Newham, Southwark, Lewisham and Greenwich), the Church has started trial runs of Sunday services in Dec. 2022 at Stratford (in Cantonese to start with), in addition to two 10-week sessions of Alpha in cooperation with All Saints West Ham. We have received generous contributions from a doner (for 3 years) for the project, and have started seeing fruits (2 became Christians and 1 was baptized in 2022).

鑑於東倫敦地區華人眾多（超過 28% 的倫敦居民居住在 Tower Hamlets、Newham、Southwark、Lewisham 和 Greenwich 五個區），教會已於 2022 年 12 月在 Stratford 開始試行主日崇拜（以粵語開始），此外還與 All Saints West Ham 合作舉辦了兩期為期 10 週的 Alpha 啟發課程。我們已收到一位捐贈者為該項目提供的慷慨捐助（為期三年），並已開始看到果實（2022 年有兩人成為基督徒，一人受洗）。

In 2022, the Church held 3 Baptism Services, and a total of 81 candidates were baptised. Besides connecting with newcomers, the Church has also organised Street Cafés at different locations throughout the year. The Church made use of these facilities to connect with the local communities. These were well received and some neighbours began to attend church services. Over 270 unchurched friends and neighbours attended the two Alpha sessions ran by the Church and at least 19 became Christians. We also partnered and participated in the Franklin Graham evangelistic crusade, known as the "God Loves You Tour", in July 2022 by conducting the training program in Chinese and by providing Cantonese and Mandarin language interpretation during the event. In addition, the Church supported 24 missionaries in 2022, and sent 4 Short-Term Mission (STM) teams to the Amazon-river villages, Croatia, Romania and Toulouse.

在 2022 年，教會舉行了 3 次洗禮崇拜，共有 81 名候選人受洗。除了與新移民建立聯繫外，教會還全年在不同地點舉辦街頭咖啡聚會。教會利用這些設施與當地社區建立聯繫。這些活動深受歡迎，一些鄰居開始參加教會聚會。超過 270 位未信主的朋友和鄰居參加了教會舉辦的兩季 Alpha 啟發課程，至少有 19 人成為了基督徒。我們也與葛培理國際事工（Franklin Graham）合作，參與了 2022 年 7 月舉行的「神愛你之旅」佈道會，以中文進行培訓課程，並在活動期間提供粵語和普通話傳譯。此外，教會在 2022 年支持了 24 位宣教士，並派出 4 個短宣隊前往亞馬遜河流域的村莊、克羅地亞、羅馬尼亞和圖盧茲。

The Church has also begun to organize itself along its language ministries to help promote cooperation, discipleship and unity. It has also started to streamline some of the discipleship programs, such as baptismal classes, promotion of Word of Faith etc. We have also finished the recording of the Cantonese version of the Freedom-In-Christ discipleship training



program. The Cantonese teaching series are now in post-production while the Mandarin version is being recorded.

教會還開始按照其語言事工進行組織，以幫助促進合作、門徒訓練和合一。教會也開始精簡一些門徒訓練項目，如洗禮班、信仰之道推廣等。我們也完成了「基督裡的自由」粵語版門徒訓練課程的錄製工作。粵語教學系列正在後期製作中，國語版正在錄製中。

## **Mission Concern Team 差傳關懷小組**

### **Mission Fund 差傳基金**

In 2022 we received £121k for Mission Fund (against budgeted £130K), of which £108k was allocated to our 24 Missionaries and 7 Mission Organizations. Travel restriction was lifted after March and we had 3 Short Term Missions to Croatia (for kids and youth camps supporting our Missionaries Andy and Lim), to Brazil partnering with Amazon Hope (to visit villages by boat), to Toulouse (to support local missionary for her outreach to university students and local families) took place in August and October.

2022 年，我們收到了 12.1 萬英鎊的差傳基金（預算為 13 萬英鎊），其中 10.8 萬英鎊分配給了我們的 24 名宣教士和 7 個宣教組織。三月份之後，旅行限制被取消，我們在八月和十月進行了三次短期宣教，分別前往克羅地亞（支持我們的宣教士安迪和林參加兒童和青年營）、與「亞馬遜希望」合作前往巴西（乘船探訪村莊）、前往圖盧茲（支持當地宣教士向大學生和當地家庭開展外展活動）。

In November, MCT organised a 4-week Mission Sermon Series and ended with the Mission Weekend on 25 to 27 November. "Mission for the Impossible" was the Mission Conference's theme and Dr Patrick Fung, General Director of OMF International from Singapore, was the keynote speaker. We had 11 different missionary speakers for the four weeks sharing the pulpit messages (Cantonese – 4, Mandarin – 4, English – 3). Friday Night's theme was "Fire on Mission" and three Short Term Mission teams shared their experiences together with missionaries supporting the STMs. Saturday afternoon was Family mission with the theme "Mission impossible in a confusing world". We had four workshops ran by various Mission Organisations, viz. "Mercy Ship – Save lives amongst forgotten poor in Africa", "OMF – Work+GO", "Teach Beyond – Rights to Education", and "Pioneers – Welcoming". There were also 9 Mission Organizations having booth stands at the PSW Hall to provide interactive information to all participants from Pioneers, Teach Beyond, Mercy Ships, OMF, WEC, OM, International Mission Board, Jian Hua Foundation and COCM.

11 月，差傳關懷小組舉辦了為期四週的宣教系列講道，並以 11 月 25 日至 27 日的宣教週末結束。差傳年會的主題是「知難而進」，來自新加坡的 OMF 國際總幹事馮浩鑒博士擔任主講員。在這四個星期裡，我們有 11 位不同的宣教士在講台上分享信息（粵語 4 位，普通話 4 位，英語 3 位）。週五晚上的主題是「差傳火熱」，三個短宣隊與支持短宣隊的宣教士分享了他們的經歷。週六下午是家庭差傳活動，主題是「亂世中熱情震動不可能」。我們有四個由不同宣教組織舉辦的工作坊，分別是「仁愛船—拯救非洲被遺忘的窮人的生命」、「OMF 海外基督使團—工作+GO」、「Teach Beyond—受教育的權利」和「先鋒—歡迎」。此外，有九個宣教團體在王又得牧師紀念堂設有攤位，

為所有與會者提供互動資訊，包括先鋒、教外、仁愛船、OMF、WEC、OM、國際宣道會、建華基金會和基督教華僑佈道會 COCM。

Global Monthly Mission Spots continued in 2022 with MCT news on Short Term Missions, Education workshops/events, missionaries' news and prayer videos, which were all produced with the help from external freelance video editor.

2022 年，全球宣教月刊繼續播出 MCT 的短宣新聞、教育工作坊/活動、宣教士新聞和禱告視頻，這些視頻都是在外部由視頻編輯自由工作者的幫助下製作的。

### **Dr Peter Chow Memorial Mission Education Fund 周照文醫生差傳教育基金**

In 2022 we supported Janice and Mads in their studies in All Nations Christian College finishing in July 2023 with £10k.

2022 年，我們資助 Janice 和 Mads 在萬國基督教神學院學習，並於 2023 年 7 月完成學業，資助金額為 1 萬英鎊。

### **Carelinks ministry and Carelinks Fund 愛心聯繫事工和愛心聯繫基金**

The Carelinks Ministry financially supported five charities, viz. TearFund, CEDAR Fund, Christian Centre for Gambling Rehabilitation (CCGR), Chinese Association for Cancer Care (CACACA) and Tamar, as of the core of its social concern activities.

作為其社會關懷活動的核心，愛心聯繫事工在財政上支持了五個慈善機構，即淚基金、CEDAR 施達基金、福音戒賭中心 (CCGR)、英國華人關懷癌症協會 (CACACA) 和他瑪 Tamar。

In 2022, the church donated £ 35,941 to the above organisations (2021: £ 39,272) following the receipt of donations intended for the Carelinks Fund. Our target in 2023 is £ 50,000. Contributions in excess of the target will be sent in its entirety to the organizations listed. Other social projects undertaken by Carelinks included the Operation Christmas Child from Samaritan's Purse. The church has raised the awareness of our members in social justice by having a "Justice Month" in June 2022. The month-long activities include talks, workshops, games etc. led by external speakers and/or Church volunteers.

2022 年，教會在收到本打算捐給愛心聯繫基金的捐款後，向上述組織捐贈了 35,941 英鎊 (2021 年：39,272 英鎊)。2023 年的目標是 50,000 英鎊。超出目標的捐款將全部捐給所列組織。愛心聯繫開展的其他社會項目包括撒瑪利亞救援會的「聖誕兒童行動」。教會在 2022 年 6 月舉辦了「公義月」活動，以提高會友的社會公義意識。為期一個月的活動包括由外來講員和/或教會義工主持的講座、工作坊、遊戲等。

Pastor CK Cheung, David Chau (acting secretary) and the Carelinks team appreciate the support and donation from the church family. May we continue to act justly and to love mercy: "He has shown you, O mortal, what is good. And what does the LORD require of you? To act justly and to love mercy and to walk humbly with your God." (Micah 6:8).

張春權牧師、代理秘書週啟賢及愛心聯繫小組感謝教會大家庭的支持及捐款。願我們繼續行公義，愛憐憫：「世人哪、耶和華已指示你何為善。他向你所要的是甚麼呢。只要你行公義、好憐憫、存謙卑的心、與你的神同行。」(彌迦書 6：8)。

## **The Next Generation Ministry 下一代事工**

The Next Generation (TNG) is the core ministry for primary-school-aged children (Kids Church) and secondary-school-aged youths (Youth Ministry) comprising of ministry groups attached to each congregation across the Chinese Church in London.

下一代事工 (TNG) 是針對小學學齡兒童 (兒童教會) 和中學學齡青少年 (青少年事工) 的核心事工，由隸屬於倫敦中華基督教會各堂會的事工小組組成。

The ministry year follows the academic year and therefore began with the Autumn Term in September 2021. In the Spring Term, commencing January 2022, Pastor Ollie Knight resumed normal duties and visited the TNG Ministry groups at each centre, and began planning for a number of key ministry events. Together with Pui Yin Ho, he visited Fort Bend Community Church (FBCC) in Texas, USA, to join their Sticky Faith Conference, which a number of congregation leaders joined remotely from London.

事工年度與學年一致，因此從 2021 年 9 月的秋季學期開始。在 2022 年 1 月開始的春季學期，劉浩然牧師恢復了正常的工作，並拜訪了各中心的 TNG 事工小組，開始計劃一些重要的事工活動。他與何沛然一起訪問了美國福遍中國教會 (Fort Bend Community Church)，參加了該教會的「甩不掉的信仰」特會。

In March 2022, our TNG Pastoral Team partnered with COCM to deliver a training event for youth ministry volunteers from Chinese churches across the UK, with a focus on integrating British-born Chinese (BBC) and British National Overseas (BNO) youths in order to disciple them effectively. In April 2022, we welcomed our new children's minister (Kids Church Pastoral Worker) Gladys Ng. She has begun connecting with the team leaders of all Kids Church groups, identifying needs for future development of this ministry, and she is based in the Hammersmith Cantonese Congregation.

2022 年 3 月，我們的 TNG 教牧團隊與 COCM 合作，為來自英國各地華人教會的青少年事工志願者舉辦了一次培訓活動，重點是如何融合英國出生的華人 (BBC) 和新一批香港移民家庭的 (BNO) 青少年，以便有效地對他們進行門徒訓練。2022 年 4 月，我們迎來了新任兒童事工牧者 (兒童教會教牧同工) 吳婉茵傳道。她已開始與所有兒童教會小組的組長聯繫，確定這項事工未來發展的需要。

After two years of postponed events, we held our largest ever Youth Easter Camp (YEC22) on 15-18 April, with 75 youths and 30 adults, including 20 small group leaders. The theme of the camp was 'Rooted' exploring our identity in Christ. Although our speaker, Ansonia Wong – youth minister from the Birmingham Chinese Evangelical Church, caught COVID

just before the camp, she was still able to deliver the messages via livestream. A number of youths committed their lives to Christ and expressed an interest in baptism.

經過兩年的延期，我們於 4 月 15 日至 18 日舉辦了有史以來規模最大的青少年復活節營會（YEC22），共有 75 名青少年和 30 名成人參加，其中包括 20 名小組組長。營會的主題是「紮根」，探索我們在基督裡的身份。雖然我們的主講人—伯明翰中華福音教會的青年牧師 Ansonia Wong 在營會開始前剛剛感染了 COVID 病毒，但她仍然能夠通過現場直播來傳遞主題信息。一些青少年將自己的生命交託給了基督，並表示有興趣接受洗禮。

In the Summer Term following Easter, we took the opportunity of Father's Day in June to share a message on inter-generational discipleship in every CCiL congregation, delivered by the TNG Pastoral Team as a follow-up from the Sticky Faith Conference. Congregation leaders have been encouraged to continue exploring local initiatives to facilitate bridge-building between different generations in our church community. In July, we held a Youth & English Ministry Baptism Celebration Service where 13 candidates were baptised. Summer activities have included PHAT, an annual youth camp in partnership with COCM, and a 4-day summer children's programme with a short-term mission team from FBCC.

在復活節後的夏季學期，我們利用六月份父親節的機會，在每一個 CCiL 會眾中分享了關於跨代門徒訓練的信息，該信息由 TNG 教牧團隊發布，作為「甩不掉的信仰」會議的後續活動。我們鼓勵會眾領袖繼續探索當地的活動，以促進教會社區中不同代際之間的橋樑建設。七月，我們舉行了青年及英語事工洗禮慶典，13 位候選人接受了洗禮。暑期活動包括與基督教華僑佈道會（COCM）合作舉辦的年度青少年夏令營（PHAT），以及一個為期四天的暑期兒童活動，該活動是與來自美國福遍中國教會（FBCC）的短宣隊合作舉辦的。

In preparation for the new ministry year with the Autumn Term in September 2022, the church ran a recruitment process to hire further new staff for The Next Generation Ministry. This began with the commencement of a pastoral internship for John Ho, a recent graduate from the London School of Theology. His focus is on the English-speaking university student fellowship, which is connected with the English Ministry of the New Soho Congregation, and developing the transition process for youths going into university life. 為了迎接 2022 年 9 月秋季學期的新事工年度，教會開展了招聘工作，為下一代事工招聘更多的新同工。首先，剛從倫敦神學院（London School of Theology）畢業的何祉樺弟兄（John Ho）開始了教牧實習。他的工作重點是英語大學生團契，該團契與蘇豪福音堂的英語事工有關，並為即將進入大學生活的青少年制定過渡程序。

In October, this was followed by the commencement of another pastoral internship for Haynam Sham, whose focus is on leading Ignite Youth Group, currently our largest youth group following the BNO influx, based in Croydon Congregation. Alongside the 1-year internship, she will be undertaking an online course with Waverley Abbey College in Contemporary Discipleship, in 2023. After five years of serving in The Next Generation Ministry at CCiL, our pastoral worker Hannah Chan has stepped down in November 2022. The term ended with a Christmas Youth Celebration in December 2022, for all TNG youth groups.

今年 10 月另一位教牧實習生岑曦嵐姊妹 ( Haynam Sham ) 也加入了我們，主要負責領導青年團契 ( Ignite Youth Group )，該團契是目前我們在 BNO 湧入之後規模最大的青年團契，位於凱敦堂 ( Croydon Congregation )。除了為期一年的實習，她還將於 2023 年在韋弗利修道院學院 ( Waverley Abbey College ) 學習當代門徒訓練的在線課程。經過在教會下一代事工五年的服事，我們的教牧同工陳朗思姊妹 ( Hannah Chan ) 將於 2022 年 11 月卸任。2022 年 12 月，所有 TNG 青年組都參加了聖誕青年慶典，為本學期畫上了圓滿的句號。

## 6. PLANS FOR FUTURE PERIODS 未來期間計劃

**The Board has identified and endorsed the following Priorities:**

理事會確定並批准了以下優先事項：

- i. **Governance:** The Board continues to seek improvement to strengthen the current governance as headed by the Board so that the whole Church with its various centres and growing congregations may serve the church community with greater alignment to our vision and priorities and with a stronger sense of corporate identity.

治理：理事會繼續尋求改進，以加強目前由理事會領導的管治，從而使整個教會及其各中心和不斷增長的會眾能夠更加配合我們的異象和優先事項，並以更強的團體認同感為教會社區服務。

The Board has produced an ordination policy which has been used for the ordination of Pastor Oliver Knight and for Pastor Pui Yin Ho in 2023. The Church will continue to plan for the ordination for other suitable members of pastoral staff.

理事會已製定了按立政策，該政策已用於按立劉浩然牧師和 2023 年按立何沛然為牧師。教會將繼續計劃按立其他合適的教牧同工。

The Board has put in place staff supervision and line-management structure to improve staff welfare and accountability, and will continue to monitor our staff's well-being.

理事會已建立了員工監督和直線管理結構，以改善員工福利和問責制，並將繼續監測員工的福利情況。

- ii. **Invest in Future:** The Church currently meets in centres over six geographic locations (not including Seven Dials since it is under the administration of Soho). Each centre aims to provide services in three languages: Mandarin, English and Cantonese (although in some locations not all three languages are offered). Since COVID, online live-stream Sunday Services have been running in parallel with physical Sunday Service in most of our centres.

投資未來：教會目前在六個地區的中心聚會（不包括 Seven Dials，因為它歸蘇豪福音堂管理）。每個中心的目標是提供三種語言的崇拜事工：普通話、英語和粵語（但有些地方不提



供所有三種語言)。自 COVID 以來，在線直播主日崇拜與大部分中心的實體主日崇拜同步進行。

The next generation is increasingly multi-cultural and their friends reflect the diversity of London. This has presented challenges in that each centre-based leadership now has to serve the local church community in a diverse manner. The next generation is also very adaptable to new technology and online gatherings.

下一代越來越具有多元文化，他們的朋友也反映了倫敦的多樣性。這帶來了挑戰，因為每個中心的領袖層現在都必須以多樣化的方式來服侍當地教會社區。下一代對新科技和在線聚會的適應能力也很強。

The church has begun trial runs of Sunday services at Stratford, in Cantonese to begin with in order to reach out to the vast Chinese population in East London, as well as to the new Hong Kong immigrants. The church has therefore added several staff due to the attrition of existing staff and as a result of the Church's growth. As the Church is expected to have over 2,000 Sunday service attendees in the latter half of 2023, the Board continues to review the deployment and recruitment of pastoral staff, including voluntary workers, as well as proposals for church plants, second services, and the rental of additional space for Sunday services and other activities. The Church will continue to identify, train and mentor capable staff members and volunteers to attend to the challenges and take on leadership role in each centre.

為了向倫敦東區的廣大華人以及新一批香港移民傳福音，教會開始在東鄰堂試行粵語主日崇拜。由於現有員工的流失和教會的發展，教會增加了幾名員工。預計到 2023 年下半年，教會整體主日崇拜的參加人數將超過 2,000 人，因此理事會將繼續審查教牧人員（包括義工）的調配和招聘，以及植堂會、增添第二堂崇拜、租用額外空間進行主日崇拜和其他活動的建議。教會將繼續物色、培訓和指導有能力的同工和義工，以應對各中心的挑戰和擔當領導角色。

The Church held a staff retreat in July 2021 to discuss and plan for such growth. One of the key elements is the gradual transformation of the Church into language-based ministries under which pastoral and volunteer staff who major in one particular language will cooperate and support each other in preaching, teaching, training, in strategic planning, and in other ways possible to make better use of existing resources, to promote unity, and to make quality decisions more suited to its cultural context. In addition, the church is in the process of building up an e-library of teaching materials to support our disciple-making process (along language-based ministry lines) including the recording of Cantonese and Mandarin versions of Freedom in Christ.

教會於 2021 年 7 月舉行了一次同工退修會，討論和計劃這種增長。其中一個關鍵因素是，教會將逐步轉變為以語言為主導的事工，在這種事工中，主修一種語言的教牧人員和義工將在講道、教導、培訓、戰略規劃以及其他可能的方面相互合作和支持，以便更好地利用現有資源，促進合一，並做出更適合其文化背景的高質量決策。此外，教會正在建立一個電子資料

庫，以支持我們的門徒訓練過程（以語言為主導的事工），包括錄製粵語和普通話版本的《基督裡的自由》。

**Ministries:** As a church we believe that the spiritual wellbeing is of importance to all the charity work. In the coming year, we will continue to promote regular corporate and individual prayer groups at each centre. We will also aim to improve and consolidate biblical teachings so that our members would receive the spiritual nourishment they need, and make effective use of the available church resources. This is in-line with our growth plan as an Intentional Disciple-making Church. The focus is to help every believer become a disciple of Jesus Christ. A number of our staff members have retired in 2022 but new staff have been added to provide adequate coverage during this transition period.

**事工：**作為一個教會，我們相信屬靈的健康對所有慈善工作都非常重要。來年，我們將繼續在各中心推廣定期的團體和個人禱告小組。我們還將致力於改進和鞏固聖經教導，使我們的成員能夠得到所需的屬靈滋養，並有效地利用現有的教會資源。這與我們作為一個銳意建造主門徒的教會的成長計劃是一致的。我們的重點是幫助每一位信徒成為耶穌基督的門徒。一些同工將於 2022 年退休，但我們已經增加了新的同工，以便在這一過渡時期提供足夠的保障。

As a Charity we are also aware of the needs in our communities. In the coming year, we will seek to work with various community projects to provide support to people affected by the economic downturn, illness and losses, such as counselling services, social economic projects such as foodbanks, elderly fellowships, English classes, and will collaborate with para-church organisations to deliver the services.

作為一家慈善機構，我們也意識到社區的需求。來年，我們將尋求與各種社區項目合作，為受經濟衰退、疾病和損失影響的人們提供支持，如心理輔導服務、社會經濟項目，如食物銀行、長者團契、英語班等，並將與準教會組織合作提供服務。

We continue to have a Memorandum of Understanding with Chinese Overseas Christian Mission (COCM) for sharing of information and resources (in particular human resources).

我們繼續與基督教華僑佈道會（COCM）簽署諒解備忘錄，共享信息和資源（尤其是人力資源）。

Following the successful church plant project in East London in 2022, the Church will continue to seek opportunities for further church plants in other parts of London (such as Ealing, Kingston and Bromley) in order to provide pastoral care for new immigrants from Hong Kong, and for local residents in the vicinities.

繼 2022 年在東倫敦成功建立堂會後，教會將繼續在倫敦其他地區（如 Ealing, Kingston, and Bromley）尋找機會進一步植堂，為來自香港的新移民和附近地區的當地居民提供牧養關懷。

## 7. FINANCIAL REVIEW 財務審查

The church reported a net deficit of £161,458 for the 2022 financial year, surpassing the previous year's reported loss of £48,300. Nevertheless, this deficit remained lower than our projected loss of £164,425.

教會在 2022 財年報告的淨赤字為 161,458 英鎊，超過了上一財年報告的 48,300 英鎊的赤字。儘管如此，這一赤字仍低於我們預計的 164,425 英鎊。

The most significant expenditure for the church was the payroll, with £906,211 allocated for staff salaries and pensions. Moving forward, the board will continue to diligently review and monitor payroll expenses.

教會最主要的支出是工資，906,211 英鎊用於員工工資和養老金。今後，理事會將繼續認真審查和監督工資支出。

Donations and rental income play a vital role in supporting the church's objectives. In 2022 the accumulated Unrestricted Fund reserve currently stands at £762,595. Within this balance, a net unrestricted loss of £127,538 was incurred during the 2022 financial year.

捐款和租金收入在支持教堂實現目標方面發揮著至關重要的作用。2022 年，累計無限制基金儲備金目前為 762,595 英鎊。在這一餘額中，2022 財年無限制淨虧損為 127,538 英鎊。

As of the end of 2022, the Restricted Funds reserve amounts to £5,236,846, with a net deficit of £33,919 attributed to all restricted funds in the 2022 financial year.

截至 2022 年底，受限基金儲備金為 5,236,846 英鎊，2022 財年所有受限基金的淨赤字為 33,919 英鎊。

Our analysis indicates that donations have rebounded to pre-pandemic levels as of December 2022, with a total of £1.06 million contributed to the general fund.

我們的分析表明，截至 2022 年 12 月，捐款已回升到 COVID 疫情前的水平，普通基金共收到 106 萬英鎊捐款。

The Articles of Association empower the Board to invest cash which is not immediately required. We have decided to invest into a savings account and aim to generate interest income.

《教會公司章程》授權理事會投資非急需的現金。我們已決定將其投資於一個儲蓄賬戶，以獲得利息收入。



## 8. STATEMENT OF TRUSTEES' RESPONSIBILITIES 受託人責任聲明

The Trustees (who are also the Directors of the Chinese Church in London) are responsible for preparing the Annual Report and financial statements in accordance with applicable law and United Kingdom Accounting Standards (United Kingdom Generally Accepted Accounting Practice), including Financial Reporting Standard 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland". Company law and the law applicable to charities in England and Wales require the Trustees to prepare financial statements for each financial year which give a true and fair view of the state of affairs of the Charitable Company and of its incoming resources and application of resources, including its income and expenditure, for that period.

受託人（同時也是倫敦中華基督教會的理事）負責根據適用法律和《英國會計準則》（英國公認會計慣例），包括《財務報告準則》第 102 條「適用於英國和愛爾蘭共和國的財務報告準則」，編制年度報告和財務報表。公司法和適用於英格蘭及威爾士慈善機構的法律要求受託人編制每個財政年度的財務報表，真實、公平地反映該財政年度內慈善公司的財務狀況及其資源收入和使用情況，包括收入和支出。

In preparing these financial statements, the Trustees are required to:-

### **Opinion**

We have audited the financial statements of Chinese Church in London (the 'charitable company') for the year ended 31 December 2022 which comprise the Statement of Financial Activities (including the Income and Expenditure Account), the Balance Sheet, the Statement of Cash Flows and the notes to the financial statements, including a summary of significant accounting policies. The financial reporting framework that has been applied in their preparation is applicable law and United Kingdom Accounting Standards (United Kingdom Generally Accepted Accounting Practice), including Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland'.

### **意見**

## 1. ACCOUNTING POLICIES 會計政策

### (a) Basis of Accounting 會計基礎

These accounts have been prepared under the historical cost convention, in accordance with the Financial Reporting Standard 102, the Companies Act 2006 and the requirements of the Statement of Recommended Practice, Accounting and Reporting by Charities (FRS 102). The company is a public benefit entity.

這些賬目是按照歷史成本慣例、財務報告標準 102、2006 年公司法以及慈善機構會計和報告建議實踐聲明 (FRS 102) 的要求編制的。該公司是一個公益實體。

The trustees consider that there are no material uncertainties about the Charity's ability to continue as a going concern. As detailed in note 22, in forming this opinion, they have considered the impact of the Covid-19 pandemic on both its income and expenditure for at least a period of twelve months from the date of approval of these financial statements.

### (b) Fixed Assets 固定資產

Fixed assets are disclosed at cost net of depreciation to date. Assets transferred from the predecessor charity have been recorded at cost equivalent to their net book value in the predecessor charity at the date of transfer.

### (c) Depreciation 折舊

Depreciation of fixed assets is calculated on cost at rates estimated to write off the assets, by equal instalments, over their expected working lives. Fixtures and fittings and office equipment are written off on a straight line basis over 5 years and 3 years respectively. Buildings and building improvements have been depreciated over the life of the property which has been estimated at 50 years. As a result of a review of the depreciation policy, the installed lift is being written off over its remaining useful life. The cost of improvements at the United Reform Church are depreciated over 20 years. Depreciation charges on assets transferred from the predecessor charity continue to be applied on the basis of cost to the predecessor charity and the predecessor charity's estimate of economic life.

**(d) Income 收入**

All income is recognised in the Statement of Financial Activities once the charitable company has entitlement to the funds, any performance conditions attached to the items of income have been met, it is probable that the income will be received and the amount can be measured reliably.

Donations, covenants and legacies are credited to the accounts in the year in which they are receivable, grossed up for tax recoverable where appropriate.

Interest is credited to the accounts in the year in which it is receivable.

The Charity is not registered for VAT and accordingly, where applicable, all costs and expenditure incurred are shown inclusive of VAT.

**(f) Funds 資金**

Unrestricted funds are those funds, which can be used at the Trustees' discretion. Restricted Funds are funds whose purposes have been restricted by the donor.

**(g) Expenditure 支出**

Charitable expenditure comprises direct expenditure attributable to the charitable objectives or activities and support costs. Where costs cannot be attributed, they have been apportioned to charitable objectives or activities according to the time or resources spent on each. Support costs are those functions that assist the work of the charitable company but do not directly undertake fundraising or charitable activities. Support costs include general overheads and governance costs (those costs incurred in the governance of the charitable company and its assets and are primarily associated with constitutional and statutory requirements).

The classification of financial instruments, both assets and liabilities, as 'basic' or 'other' requires judgement as to whether all applicable conditions as basic are met. This includes the type of investment or loan and its return. The Charity only has financial assets and liabilities of a kind that qualify as basic financial instruments. These are initially recognised at transaction value and subsequently valued at their settlement value.

Debtors are recognised when the Charity is legally entitled to the income after any performance conditions have been met, the amount can be measured reliably and it is probable that the income will be received. Creditors are recognised when the charity has a present legal or constructive obligation resulting from a past event to make payment to a third party, it is probable that settlement will be required and the amount due to settle the obligation can be measured or estimated reliably.

For the purpose of the Statement of Cash Flows cash and cash equivalents are as defined above net of outstanding bank overdrafts if they exist.
