The objects of the Charity are the preservation, repair, restoration, maintenance and improvement (either by means of alteration or by means of addition for the public benefit) of the fabric of St George's RC Church, Taunton, the old pre-school nursery, the old school, the rectory and parish centre and the contents, major fittings and ornaments, but without prejudice to the generality of the foregoing, the organ chimes, statues, monuments, brasses, vestments and grounds and ancillary charitable purposes.

The Friends of St Georges RC Church – Taunton has as its main aim and purpose the raising of funds to support the parish priest in his work, and the Roman Catholic and wider community of Taunton by maintaining and improving St Georges Church, the old pre-school nursery, the old school, the rectory, parish centre and grounds.

The trustees in considering these aims and purposes have considered the Commission's guidance on Public benefit and the specific guidance on charities for the advancement of religion.

Achievements and Performance

The Victorian Church as a Grade II* listed building is important as the main centre of Roman Catholic worship in Taunton and surrounding area, as well as being part of the cultural and historic heritage of the town.

Achievements and Performance (Continued)

As well as being a place of worship for the Roman Catholic community, the church hosts ecumenical events from time to time; and is used as a venue for concerts. The church is kept open almost all day every day for private worship or for any member of the public for private prayer or just as a place for quiet, intimate and peaceful reflection.

In addition to use by the parish, the parish centre and ancillary buildings are available for hire and are used by many local organisations, not linked to the church, including The Women's Institute, the NHS and various clubs.

Trustees' Responsibilities

The Charities Act 1993 requires the Trustees to prepare a Receipts and Payments Account and a Statement of Assets and Liabilities. The Trustees are responsible for keeping proper accounting records which disclose with reasonable accuracy at any time the financial position of the Charity. They are also responsible for safeguarding the assets of the Charity and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

Review of the Year

Friends of St George's Trust was started in 2005 as a charity for the preservation, repair, restoration maintenance and improvement of the fabric of St George's Church and associated property. Since then, through the generosity of parishioners, the trustees have raised funds to install the window at the north end of the church, the cleaning and repair of the stained glass window above the altar and fund many other repairs and improvements.

During the year 2024-2025 the Trust was asked by the parish priest for funding a contribution of £10.5k towards secondary glazing for the Rectory, £22k towards pinnacle repairs to the church tower and moss removal from the church roof, helped by a generous donation of £10k from a parishioner, and £8k towards the cost of the PV panels and storage batteries for the Catholic Centre.

The Trust is generously supported by parishioners who contribute by standing order or by joining the 200 Club. The Trust is also supported by both legacies and donations at funerals.

On behalf of the Parish Congregation and the Parish Priest, may I thank all the parishioners who contribute to this worthy charity. This year Geraldine Braycotton resigned as a trustee and was replaced by Adrian Gamble. Personally I also would like to thank my fellow trustees for their time and skills in maintaining the trust. During the year 2023-2024 the Trust was asked by the parish priest for funding refurbishment of the church lighting to modern standards and LED lighting (£26,791), removal of asbestos revealed by the quinquennial survey (£58,085) and a contribution towards secondary glazing in the rectory (£15,000).

The Trust is generously supported by parishioners who contribute by standing order or by joining the 200 Club. The Trust is also supported by both legacies and donations at funerals.

The Charities Act 1993 requires the Trustees to prepare a Receipts and Payments Account and a Statement of Assets and Liabilities. The Trustees are responsible for keeping proper accounting records which disclose with reasonable accuracy at any time the financial position of the Charity. They are also responsible for safeguarding the assets of the Charity and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

Review of the Year

Friends of St George's Trust was started in 2005 as a charity for the preservation, repair, restoration maintenance and improvement of the fabric of St George's Church and associated property. Since then, through the generosity of parishioners, the trustees have raised funds to install the window at the north end of the church, the cleaning and repair of the stained glass window above the altar and fund many other repairs and improvements.

During the year 2022/23 the Trust was asked by the parish priest for funding to cover the cost of replacement and restoration of certain brasses. The Trust was also asked to assist with the funding of the refurbishment and upgrading of the Church lighting system (£26,926) and the removal of asbestos as revealed by the quinquennial survey carried out in the year (£39,000). The last two items were not paid out during the year, however, a transfer to restricted funds has been made to reflect the commitment.

The Trust is supported by parishioners who contribute by standing order or by joining the 200 Club. The Trust is also supported by both legacies and donations at funerals.

On behalf of the Parish Congregation and the Parish Priest, may I thank all the parishioners who contribute to this worthy charity. Personally, I would like also to thank my fellow trustees for their time and skills in maintaining the Trust.

4 Unrestricted and Restricted Funds

Restricted funds are the unexpended balances of funds raised for specific purposes within the Charity's objectives and which must be applied for those purposes only. All funds raised by the charity prior to 1 April 2010 were for the purposes of installing a new stained glass window and the redecoration of the church in celebration of the church's 150th anniversary. The balance of funds held at 31 March 2010 was therefore restricted to that specific purpose. At 31 March 2023 £65,926 was allocated to help finance the refurbishment and upgrading of the church lighting system and the removal of asbestos as revealed by the quinquennial survey carried out in the year.

Unrestricted funds are the free funds of a Charity, which are not designated for a particular purpose, and can therefore be used in furtherance of the general objects of the Charity.
