The FOBS is a small PTA covering Brookfield Infant and Junior School. The school has 450 pupils on roll across the Federation. Brookfield Infant School and Brookfield Junior School make up the Flourish Federation linking the two schools as they are both situated on the same site. The SLT work across both sites and create a joined-up approach to many aspects of their management.

The FOBS work closely with the senior management team. We have 4 trustees listed above and we head up the FOBS team. We have approximately 10 active members who support us to varying levels. We recruit new members through holding regular meetings about events, inviting new parents to the school by taking part in the "New Parent" meeting hosted by the SLT. We also send out flyers at the start of each new intake to new parents if they wish to get involved.

We hold an annual AGM in September/October. All parents are invited to attend and the SLT from both schools are also invited. One member of SLT as a minimum is always in attendance.

The objective of the FOBS is "Raising funds to enhance children's experience at Brookfields"

Each year we plan our activities working closely with the SLT so ensure we do not clash with any other events and share this plan with the wider FOBS group.

This was a busy year for us as we had just come out of covid and held two summer fetes in on academic year

Holding these events enabled the FOBS to contribute a substantial amount to the school to help cover the cost of interactive white boards for each class across both Infant and Junior school. This was a huge investment and one that will enhance the children's learning experience. Something the FOBS pride themselves on being able to do. Each year we present the year 2 leavers with a wooden medal as a memento of their time at Brookfield Infants before they move onto the Junior school. During this year it was also the Queens Platinum Jubilee and an important event we felt should be recognised. Every child at the Flourish Federation received a medal in recognition of this.

Running a PTA also has annual costs and at times investments must be made. This year we needed new gazebos for our events and we needed a new large gazebo used for refreshment purposes for many events. The school also have access to the Gazebos for their events such as sports day etc. We are also a member of Parent kind a PTA group that we use for help and advise including flyer template etc and this has an annual subscription of £116.00.

Any expenditure we make is passed by the wider FOBS group. We do not spend any of the profit without a majority vote. The trustees do not make these purchases without the wider group approval.

The FOBS prides itself on also being a part of the community. Our community events are very well attended and the School Fete and Fire work events are fast becoming a hugely well attended event that is building year on year. The school now manage the firework event directly due to the size of the event as it has grown year on year. The FOBS are however very proud that we introduced the school to the event and proved how popular it could be. We make sure where possible we cater for everyone. We don't charge entry to our fete making it accessible to all. Although we are here to raise funds for the school, we are also acutely aware of the cost-of-living a like to be able to include everyone at the fete.
