Activities

Objects: (A) THE PROTECTION OF THE ENVIRONMENT AND WILDLIFE, INCLUDING ELEPHANT CONSERVATION IN PARTICULAR BUT NOT EXCLUSIVELY IN SRI LANKA, THROUGH THE PROVISION OF RESOURCES TO ENVIRONMENTAL ORGANISATIONS AND INDIVIDUALS TO ADVANCE ENVIRONMENTAL JUSTICE, AND TO PREVENT ENVIRONMENTAL DESTRUCTION AND CLIMATE CHANGE. (B) TO PROMOTE SOCIAL JUSTICE, THE RELIEF OF POVERTY AND THE ERADICATION OF SOCIAL INEQUALITY IN PARTICULAR BUT NOT EXCLUSIVELY AMONG CHILDREN AND THE ELDERLY IN SRI LANKA, THROUGH THE PROVISION OF FINANCIAL AID, FOOD, CLOTHING, HOMES AND MEDICAL AID. (C) THE ADVANCEMENT OF EDUCATION IN PARTICULAR BUT NOT EXCLUSIVELY AMONG CHILDREN IN SRI LANKA, THROUGH THE PROVISION OF RESOURCES TO ENABLE THEM TO PURSUE THEIR EDUCATION. (D) TO PROMOTE HUMAN RIGHTS (AS SET OUT IN THE UNIVERSAL DECLARATION OF HUMAN RIGHTS AND SUBSEQUENT UNITED NATIONS CONVENTIONS AND DECLARATIONS) IN PARTICULAR BUT NOT EXCLUSIVELY IN SRI LANKA, THROUGH THE PROVISION OF FINANCIAL GRANTS TO ORGANISATIONS AND INDIVIDUALS ENGAGED IN HUMAN RIGHTS, CRIMINAL JUSTICE, CHILD PROTECTION, PEACE AND RECONCILIATION, PENAL REFORM, LEGAL EDUCATION, LEGAL REPRESENTATION AND ACCESS TO JUSTICE. IN FURTHERANCE OF THAT OBJECT BUT NOT OTHERWISE, THE TRUSTEES SHALL HAVE POWER: TO ENGAGE IN POLITICAL ACTIVITY PROVIDED THAT THE TRUSTEES ARE SATISFIED THAT THE PROPOSED ACTIVITIES WILL FURTHER THE PURPOSES OF THE CHARITY TO AN EXTENT JUSTIFIED BY THE RESOURCES COMMITTED AND THE ACTIVITY IS NOT THE DOMINANT MEANS BY WHICH THE CHARITY CARRIES OUT ITS OBJECTS.

Activities: Social Justice and Environmental Justice in Sri Lanka. Raise awareness, funds and make grants to protect poor communities, children, disabled, the environment and endangered animals in Sri Lanka. Run entirely by unpaid trustees and volunteers since 31. 1. 05.
