PROVIDING PRACTICAL ASSISTANCE IN ACCORDANCE WITH SUB CLAUSE 3.1.8 BELOW; ANDIII. PROMOTING RESEARCH AND PUBLISHING THE USEFUL RESULTS THEREOF IN ACCORDANCE WITH SUB CLAUSE 3.1.11 BELOW;3.1.5 THE REDUCTION AND ELIMINATION OF DISCRIMINATION ON THE GROUNDS OF RACE AND RELIGION BY ALL OR ANY OF THE FOLLOWING MEANS:I. PROVIDING INFORMATION AND EDUCATION ABOUT THE CAUSES AND EFFECTS OF RACIAL AND RELIGIOUS DISCRIMINATION;II. RACIAL OR RELIGIOUS DISCRIMINATION;V. ALCOHOL AND DRUGS ABUSE AND MISUSE;VI. CRIME INCLUDING ANY FORM TERRORISM;3.1.9 TO PROMOTE AND ASSIST IN THE REHABILITATION OF EX-OFFENDERS AND PERSONS AFFECTED BY DRUG, ALCOHOL OR OTHER SUBSTANCE ADDICTION OR ABUSE;3.1.10 THE PROVISION OF RECREATIONAL FACILITIES AND ACTIVITIES IN THE INTERESTS OF SOCIAL WELFARE WITH THE OBJECT OF IMPROVING THE CONDITIONS OF LIFE FOR THOSE PERSONS IN NEED OF SUCH FACILITIES BY REASON OF THEIR YOUTH AGE INFIRMITY OR DISABLEMENT POVERTY OR SOCIAL AND ECONOMIC CIRCUMSTANCES BY PROMOTING THEIR SPIRITUAL MENTAL PHYSICAL AND SOCIAL WELL- BEING;3.1.11 TO PROMOTE ENCOURAGE OR UNDERTAKE ORGANISED RESEARCH SURVEYS INVESTIGATIONS AND PUBLISH THE USEFUL RESULTS THEREOF; AND3.1.12 THE ADVANCEMENT OF SUCH OTHER CHARITABLE OBJECTS FOR THE PUBLIC BENEFIT AS THE BOARD OF TRUSTEES MAY FROM TIME TO TIME THINK FIT.
