THE PROVISION OF A RETREAT HOUSE, INCLUDING FACILITIES FOR PRAYER, MEDITATION AND SPIRITUAL HEALING;C. THE FOSTERING OF RESPONSIBILITY TOWARDS AND APPRECIATION OF THE ENVIRONMENT;D. THE BUILDING OF A CHRISTIAN COMMUNITY TO FURTHER OBJECTS (A), (B) AND (C) ABOVE;
