





- We have organised live streaming African Music workshops with young people from African refugees' background. This project gave young people from African community opportunity to learn how to play different type of music instruments.
- We also organised different live streaming music performances with our London based African artists in order to entertain our local community.

8) The charity's policy on Reserve

The organisation's policy on reserve is to build reserves up to a level which ensures the charity's core activities could continue during the period of unforeseen difficulty. For the current year the charity has no free reserve.


