2.1 Objects: (Continued)

We have subsidised holidays for people in need of a break who would not otherwise be able to afford it. The Church holiday in August 2021 was again a great blessing as it was a time for people from the Church to see each other after a time of 'lockdown' and to encourage each other in the Christian faith.

A local school donated children's gifts in early December 2021 which we collected and then passed on to the Wycombe Food Hub for safe distribution.

A local care company required a space to safely train care-givers providing care in people's homes. We offered them the Church building at no charge to carry out this training. The company has used the building on a monthly basis and has made a donation to the charity

We continued to maintain the hanging baskets and tubs of flowers outside the Church which provided a splash of colour during the summer which brought a great deal of pleasure to people of all ages in the neighbourhood.

Our web site details are shown at the end of the Report.

2.2 Risk statement

The Trustees have considered the risks to children and have ensured that they are always under supervision.

They have continued to minimise the risk of fire by adhering to relevant legislation.

Risks relating to Covid 19 have been managed in accordance with government regulation.

There have been no significant risk issues during the year.

2.3 Charity Accounts

The accounts have been prepared and are being submitted alongside this report.

2.4 Other activity

The charity website which can be located at www.churchofshalom.co.uk provides additional information about the activity of the Church.

3.0 The coming year 2022-23

The activities of the charity in terms of advancing the Christian faith will also continue through our weekly meetings.

It is our intention to recommence the weekly ladies' meeting restarted in May 2022. This is a very important element of our meeting together each week.

It is anticipated that the link with the Wycombe Food Hub will continue and this will enable distribution of food to those in need.

NOTES TO THE ACCOUNTS (continued)

3 Expenditure and Liabilities

3.1 Expenditure and Liability Recognition

All expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all costs related to the category. Liabilities are recognised where it is more likely than not that there is a legal or constructive obligation committing the charity to pay out resources and the amount of the obligation can be measured with reasonable certainty.

Irrecoverable VAT is charged as an expense against the activity for which expenditure arose.

3.2 Creditors

The charity has creditors which are measured at settlement amounts less any trade discounts.

3.3 Basic financial instruments (bank and cash)

The charity accounts for basic financial instruments on initial recognition as per paragraph 10.7 FRS 102 SORP. Subsequent measurement is as per paragraphs 11.17 to 11.19, FRS 102 SORP.

4 Funds

Unrestricted funds are available for use at the discretion of the trustees in furtherance of the general objectives of the charity and which have not been designated for other purposes.

5 Related party transactions

The total amount of pastor fees received by key management personnel in the year was £23,100 (2021: £23,850).

None of the trustees have been paid any remuneration or received any other benefit during the year (2021: £nil).

The aggregate value of unconditional donations made by trustees in the year ended 30 April 2022 was £6,890 (2021: £7,969)
