#### **Structure, governance and management**

We are the main body of this UK-based charity. In Sri Lanka, we have two separate Trusts, both registered locally with the Sri Lankan government. The first Trust is known as 'Thiruketheeswaram Sivan Arul Illam Trust'. The 200 orphans and other destitute children are cared for by this trust locally. We have 4 Directors who manage this trust and serve as signatories to issue cheques for the day-to-day running of the organisation. They hold fortnightly or monthly meetings to discuss children and staff issues and improve our services. We have 21 staff, including carers, cooks, security guards and drivers, serving in the organisation. The child probation or protection local governmental body holds regular monthly meetings with our directors and staff to ensure the safe, proper care of children. We have appointed independent auditors/accountants to provide an annual audit report for this institution, and the reports are all in order and available on request. The directors are in direct contact with the trustees in the UK to inform them of what is happening and to seek their opinions on decision-making when required.

We have now opened two separate hostels for boys and girls on the same premises. Each hostel accommodates 25 destitute children, for a total of 50. The purpose of the hostel is to provide equal opportunities to poor children eager to study in other parts of the country (North/East & Upcountry). We now have a total of 200 children across our entire institution. This was only possible because of our generous donors who continue to support.

We are proud to announce that our children's home (Girls & Boys homes) was chosen as the best home in Mannar and received awards ceremonially by government officials in October 2023. This was based on exam results, children's behaviour, hygiene, sports and other skills, as well as recognition of the overall administration and running of the home and hostel.

The second Trust, known as 'Thiruketheeswaram Sivan Arul Vocational Training & Production Centre Trust', is there to help the most vulnerable families, especially war-affected widows, disabled people, amputees, and paraplegics, by providing livelihood support. We run a food processing factory in Kilinochi to provide a livelihood for widows and people with disabilities. About 100 vulnerable people are employed in the factory, mostly widows & young women affected by the war. We also run a bakery/café in Mullaithivu to help the local community and provide livelihoods for disabled & destitute families. About 30 staff, mostly young, vulnerable girls, work at this bakery. This is taken care of by two directors, both of whom are fully committed to making it a viable, sustainable business venture to provide livelihood support for many families. The directors are in constant touch with the trustees by email and telephone to give feedback and updates on progress. We receive monthly reports from the accountant at the factory. Also, an independent auditor/accountant is nominated to audit the factory's and bakery's productivity, sales, and income. We also have qualified registered public health inspectors visiting time to time to assess the quality & hygiene of the products made in both locations. We also have a 5-member team of field officers who monitor our children's education programmes in the community and assess the progress of the university student sponsor project and the hostel students' education projects. This is done successfully through progress reports from school headmasters and hostel wardens, which provide us with account breakdowns of expenditures.

#### Achievements and performance

##### Achievements and performance

Sivan Arul-Humanity, also known as 'Sivan Arul Illam' in Sri Lanka, has continued to work very hard over the past year on projects that assist the needy in the Vanni area and the East, namely Muthur, Batticaloa & Akkaraipattu. We continue to rehabilitate families who are severely affected by the war. It is heart warming to see that many of these families can manage their lives independently, with income from small-scale businesses established for them through our financial assistance.

Our children's home in Thiruketheeswaram, Mannar, now has around 200 children, aged 4 to 18. We have employed 21 staff, including carers, cooks, administrative officers, watchers, etc. The children attend the local Gowri Ambal School. We provide extra tuition for the core subjects. They enjoy extracurricular activities, including sports, music, dance, yoga, and meditation. The children are taken on regular educational & leisure trips outside the home. They are given made-to-measure new clothes 3 to 4 times a year. 2 children have entered university this year, and two have completed their university degrees. 8 children who have completed A/L are awaiting admission for various technical college government-approved courses. 18 children sat GCSE (O/L) and 15 qualified to do A/L. 8 children sat A/L and their pass rate is 100%. 12 have sought employment in our own social business enterprises (Factory, Bakery, Pure vegetarian Restaurant, and 4 integrated farms).

There were cries from many war affected families for assistance. We have so far rehabilitated over 4000 families by providing means to earn income and continue to provide monthly financial help to about 50 families with widows or paraplegics or amputees, mainly to educate their children. It is very gratifying to see how small regular contributions from us make a difference to the families and education of their children. There are many single mothers caring for their families particularly in Kilinochi & Mullaithivu district. Since they do not have skills to be engaged in a trade they continue to struggle to have 3 meals a day. So, many of their children are undernourished.

A women headed food processing factory has been built in Uruthirapuram, Kilinochi (known as Sivan Arul Vocational Training & Production Centre), to offer sustainable employment opportunities for needy females who are widows, disabled & unmarried. The ladies are now processing large quantities of rice flour, chilli powder, turmeric powder etc., and the main wholesale buyers are the traders in Kilinochi. We are also now exporting these spices to Australia, UK/Europe. We are now employing over 130 vulnerable people. There is also a women hostel attached to this factory, mainly accommodating disabled young women with disabled toilet facilities. They too are employed in the factory. There are around 20 young disabled living here.

We have opened a bakery in Puthukudiyiruppu to help the war affected disabled & vulnerable. This is providing them a sustainable livelihood. They are making bread, cakes, sweets, savoury short eats, buns etc selling them in a mobile van, taking large orders for weddings, parties etc. We are also exporting savouries and sweets abroad made in this bakery. We are employing 30, mostly, vulnerable young women

We have established a vocational Training, IT & Tuition Centre in Akkaraipattu, Amparai next to a girls orphan This is registered locally in the name of 'Sivan Arul Foundation'. This is to help the vulnerable young girls in the local community to seek employment by training them in IT. 110, youth have completed government approved NVQ3 (Computer Application Assistant & NVQ4 -Graphic Design courses and obtained certificates from TVEC ( Government body conducted exams) . They have all.

now seek employment or studying in university. We have also provided other government approved courses in Beauty therapy, sewing, handicraft, food processing etc.

There are 5 free education centres in East and North. We have recently built a large community centre in Thirukkivil, Amparai to help the local community. Over 70 children attend this centre for free education in many subjects (Maths, science, English, Tamil, and History). In Neenakerny, Muthur centre 80 children are registered, and all 5 subjects mentioned above are taught. This is a very deprived, backward village. One student from our centre passed GCSE (O/L) and studying A/L. 5 children have passed scholarship cut off from this centre. In Kanchirankuda, Batticaloa centre 24 children sat O/L 19 are qualified to do A/L. In Olumadu Nedunkerny Vavuniya centre 175 children are registered. 32 sat O/L and 22 are qualified to do A/L. 3 students have entered university. 35 new students have started their GCSE (O/L) course. In Katkulam, Vavuniya Centre 170 students are registered. 13 students sat GCSE (O/L) 4 are qualified to do A/L. 11 new students have enrolled to start GCSE(O/L)

Education for upcountry children- It's well known fact that many of the kids studying in the upcountry areas struggle to find optimal education mainly due to lack of transportation facilities. Many of these students walk long distances, with some instances nearing 3-4 hours to go to the school. They also do not get the opportunity to have quality education. To empower these children to study and

Receive standard education. Sivan Arul had come up with two initiatives

1. Offer admission to Sivan Arul hostel in Thiruketheeswaram ( 60 upcountry children study in our hostel)
2. Started a hostel /teaching facility in Jaffna for children who obtained high grades in Year 10
3. 10 children from a very poor background in upcountry have been given opportunity to study in Stanley College, Jaffna, living in their hostel. ( sponsored by TAB –Tamil Association of Brent)

In Srirudram, we have built four luxury rooms with attached toilets, which would attract temple worshipers from abroad & other tourists. We believe these business ventures will generate income for the vulnerable community members to achieve a stable livelihood.

' We have secured 7 acres of government land on long-term lease ( over 33 33-year period, renewable ) under the name of the children's home, which is located relatively close to the children's home. We have planted 400 coconut trees on this land to provide children with a sustainable income in about 3 years. In the meantime, we are growing all the vegetables, fruits, etc., that would otherwise be bought in the market, for daily consumption by the children. The older children? Participate in the development? & cultivation of this land, which gives them a form of recreation, therapy & hobby to keep themselves active & occupied during their holidays & free time. We are building around 10 houses on this land for our older children who have no parents or family. We believe that they will become self-reliant over time, start their own families, and continue to help other needy children and families. We have also secured an additional 10 acres of government land in Palampitty, Madu district. Another farm has been donated to us in Mavittapuram. This also cultivates vegetables, rears cows to sell milk, and raises chickens to sell eggs. It offers employment for the local community. The income generated supports our children's education. We have invested an enormous sum, mainly in the east of Sri Lanka, on revolving fund interest-free loan projects.

We run very successful Aranery schools teaching moral values, reading, writing, encouraging home cultivation of vegetables, for over 600 poor children in upcountry estates ( in 16 estates) every Sunday, offering free meals for all these children and some elderly in the villages. A similar project is also conducted in the East ( Thirukkovil) for over 300 poor children.

We have an elderly home in Yattiantota, Kegalle. 10 vulnerable ladies who worked as tea pluckers in the upcountry are being cared for in this home. We also conduct a government-approved ICTT NVQ3 course and Graphic Design for 20 poor upcountry children in this centre (Upstairs of the elders' home in Yattiantota), which is dedicated to free education for all poor children in the upcountry. In addition to IT we have SMART Board classes are conducted in Maths, Science, English, Tamil, Sinhala, Geography and History. About 45 children from poor estates attend these classes.

We have recently launched our own Radio station called "Aayul" in Yatiantota Annalakshmi Anbu Illam to give employment opportunities for Upcountry estate youths and to market our own food products.

There is a shop run in Yatiantota to generate income for the elders home and education of estate children We hope to start a government registered nursery for the estate children in Yatiantota

After-school activities will also be conducted at 3 other centres in Muthur (Seethanaveli, Paattalipuram & Santhosapuram), mainly to motivate children. whom are not attending schools due to poverty, lack of interest from parents. We have introduced a unique education program for our 7tuition centres across the country, in Mannar, in our children's home ( Sivan Arul Illam), Olumadu-Nedunkerny-Late Thuraisingham memorial Sivan Arul Kalvinilayam, Sivan Arul Kalvinilayam, Upcountry (Yattiantota Sivan Arul-Annaluxmy Anbu Illam), Kanchirankuda Karithas- Sivan Arul Kalvinilayam in Batticaloa, Akkaraipattu- IT centre, Neenakerny, Muthur Sivan Arul-Ilanthalir Kalvinilayam and Katkulam-Vavuniya Late Vijayakumar memorial Sivan Arul Kalvinilayam.

#### **New Project-**

##### **Palms Together – New Project Under Sivan Arul Hope Ltd**

Palms Together is a new project established in February 2025 under Sivan Arul Hope Ltd. The project's objective is to support women from single-income households in the North and East of Sri Lanka to earn a sustainable livelihood through the production of palmyra handicrafts and handloom products.

The project operates on a leadership and capacity-building model. Women who are already established in their craft are identified and supported as local leaders. These leaders:

- Train other women in Palmyra and handloom skills
- Assist them in marketing and selling their products
- Oversee and support the quality and consistency of the work

This model is particularly important in the North and East of Sri Lanka, where cultural and language barriers mean many women are unwilling or unable to travel to other parts of the country. By working through locally based leaders, Palms Together can reach remote and isolated communities where women would otherwise have very limited or no support in accessing markets.

Although the project is at an early stage, it has already achieved significant initial success, including.

We started this program 4 years ago & our studies have proved them to be very useful, making a positive impact on the performance, growth & school attendance of these children We have introduced a unique education program for our seven tuition centres across the country, in Mannar, in our children home ( Sivan Arul Illam), Olumadu-Nedunkerny-Late Thuraisingham memorial Sivan Arul Kalvinilayam, Sivan Arul Kalvinilayam, Upcountry (Yattiantota Sivan Arul-Annaluxmy Anbu Illam), Kanchirankuda Karithas- Sivan Arul Kalvinilayam in Batticaloa, Akkaraipattu- IT centre, Neenakerny, Muthur Sivan Arul-Ilanthalir Kalvinilayam and Katkulam-Vavuniya Late Vijayakumar memorial Sivan Arul Kalvinilayam.

We would also continue to promote our 3 very successful IT centres in Akkaraipattu, Nedunkerny, Jaffna & Mannar.







#### **1. General information**

The charity is a public benefit entity and a private company limited by guarantee, registered in England and Wales and a registered charity in England and Wales. The registered office address is 2 Monkham Lane, Woodford Green, Essex, IG8 0NL.

#### **2. Statement of compliance**

These financial statements have been prepared in compliance with FRS 102, 'The Financial Reporting Standard applicable in the UK and the Republic of Ireland', the Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (Charities SORP (FRS 102)) and the Companies Act 2006.

#### **3. Accounting policies**

##### **Basis of preparation**

The financial statements have been prepared on the historical cost basis, as modified by the revaluation of certain financial assets and liabilities and investment properties measured at fair value through income or expenditure.

The financial statements are prepared in sterling, which is the functional currency of the entity.

##### **Going concern**

The charity is treated as a going concern, as there is a foundation of regular donors who will continue to donate money. There is also £51,272 reserved for contingencies.

##### **Judgements and key sources of estimation uncertainty**

The preparation of the financial statements requires management to make judgements, estimates and assumptions that affect the amounts reported. These estimates and judgements are continually reviewed and are based on experience and other factors, including expectations of future events that are believed to be reasonable under the circumstances.

The judgements (apart from those involving estimations) that management has made in the process of applying the entity's accounting policies and that have the most significant effect on the amounts recognised in the financial statements are as follows:

Regular donors will continue to make contributions in the future. The trustees will continue to find new individuals/organisations that will donate money.

##### **Foreign currencies**

Foreign currency transactions are initially recorded in the functional currency by applying the spot exchange rate as at the date of the transaction. Monetary assets and liabilities denominated in foreign currencies are translated at the exchange rate ruling at the reporting date, with any resulting gains or losses recognised in the statement of financial activities.

**Fund accounting**

Unrestricted funds are available for the trustees' discretion to further any of the charity's purposes.

Designated funds are unrestricted funds earmarked by the trustees for a particular future project or commitment.

Restricted funds are subject to expenditure restrictions imposed by the donor or set out in the terms of an appeal, and fall into one of two sub-classes: restricted income funds or endowment funds.

**Incoming resources**

All incoming resources are included in the statement of financial activities when entitlement has passed to the charity; the economic benefits associated with the transaction will probably flow to the charity, and the amount can be reliably measured. The following specific policies are applied to particular categories of income:

- Income from donations or grants is recognised when there is evidence of entitlement to the gift, receipt is probable, and its amount can be measured reliably.
- Legacy income is recognised when receipt is probable and entitlement is established.
- income from donated goods is measured at the fair value of the goods unless this is impractical to measure reliably, in which case the value is derived from the cost to the donor or the estimated resale value. Donated facilities and services are recognised in the accounts when received if the value can be reliably measured. No amounts are included for the contribution of general volunteers.
- income from contracts for the supply of services is recognised with the delivery of the contracted service. This is classified as unrestricted funds unless there is a contractual requirement for it to be spent on a particular purpose and returned if unspent, in which case it may be regarded as restricted.

##### Resources expended

Expenditure is recognised on an accruals basis as a liability is incurred. Expenditure includes any VAT which cannot be fully recovered, and is classified under headings of the statement of financial activities to which it relates:

- expenditure on raising funds includes the costs of all fundraising activities, events, non-charitable trading activities, and the sale of donated goods.
- expenditure on charitable activities includes all costs incurred by a charity in undertaking activities that further its charitable aims for the benefit of its beneficiaries, including those support costs and costs relating to the governance of the charity apportioned to charitable activities.
- other expenditure includes all expenditure that is neither related to raising funds for the charity nor part of its expenditure on charitable activities.

All costs are allocated to expenditure categories reflecting the use of the resource. Direct costs attributable to a single activity are assigned directly to that activity. Shared costs are apportioned between the activities they contribute to on a reasonable, justifiable and consistent basis.

##### Financial instruments

A financial asset or a financial liability is recognised only when the charity becomes a party to the contractual provisions of the instrument.

Basic financial instruments are initially recognised at the amount receivable or payable including any related transaction costs.

Current assets and current liabilities are subsequently measured at the cash or other consideration expected to be paid or received and not discounted.

Debt instruments are subsequently measured at amortised cost.

Where investments in shares are publicly traded or their fair value can otherwise be measured reliably, the investment is subsequently measured at fair value with changes in fair value recognised in income and expenditure. All other such investments are subsequently measured at cost less impairment.

Other financial instruments, including derivatives, are initially recognised at fair value, unless payment for an asset is deferred beyond normal business terms or financed at a rate of interest that is not a market rate, in which case the asset is measured at the present value of the future payments discounted at a market rate of interest for a similar debt instrument.

Other financial instruments are subsequently measured at fair value, with any changes recognised in the statement of financial activities, with the exception of hedging instruments in a designated hedging relationship.

Financial assets that are measured at cost or amortised cost are reviewed for objective evidence of impairment at the end of each reporting date. If there is objective evidence of impairment, an impairment loss is recognised under the appropriate heading in the statement of financial activities in which the initial gain was recognised.

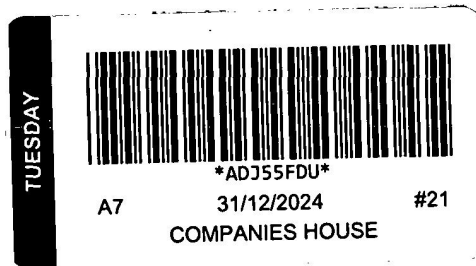

#### **Structure, governance and management**

We are the main body of this charity which is based in UK. In Sri Lanka we have two separate Trusts formed and they are registered locally with Sri Lankan government. The first Trust is known as Thiruketheeswaram Sivan Arul Illam Trust; The 200 orphans and other destitute children are cared by this trust locally. We have 4 Directors who manage this trust, being the signatories to issue cheques for the day to day running of the organisation. They hold fortnightly or monthly meetings to discuss, children and staff issues and improve our services. We have 21 staff including carers, cooks, security guards and drivers serving in the organisation. The child probation or protection local governmental body have regular monthly meetings with our directors and staff to maintain good, safe care of children. We have appointed independent auditors/ accountants to provide annual audit report for this institution and the reports are all in order and are available on request. The directors are directly in contact with the trustees in UK to inform what is going on and to ask for opinions of trustees in decision making when required.

We have now started two separate hostels for both boys and girls in the same premises. Each hostel accommodates 25 destitute children, a total of 50 children in the hostel. The purpose of the hostel is to give equal opportunities to poor children who are eager to study in other parts of the country(North/East & Upcountry). Now we have a total of 200 children in our entire institution. This was only possible because of our generous donors who are continuing to support. We are proud to announce that our children home,(Girls, Boys homes) chosen as the best home in Mannar and received awards ceremonially by government officials in October 2023. This was based on exam results, behaviour of children, hygiene, sports and other skills. Also recognition of overall administration and running of home and hostel.

The second Trust known as Thiruketheeswaram Sivan Arul Vocational Training ; Production Centre Trustis there to help the most vulnerable needy families, especially the war affected widows, disabled, amputees and paraplegics to provide livelihood support. We run food processing factory in kilinochi to provide livelihood for the widows, and disabled. About 100 vulnerable people are employed in the factory, mostly widows & young women affected by the war. We also run a bakery/ cafeteria in in Mullaithivu to help local community and provide livelihood for disabled; destitute families. About 30 staff, mostly young vulnerable girls are employed in this bakery. This is taken care by two directors both of whom are fully committed to make it a viable, sustainable business venture to provide livelihood support for many families. The directors are in constant touch with the trustees by e-mail and telephone to give feed back, updates of progress. We have monthly reports sent by the accountant in in the factory. Also an independent auditor/ accountant is nominated to audit the productivity, sales and income generated in the factory and bakery.. We also have qualified registered public health inspectors visiting time to time to assess the quality ; hygiene of the products made in both locations. We also have a 5-member team of field officers employed to monitor our children education programmes in the community, assess progress of university student sponsor project and hostel students education projects. This is successfully done with progress reports, from school headmasters, hostel wardens, giving us account break downs of expenditures.

Provide sustainable livelihood for war affected vulnerable destitute families, especially the widows, amputees, disabled and paraplegics, to create job opportunities for local communities in the north/ east who are living below poverty level and help their children with improved nutrition, better education facilities etc.

To rehabilitate orphaned children and families in order to meet the spiritual, physical, nutritional, social, educational, economic skills and training needs.

To provide support for homeless and poor individuals and families including emergency shelter, housing, food-assistance in-home care and family support.

To foster human development of poor, disadvantaged and vulnerable women and to ensure socio-economic justice and self reliance for alleviation of poverty.

#### Strategic report

The following sections for achievements and performance and financial review form the strategic report of the charity. Achievements and performance

Sivan Arul-Humanity , also known as 'Sivan Arul Illam' in Sri Lanka has continued to work very hard in the past year with projects that would assist the needy in Vanni area and East, namely Muthur, Batticaloa & Akkaraipattu. We continue to rehabilitate families who are severely affected by the war. It is heart-warming to see many of these families are able to manage their lives on their own with income derived from small scale business established for them through our financial assistance.

Our children home in Thiruketheeswaram, Mannar now have around 200 children, age range from 4 to 18 yrs). We have employed 21 staff, including carers, cooks, administrative officers, watchers, etc. The children attend the local Gowri Ambal School. We provide extra tuition for the core subjects. They enjoy the extra-curricular activities, including sports, music, dance, yoga, meditation etc. The children are taken on regular educational & leisure trips outside the home. They are given made to measure new clothes 3 to 4 times a year. 2 children have entered university this year and 2 children have completed their university degree this year. 8 children who have completed A/L are awaiting admission for various technical college government approved courses. 18 children sat GCSE (O/L) and 15 qualified to do A/L . 8 children sat A/L and their pass rate is 100%. 12 have seek employment in our own social

business enterprises (Factory, Bakery, Pure-vegetarian Restaurant, and 4 integrated farms). . . There were cries from many war affected families for assistance. We have so far rehabilitated over 4000 families by providing means to earn income and continue to provide monthly financial help to about 50 families with widows or paraplegics or amputees, mainly to educate their children. It is very gratifying to see how small regular contributions from us make a difference to the families and education of their children. There are many single mothers caring for their families particularly in Kilinochi & Mullaithivu district. ##### Achievements and performance

Sivan Arul-Humanity, also known as 'Sivan Arul Illam' in Sri Lanka has continued to work very hard in the past year with projects that would assist the needy in Vanni area and East, namely Muthur, Batticaloa & Akkaraipattu. We continue to rehabilitate families who are severely affected by the war. It is heart-warming to see many of these families are able to manage their lives on their own with income derived from small scale business established for them through our financial assistance.

Our children home in Thiruketheeswaram, Mannar now have around 200 children, age range from 4 to 18 yrs). We have employed 21 staff, including carers, cooks, administrative officers, watchers, etc. The children attend the local Gowri Ambal School. We provide extra tuition for the core subjects. They enjoy the extra-curricular activities, including sports, music, dance, yoga, meditation etc. The children are taken on regular educational & leisure trips outside the home. They are given made to measure new clothes 3 to 4 times a year. 2 children have entered university this year and 2 children have completed their university degree this year. 8 children who have completed A/L are awaiting admission for various technical college government approved courses. 18 children sat GCSE (O/L) and 15 qualified to do A/L. 8 children sat A/L and their pass rate is 100%. 12 have seek employment in our own social

business enterprises (Factory, Bakery, Pure vegetarian Restaurant, and 4 integrated farms). . . There were cries from many war affected families for assistance. We have so far rehabilitated over 4000 families by providing means to earn income and continue to provide monthly financial help to about 50 families with widows or paraplegics or amputees, mainly to educate their children. It is very gratifying to see how small regular contributions from us make a difference to the families and education of their children. There are many single mothers caring for their families particularly in Kilinochi & Mullaithivu district. Since they do not have skills to be engaged in a trade they continue to struggle to have 3 meals a day. So, many of their children are undernourished.

( sponsored by TAB -Tamil Association of Brent)

We are also very grateful to Aadhi Parasakthi Valipattu Mandram, Harrow, UK for providing financial assistances to help our children in Thiruketheeswaram Sivan Arul Illam, providing special meals for them, giving money to deposit in their savings account. They also assist with our other projects, in Kilinochi factory, Puthukudiyiruppu bakery etc The Aadhi Parasakthi Mandram also sponsors regular special meals to the poor, undernourished in the community in Vanni and special meals regularly to the children home. They also sponsor monthly, supporting many university students, educating many destitute orphan children and helping many families with setting up suitable livelihoods. Their support to our organisation is invaluable for the past 12 years & we cannot sustain without their financial assistances. Aadhi Parasakthi Valipaattu Mandram, Harrow, UK also carries out a large education development project helping over 50 students in Vanni, including university students to achieve good/ higher education in order to seek, & secure employment in their lives to support their families. They are also donating a large sum of money in re-building lives, mostly in the East of Sri Lanka. Their main focus is on building numerous wells for drinking water, cultivation etc. Also building numerous houses for very poor families living in huts. They also help several families to set up livelihood projects which are sustainable. They also build numerous toilets for poor community. Ratnam Foundation Trust , UK are supporting many projects, including Akkaraipattu IT centre . Over 80 youth have qualified in NVQ3 & NVQ4 and seek employment or continuing studies in university. .

#### **New Projects**

We have opened a pure vegetarian restaurant, called 'Sri Rudram" in Thiruketheeswaram, Mannar, employing our own children in the children home. Also offering employment for local community. Next to this we have built a mini factory to produce seasonal authentic food items, such as palmyrah jam, cordial, pinattu, pulukodiyal, odiyil flour, Kassava flour, lime pickle, moor milakai, vadakam etc. We also sell all our factory & bakery products in the restaurant, with a small outlet to showcase all our products (rice flour, Jaffna curry powder, pakkora, kassava chips, ginger biscuits & many more!!!!) There have built 4 luxury rooms with attached toilets built which would attract temple worshipers from abroad & abroad & another tourist. These business ventures we believe will generate income for the vulnerable group of the community to have stable livelihood. . ' We have secured 9 acres government land on long term lease ( over 30 yr period, renewable ) under the name of children home, which is located fairly close the children home. We have planted 400 coconut plants in this land in order to give children sustainable income in about 3 yrs. Mean time we are growing all the vegetables which otherwise would be bought in the market, fruits etc for daily consumption for the children. The older children participate in the development & cultivation of this land which gives them a form of recreation, therapy & hobby to keep them self-active & occupied during their holidays & free time. We are building around 10 houses in this land for our older children with no parents or family. We believe that they will become self-reliant over a period of time, starting their own families and will continue to help other

needy children and families. We have also secured further 10 acres of government land in Palampitty, Madu district. There is another farm donated to us in Mavittapuram. This also cultivates vegetables, rearing cows to sell milk and chicken poultry to sell eggs. It offers employment for local community. The income generated is supporting our children in education. We have invested a large sum mainly in the east of Sri Lanka, on revolving fund interest free loan projects e.g., Goat rearing for 20 families in Manikkamadu, Chicken poultry for 5 families in Kachikudiyaru, cultivation of ground nuts, ulunthu & cowpea for 60 families

We run very successful Aranery schools (teaching moral values, reading, writing, encouraging home cultivation of vegetables, for over 1200 poor children in upcountry estates (in 23 estates) every Sunday, offering free meals for all these children and some elderly in the villages. A similar project is also conducted in the East (Thirukkovil) for over 300 poor children. We have an elders home in Yattiantota, Kegalle, 10 vulnerable ladies who worked as tea pluckers in upcountry are being cared in this home. We also conduct, government approved ICTT NVQ3 course for 20 poor upcountry children in this centre (Upstairs of elders home in Yattiantota is dedicated to free education for all poor children in upcountry) In addition to IT we have SMART Board classes are conducted in Maths, Science, English, Tamil, Sinhala, Geography and History. About 45-50 children from poor estates attend these classes.

Families in Kanchirankuda, Kanchikudiyaru & Kanagar Kiramam (farmers), sewing machines for 10 vulnerable ladies in Vivekanadapuram. We have given 6 motor water pumps and long feeding pipes to promote cultivation in Aandankulam & Katumurivu, in Batticaloa. The farmers will repay the cost of the water pumps. This will be an integrated farm, with rearing goats, cows, chicken poultry and vegetables. This provides employment to the vulnerable, poor, local community. The income generated will also be shared with our children home, for their day-to-day expenses. We have completed goat rearing program in Vaharai- Batticaloa district & Akkaraipattu for 20 women headed families by giving them each 4 to 5 goats as a lucrative livelihood. We are cultivating 3 acres land in Neenakerny in Muthur district in order to help the poor community. We are about to start a multipurpose community centre in our land here to conduct after school educational, sports activities, Aranery & recreation for elderly who are begging on streets for living. After school activities are also going to be conducted in 3 other centres in Muthur, (Seethanaveli, Paattalipuram & Santhosapuram), mainly to motivate children many of whom are not attending schools due to poverty, lack of interest from parents. We are also constructing many simple, drinking, bathing water wells in Batticaloa & Amparai district where there are many poor villages without drinking, bathing water & toilet facilities. We are also supplying 'Saththuma' nutritional powder free, for about 1700 pre-school & primary school children in Vanni & East where there is extreme poverty & malnutrition. We started this program 4 years ago & our studies have proved them to be very useful, making a positive impact on the performance, growth & school attendance of these children. We have introduced a unique education program for our 7 tuition centres across the country, in Mannar, in our children home (Sivan Arul Illam), Olumadu-Nedunkerny-Late Thuraisingham memorial Sivan Arul Kalvinilayam, Sivan Arul Kalvinilayam, Upcountry (Yattiantota Sivan Arul-Annaluxmy Anbu Illam), Kanchirankuda Karithas- Sivan Arul Kalvinilayam in Batticaloa, Akkaraipattu- IT centre, Neenakerny, Muthur Sivan Arul-Ilanthalir Kalvinilayam and Katkulam-Vavuniya Late Vijayakumar memorial Sivan Arul Kalvinilayam.


Plans for future periods

**1. General information**

The financial statements have been prepared on the historical cost basis, as modified by the revaluation of certain financial assets and liabilities and investment properties measured at fair value through income or expenditure.

The financial statements are prepared in sterling, which is the functional currency of the entity.

**Going concern**

The charity is treated as a going concern as there is a foundation of regular donators who will continue to donate money.

**Judgements and key sources of estimation uncertainty**

The preparation of the financial statements requires management to make judgements, estimates and assumptions that affect the amounts reported. These estimates and judgements are continually reviewed and are based on experience and other factors, including expectations of future events that are believed to be reasonable under the circumstances.

The judgements (apart from those involving estimations) that management has made in the process of applying the entity's accounting policies and that have the most significant effect on the amounts recognised in the financial statements are as follows:

Regular donators will continue to make contributions in the future. The trustees will continue to find new individuals/organisations that will donate money.

**Foreign currencies**

Foreign currency transactions are initially recorded in the functional currency, by applying the spot exchange rate as at the date of the transaction. Monetary assets and liabilities denominated in foreign currencies are translated at the exchange rate ruling at the reporting date, with any gains or losses being taken to the statement of financial activities.

##### Fund accounting

Unrestricted funds are available for use at the discretion of the trustees to further any of the charity's purposes.

Designated funds are unrestricted funds earmarked by the trustees for particular future project or commitment.

Restricted funds are subjected to restrictions on their expenditure declared by the donor or through the terms of an appeal, and fall into one of two sub-classes: restricted income funds or endowment funds.

##### Incoming resources

All incoming resources are included in the statement of financial activities when entitlement has passed to the charity; it is probable that the economic benefits associated with the transaction will flow to the charity and the amount can be reliably measured. The following specific policies are applied to particular categories of income:

- income from donations or grants is recognised when there is evidence of entitlement to the gift, receipt is probable and its amount can be measured reliably.
- legacy income is recognised when receipt is probable and entitlement is established.
- income from donated goods is measured at the fair value of the goods unless this is impractical to measure reliably, in which case the value is derived from the cost to the donor or the estimated resale value. Donated facilities and services are recognised in the accounts when received if the value can be reliably measured. No amounts are included for the contribution of general volunteers.
- income from contracts for the supply of services is recognised with the delivery of the contracted service. This is classified as unrestricted funds unless there is a contractual requirement for it to be spent on a particular purpose and returned if unspent, in which case it may be regarded as restricted.

**Resources expended**

Expenditure is recognised on an accruals basis as a liability is incurred. Expenditure includes any VAT which cannot be fully recovered, and is classified under headings of the statement of financial activities to which it relates:

- expenditure on raising funds includes the costs of all fundraising activities, events, non-charitable trading activities, and the sale of donated goods.
- expenditure on charitable activities includes all costs incurred by a charity in undertaking activities that further its charitable aims for the benefit of its beneficiaries, including those support costs and costs relating to the governance of the charity apportioned to charitable activities.
- other expenditure includes all expenditure that is neither related to raising funds for the charity nor part of its expenditure on charitable activities.

All costs are allocated to expenditure categories reflecting the use of the resource. Direct costs attributable to a single activity are allocated directly to that activity. Shared costs are apportioned between the activities they contribute to on a reasonable, justifiable and consistent basis.

**Financial instruments**

A financial asset or a financial liability is recognised only when the charity becomes a party to the contractual provisions of the instrument.

Basic financial instruments are initially recognised at the amount receivable or payable including any related transaction costs.

Current assets and current liabilities are subsequently measured at the cash or other consideration expected to be paid or received and not discounted.

Debt instruments are subsequently measured at amortised cost.

Where investments in shares are publicly traded or their fair value can otherwise be measured reliably, the investment is subsequently measured at fair value with changes in fair value recognised in income and expenditure. All other such investments are subsequently measured at cost less impairment.

Other financial instruments, including derivatives, are initially recognised at fair value, unless payment for an asset is deferred beyond normal business terms or financed at a rate of interest that is not a market rate, in which case the asset is measured at the present value of the future payments discounted at a market rate of interest for a similar debt instrument.

Other financial instruments are subsequently measured at fair value, with any changes recognised in the statement of financial activities, with the exception of hedging instruments in a designated hedging relationship.

Financial assets that are measured at cost or amortised cost are reviewed for objective evidence of impairment at the end of each reporting date. If there is objective evidence of impairment, an impairment loss is recognised under the appropriate heading in the statement of financial activities in which the initial gain was recognised.

### **Structure, governance and management**

We are the main body of this charity which is based in UK. In Sri Lanka we have two separate Trusts formed and they are registered locally with Sri Lankan government. The first Trust is known as Thiruketheeswaram Sivan Arul Illam Trust; The 200 orphans and other destitute children are cared by this trust locally. We have 4 Directors who manage this trust, being the signatories to issue cheques for the day to day running of the organisation. They hold fortnightly or monthly meetings to discuss, children and staff issues and improve our services. We have 21 staff including carers, cooks, security guards and drivers serving in the organisation. The child probation or protection local governmental body have regular monthly meetings with our directors and staff to maintain good, safe care of children. We have appointed independent auditors/ accountants to provide annual audit report for this institution and the reports are all in order and are available on request. The directors are directly in contact with the trustees in UK to inform what is going on and to ask for opinions of trustees in decision making when required.

We have now started two separate hostels for both boys and girls in the same premises. Each hostel accommodates 25 destitute children, a total of 50 children in the hostel. The purpose of the hostel is to give equal opportunities to poor children who are eager to study in other parts of the country (North/East & Upcountry). Now we have a total of 200 children in our entire institution. This was only possible because of our generous donors who are continuing to support. We are proud to announce that our children home, (Girls & Boys homes) chosen as the best home in Mannar and received awards ceremonially by government officials in October 2023. This was based on exam results, behaviour of children, hygiene, sports and other skills. Also recognition of overall administration and running of home and hostel.

The second Trust known as Thiruketheeswaram Sivan Arul Vocational Training & Production Centre Trust; is there to help the most vulnerable needy families, especially the war affected widows, disabled, amputees and paraplegics to provide livelihood support. We run food processing factory in kilinochi to provide livelihood for the widows, and disabled. About 100 vulnerable people are employed in the factory, mostly widows & young women affected by the war. We also run a bakery/ cafeteria in Mullaithivu to help local community and provide livelihood for disabled & destitute families. About 30 staff, mostly young vulnerable girls are employed in this bakery. This is taken care by two directors both of whom are fully committed to make it a viable, sustainable business venture to provide livelihood support for many families. The directors are in constant touch with the trustees by e-mail and telephone to give feed back, updates of progress. We have monthly reports sent by the accountant in the factory. Also an independent auditor/ accountant is nominated to audit the productivity, sales and income generated in the factory and bakery. We also have qualified registered public health inspectors visiting time to time to assess the quality & hygiene of the products made in both locations. We also have a 5-member team of field officers employed to monitor our children education programmes in the community, assess progress of university student sponsor project and hostel students education projects. This is successfully done with progress reports, from school headmasters, hostel wardens, giving us account break downs of expenditures.

#### **Achievements and performance**

Sivan Arul-Humanity , also known as 'Sivan Arul Illam' in Sri Lanka has continued to work very hard in the past year with projects that would assist the needy in Vanni area and East, namely Muthur, Batticaloa & Akkaraipattu. We continue to rehabilitate families who are severely affected by the war. It is heart-warming to see many of these families are able to manage their lives on their own with income derived from small scale business established for them through our financial assistance. Our children home in Thiruketheeswaram, Mannar now have around 200 children, age range from 4 to 18 yrs). We have employed 21 staff, including carers, cooks, administrative officers, watchers, etc. The children attend the local Gowri Ambal School. We provide extra tuition for the core subjects. They enjoy the extra-curricular activities, including sports, music, dance, yoga, meditation etc. The children are taken on regular educational & leisure trips outside the home. They are given made to measure new clothes 3 to 4 times a year. 4 children have entered university this year & 10 children qualified to do A/L following recent O/L results. 7 children who were studying in university have graduated this year and their official convocations took place .We are very proud to announce that the recent national exam results for 10 th Grade (GCSE-O/L) were released and 10 of the 12 kids who sat the exams passed and 8 students sat A/L exam , all 8 passed.To date 18 children from our children home have entered universities and 12 have seek employment in our own social business enterprises ( Factory, Bakery, Pure vegetarian Restaurant, and 4 integrated farms). Nearly 600 children studying in our 3 free education centres located in the North & East have also done very well in the recent GCSE Exam. These are children from Olumadu -Nedunkerny, Vavuniya, Katkulam-Asikulam Sivan Arul Kalvinilayam, Vavuniya. & Sivan Arul Kalvinilayam, in Kanchirankuda, Batticaloa.29 students who attended our free education centre in Kanchirankuda sat GCSE-O/L.25 students passed and got best results in the district obtaining 8As 1B.

There were cries from many war affected families for assistance. We have so far rehabilitated over 4000 families by providing means to earn income and continue to provide monthly financial help to about 50 families with widows or paraplegics or amputees, mainly to educate their children. It is very gratifying to see how small regular contributions from us make a difference to the families and education of their children. There are many single mothers caring for their families particularly in Kilinochi & Mullaithivu district. Since they do not have skills to be engaged in a trade they continue to struggle to have 3 meals a day. So, many of their children are undernourished. A women headed food processing factory has been built in Uruthirapuram, Killnochi (known as Sivan Arul Vocational Training & Production Centre), to offer sustainable employment opportunities for needy females who are widows, disabled & unmarried. The ladies are now processing large quantities of rice flour, chilli powder, turmeric powder etc., and the main wholesale buyers are the traders in Kilinochi. We are also now exporting these spices to Australia, UK/Europe. We are now employing over 130 vulnerable people. There is also a women hostel attached to this factory, mainly accommodating disabled young women with disabled toilet facilities. They too are employed in the factory. There are around 20 young disabled living here.

We have opened a bakery in Puthukudiyiruppu to help the war affected disabled & vulnerable. This is providing them a sustainable livelihood. They are making bread, cakes, sweets, savoury short eats, buns etc selling them in a mobile van, taking large orders for weddings, parties etc. We are also exporting savouries and sweets abroad made in this bakery. We are employing 30 , mostly ,vulnerable young women We have established a vocational Training , IT & Tuition Centre in Akkaraipattu, Amparai next to a girls orphanage. This is registered locally in the name of 'Sivan Arul Foundation'.This is to help the older girls in children home & vulnerable young girls in the local community to seek employment by training them in IT. 80 youth have completed government approved NVQ3 ( Computer Application Assistant & NVQ4 -Graphic Design courses and obtained certificates from TVEC ( Government body conducted exams) . They have all now seek employment or studying in university. We have also provided other government approved courses in Beauty therapy, sewing, handicraft, food processing etc.

Education for upcountry children- It's well known fact that many of the kids studying in the upcountry areas struggle to find optimal education mainly due to lack of transportation facilities .Many of these students walk long

distances ,with some instances nearing 3-4 hours to go to the school. They also do not get the opportunity to have quality education. 2. Started a hostel /teaching facility in Jaffna for children who obtained high grades in Year 10







##### **Structure, governance and management**

We are the main body of this charity which is based in UK. In Sri Lanka we have two separate Trusts formed and they are registered locally with Sri Lankan government. The first Trust is known as 'Thiruketheeswaram Sivan Arul Illam Trust' The 110 orphans and other destitute children are cared by this trust locally. We have 4 Directors who manage this trust, being the signatories to issue cheques for the day to day running of the organisation. They hold fortnightly or monthly meetings to discuss, children and staff issues and improve our services. We have 21 staff including carers, cooks, security guards and drivers serving in the organisation. The child probation or protection local governmental body have regular monthly meetings with our directors and staff to maintain good, safe care of children. We have appointed independent auditors/ accountants to provide annual audit report for this institution and the reports are all in order and are available on request. The directors are directly in contact with the trustees in UK to inform what is going on and to ask for opinions of trustees in decision making when required.

We have now started two separate hostels for both boys and girls in the same premises. Each hostel accommodates 25 destitute children, a total of 50 children in the hostel. The purpose of the hostel is to give equal opportunities to poor children who are eager to study in other parts of the country (North/East & Upcountry). Now we have a total of 175 children in our entire institution. This was only possible because of our generous donors who are continuing to support.

The second Trust known as 'Thiruketheeswaram Sivan Arul Vocational Training & Production Centre Trust' is there to help the most vulnerable needy families, especially the war affected widows, disabled, amputees and paraplegics to provide livelihood support. We run food processing factory in kilinochi to provide livelihood for the war windows, some are disabled. About 100 vulnerable people are employed in the factory, mostly widows & young women affected by the war. We also run a bakery/ cafeteria in in Mullaithivu to help local community and provide livelihood for disabled & destitute families. About 30 staff, mostly young vulnerable girls are employed in the bakery. This is taken care by two directors both of whom are fully committed to make it a viable, sustainable business venture to provide livelihood support for many families. The directors are in constant touch with the trustees by e-mail and telephone to give feedback, updates of progress. We have monthly reports sent by the accountant in in the factory. Also an independent auditor/ accountant is nominated to audit the productivity, sales and income generated in the factory. We also have qualified registered public health inspectors visiting time to time to assess the quality & hygiene of the products made in both locations. We also have a 5-member team of field officers employed to monitor our children education, programme in the community assess progress of university student sponsor project and hostel students' education projects. This is successfully done with progress reports, from school head masters, hostel wardens, giving us account break downs of expenditures.

#### Achievements and performance

Tsunami Rehabilitation, also known as 'Sivan Arul Illam' in Sri Lanka has continued to work very hard in the past year with projects that would assist the needy in Vanni area and East, namely Muthur, Batticaloa & Akkaraipattu. We continue to rehabilitate families who are severely affected by the war. It is heart warming to see many of these families are able to manage their lives on their own with income derived from small scale business established for them through our financial assistance.

Our children home in Thiruketheeswaram, Mannar now have around 130 children, age range from 4 to 18 yrs). We have employed 21 staff, including carers, cooks, administrative officers, watchers, etc. The children attend the local Gowri Ambal School. We provide extra tuition for the core subjects. They enjoy the extra-curricular activities, including sports, music, dance, yoga, meditation etc. The children are taken on regular educational & leisure trips outside the home. They are given made to measure new clothes 3 to 4 times a year. 4 children have entered university this year & 10 children qualified to do A/L following recent O/L results. 7 children are studying in university. There were cries from many war affected families for assistance. We have so far rehabilitated over 4000 families by providing means to earn income and continue to provide monthly financial help to about 50 families with widows or paraplegics or amputees, mainly to educate their children. It is very gratifying to see how small regular contributions from us make a difference to the families and education of their children. There are many single mothers caring for their families particularly in Kilinochi & Mullaithivu district. Since they do not have skills to be engaged in a trade they continue to struggle to have 3 meals a day. So, many of their children are undernourished.

A women headed food processing factory has been built in Uruthirapuram, Kilinochi (known as Sivan Arul Vocational Training & Production Centre), to offer sustainable employment opportunities for needy females who are widows, disabled & unmarried. The ladies are now processing large quantities of rice flour, chilli powder, turmeric powder etc., and the main wholesale buyers are the traders in Kilinochi. We are also now exporting these spices to Australia, UK/Europe. We are now employing over 130 vulnerable people. There is also a women hostel attached to this factory, mainly accommodating disabled young women with disabled toilet facilities. They too are employed in the factory. There are around 20 young disabled living here.

We have opened a bakery in Puthukudiyiruppu to help the war affected disabled & vulnerable. This is providing them a sustainable livelihood. They are making bread, cakes, sweets, savoury short eats, buns etc selling them in a mobile van, taking large orders for weddings, parties etc. We are also exporting savouries and sweets abroad made in this bakery. We are employing 30, mostly, vulnerable young women. We have established a vocational Training, IT & Tuition Centre in Akkaraipattu, Amparai next to a girls orphanage. This is registered locally in the name of 'Sivan Arul Foundation'. This is to help the older girls in children home & vulnerable young girls in the local community to seek employment by training them in IT, Beauty therapy, sewing, handicraft, various food processing etc. Also, improving educational standards & encouraging deprived children to aim enter universities. Tuitions given in maths, English, tamil, Sinhala, science, & history. This project has already proved to be successful. We have completed NVQ Level 4, government approved 6 months course in graphic design & administration for the first batch and very pleased to say that all 20 young girls from the local, poor community have seek employment. We are soon going to complete the similar course for about 35 young girls & hope that they too will be successful in seeking jobs. Our recent GCSE results also has been very good for children attending our tuition centre.

We have also started a tuition centre in Olumadu-Nedunkeni, a very poor deprived part of Sri Lanka. This is called 'Sivan Arul Kalvinilayam'. There are over 250 poor children benefiting free tuition in science, maths, English, history, tamil & IT. The recent scholarship exam results for Grade 5 & GCSE O/L results were record breaking & quite exceptional for this year and they have never had this success

in the past, apparently in this particular village. We have made children, teachers & parents very proud by this great achievement. We motivate the keen children in this area to aim for

higher education & university entrance. This project sponsored by a well wisher in UK, for the past 2 ½ years.

We are also very grateful to Aadhi Parasakthi Valipattu Mandram, Harrow, UK for providing financial assistances to help our children in Thiruketheeswaram Sivan Arul Illam, providing special meals for them, giving money to deposit in their savings account. They also assist with our other projects, in Kilinochi factory, Puthukudiyiruppu bakery etc The Aadhi Parasakthi Mandram also sponsors regular special meals to the poor, undernourished in the community in Vanni and special meals regularly to the children home.. They also sponsor monthly, supporting many university students, educating many destitute orphan children and helping many families with setting up suitable livelihoods. Their support to our organisation is invaluable for the past 10 years & we cannot sustain without their financial assistances. Aadhi Parasakthi Valipaattu Mandram, Harrow, UK also carries out a large education development project helping over 50 students in Vanni , including university students to achieve good/ higher education in order to seek, &

also donating a large sum of money in re-building lives, mostly in the East of Sri Lanka. Their main focus is on building numerous wells for drinking water, cultivation etc. Also building numerous houses for very poor families living in huts. They also help several families to set up livelihood projects which are sustainable. They also build numerous toilets for poor community. Ratnam Foundation Trust , UK are supporting many projects, including Akkaraipattu IT centre ( successful in giving employment for the first batch of 20 poor girls who completed the government approved course), St Xavier school, Aligambai scholarship classes for Grade 5. In fact one of the students got top marks in the last scholarship exam through these classes and received an award for best performance ever from this very poor, deprived area. IT centre in Jaffna through CCYE., IT centre in Nedunkerny etc

#### New Projects

We have opened a pure vegetarian restaurant, called 'SriRudram'in Thiruketheeswaram, Mannar, employing our own children in the children home. Also offering employment for local community. Next to this we have built a mini factory to produce seasonal authentic food items, such as palmyrah jam, cordial , pinattu, pulukodiyal, odiyil flour, Kassava flour, lime pickle, moor milakai, vadakam etc. We also sell all our factory & bakery products in the restaurant, with a small outlet to showcase all our products ( rice flour, Jaffna curry powder, pakkora, kassava chips, ginger biscuits & many more!!!!) There have built 4 luxury rooms with attached toilets built which would attract temple worshipers from abroad & other tourist. These business ventures we believe will generate income for the vulnerable group of the community to have stable livelihood. . We are also targeting children from very poor villages in upcountry to give them an opportunity to have good education which they never had before. We have established a tuition centre & preschool for 200 children in Galkantha, Haputalla (Bandarawala). These children have shown a significant progress, enthusiasm in this program. This is sponsored by a well-wisher in UK, in memory of his late father & the Tuition Centre is called ' Late Mr M. Sathasivam Sivan Arul Kalvinilayam' We have secured 6 acres government land on long term lease ( over 30 yr period, renewable ) under the name of children home, located fairly close the children home . We have planted 400 coconut plants in this land in order to give children sustainable income in about 3 yrs. Mean time we are gNrowing all the vegetables which otherwise would be bought in the market, fruits etc for daily consumption for the children. The older children participate in the development gives them a form of recreation, therapy & hobby to keep them self-active & occupied during their holidays & free time. We are building around 10 houses in this land for our older children with no parents or family. We believe that they will become self reliant over a period of time, starting their own families and will continue to help other needy children and families. We have also secured further 10 acres of government land in Palampitty, Madu district. There is another farm donated to us in Mavittapuram. This also cultivates vegetables, rearing cows to sell milk and chicken poultry to sell eggs. It offers employment for local community. The income generated is supporting our children in education . We have invested a large sum mainly in the east of Sri Lanka, on revolving fund interest free loanprojects e.g. Goat rearing

chicken poultry for 5 families in Kachikudiyaru, cultivation of ground nuts, ubuntu & cowpea for 60

families in Kanchirankuda, Kanchikudiyaru & Kanagar Kiramam (farmers) , sewing machines for 10 vulnerable ladies in Vivekanadapuram . We have given 6 motor water pumps and long feeding pipes to promote cultivation in Aandankulam & Katumurivu, in Batticaloa. The farmers will repay the cost of the water pumps. This will be an integrated farm, with rearing goats, cows, chicken poultry and vegetables. This provides employment to the vulnerable, poor, local community. The income generated will also be shared with our children home, for their day-to-day expenses. We have completed goat rearing program in Vaharai- Batticaloa district & Akkaraipattu for 20 women headed families by giving them each 4 to 5 goats as a lucrative livelihood. We are successfully cultivating vegetables, ground nut, rearing over 30 goats, egg laying chicken poultry farming 3 acres land in Kannagipuram, giving employment for local community, including a leprosy victim who is the care taker. We have also built a house for this family within our farm. The proceeds are sold in the local market & some of the profits are used for the running of our tuition centre in Akkaraipattu. We are also cultivating another 3 acres land in Neenakerny in Muthur district to help the poor community. We are about to start a multipurpose community centre in our land here to conduct after school educational, sports activities, Aranery & recreation for elderly who are begging on streets for living. After school activities are also going to be conducted in 3 other centres in Muthur, (Seethanaveli, Paattalipuram & Santhosapuram), mainly to motivate children many of whom are not attending schools due to poverty, lack of interest from parents. We are also constructing many simple, drinking, bathing water wells in Batticaloa & Amparai district where there are many poor villages without drinking, bathing water & toilet facilities. We are also supplying 'Saththuma' nutritional powder free, for about 1700 pre-school & primary school children in Vanni & East where there is extreme poverty & malnutrition. We started this program 4 years ago & our studies have proved them to be very useful, making a positive impact on the performance, growth & school attendance of these children We have introduced a unique education program for our 4 tuition centres across the country, in Mannar, in our children home ( Sivan Arul Illam), Olumadu-Nedunkerny, Sivan Arul Kalvinilayam, Upcountry, in Bandarawala, ( Late Mr Sathasivam Memorial Education Centre) & Akkaraipattu, Sivan Arul Foundation. This is known as e-learning using, tablets (for individual students), projector/screen/ laptop in groups for grade 10 & 11 , following the syllabus, in English, maths & science. We believe this would help improve educational standards of children living in poverty-stricken areas. This is sponsored by Jaffna University Graduate Association, Victoria- Australia.

We are truly grateful to all donors; without their support it would not be possible to continue with all our projects.



#### **1. General information**

The charity is a public benefit entity and a private company limited by guarantee, registered in England and Wales and a registered charity in England and Wales. The address of the registered office is 2 Monkams Lane, Woodford Green, Essex, IG8 0NL.

#### **2. Statement of compliance**

These financial statements have been prepared in compliance with FRS 102, 'The Financial Reporting Standard applicable in the UK and the Republic of Ireland', the Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (Charities SORP (FRS 102)) and the Companies Act 2006.

#### **3. Accounting policies**

##### **Basis of preparation**

The financial statements have been prepared on the historical cost basis, as modified by the revaluation of certain financial assets and liabilities and investment properties measured at fair value through income or expenditure.

The financial statements are prepared in sterling, which is the functional currency of the entity.

##### **Going concern**

The charity is treated as a going concern as there is a foundation of regular donators who will continue to donate money.

##### **Judgements and key sources of estimation uncertainty**

The preparation of the financial statements requires management to make judgements, estimates and assumptions that affect the amounts reported. These estimates and judgements are continually reviewed and are based on experience and other factors, including expectations of future events that are believed to be reasonable under the circumstances.

The judgements (apart from those involving estimations) that management has made in the process of applying the entity's accounting policies and that have the most significant effect on the amounts recognised in the financial statements are as follows:

Regular donators will continue to make contributions in the future. The trustees will continue to find new individuals/organisations that will donate money.

##### **Fund accounting**

Unrestricted funds are available for use at the discretion of the trustees to further any of the charity's purposes.

Designated funds are unrestricted funds earmarked by the trustees for particular future project or commitment.

Restricted funds are subjected to restrictions on their expenditure declared by the donor or through the terms of an appeal, and fall into one of two sub-classes: restricted income funds or endowment funds.

#### 3. Accounting policies *(continued)*

##### Incoming resources

All incoming resources are included in the statement of financial activities when entitlement has passed to the charity; it is probable that the economic benefits associated with the transaction will flow to the charity and the amount can be reliably measured. The following specific policies are applied to particular categories of income:

- income from donations or grants is recognised when there is evidence of entitlement to the gift, receipt is probable and its amount can be measured reliably.
- legacy income is recognised when receipt is probable and entitlement is established.
- income from donated goods is measured at the fair value of the goods unless this is impractical to measure reliably, in which case the value is derived from the cost to the donor or the estimated resale value. Donated facilities and services are recognised in the accounts when received if the value can be reliably measured. No amounts are included for the contribution of general volunteers.
- income from contracts for the supply of services is recognised with the delivery of the contracted service. This is classified as unrestricted funds unless there is a contractual requirement for it to be spent on a particular purpose and returned if unspent, in which case it may be regarded as restricted.

##### Resources expended

Expenditure is recognised on an accruals basis as a liability is incurred. Expenditure includes any VAT which cannot be fully recovered, and is classified under headings of the statement of financial activities to which it relates:

- expenditure on raising funds includes the costs of all fundraising activities, events, non-charitable trading activities, and the sale of donated goods.
- expenditure on charitable activities includes all costs incurred by a charity in undertaking activities that further its charitable aims for the benefit of its beneficiaries, including those support costs and costs relating to the governance of the charity apportioned to charitable activities.
- other expenditure includes all expenditure that is neither related to raising funds for the charity nor part of its expenditure on charitable activities.

All costs are allocated to expenditure categories reflecting the use of the resource. Direct costs attributable to a single activity are allocated directly to that activity. Shared costs are apportioned between the activities they contribute to on a reasonable, justifiable and consistent basis.

##### Financial instruments

A financial asset or a financial liability is recognised only when the charity becomes a party to the contractual provisions of the instrument.

Basic financial instruments are initially recognised at the amount receivable or payable including any related transaction costs.

##### Financial instruments *(continued)*

Current assets and current liabilities are subsequently measured at the cash or other consideration expected to be paid or received and not discounted.

Debt instruments are subsequently measured at amortised cost.

Where investments in shares are publicly traded or their fair value can otherwise be measured reliably, the investment is subsequently measured at fair value with changes in fair value recognised in income and expenditure. All other such investments are subsequently measured at cost less impairment.

Other financial instruments, including derivatives, are initially recognised at fair value, unless payment for an asset is deferred beyond normal business terms or financed at a rate of interest that is not a market rate, in which case the asset is measured at the present value of the future payments discounted at a market rate of interest for a similar debt instrument.

Other financial instruments are subsequently measured at fair value, with any changes recognised in the statement of financial activities, with the exception of hedging instruments in a designated hedging relationship.

Financial assets that are measured at cost or amortised cost are reviewed for objective evidence of impairment at the end of each reporting date. If there is objective evidence of impairment, an impairment loss is recognised under the appropriate heading in the statement of financial activities in which the initial gain was recognised.

For all equity instruments regardless of significance, and other financial assets that are individually significant, these are assessed individually for impairment. Other financial assets are either assessed individually or grouped on the basis of similar credit risk characteristics.

Any reversals of impairment are recognised immediately, to the extent that the reversal does not result in a carrying amount of the financial asset that exceeds what the carrying amount would have been had the impairment not previously been recognised.

##### Defined contribution plans

Contributions to defined contribution plans are recognised as an expense in the period in which the related service is provided. Prepaid contributions are recognised as an asset to the extent that the prepayment will lead to a reduction in future payments or a cash refund.

When contributions are not expected to be settled wholly within 12 months of the end of the reporting date in which the employees render the related service, the liability is measured on a discounted present value basis. The unwinding of the discount is recognised as an expense in the period in which it arises.

#### 4. Limited by guarantee

There is no guarantee of members and no liability for members; the charity only spends money received through donation and does not borrow any money.
