THE RELIEF OF POVERTY HARDSHIP AND DISTRESS, AMONG VULNERABLE AFRICAN CHILDREN, THEIR FAMILIES AND COMMUNITIES IN NEED BY, BUT NOT LIMITED TO, THE PROVISION OF SERVICES, AND OR FINANCIAL AND MATERIAL ASSISTANCE IN MATTERS RELATED TO THE ADVANCEMENT OF HEALTH, EDUCATION AND EMPLOYMENT BY FACILITATING ACCESS TO OTHER SUPPORT PROVIDERS AND SERVICES FOR PUBLIC BENEFIT.2. THE PROVISION, IN THE INTEREST OF SOCIAL WELFARE, OF FACILITIES FOR RECREATION OR LEISURE TIME OCCUPATION AMONG THE BENEFICIARIES WITH THE OBJECT OF IMPROVING THEIR CONDITIONS OF LIFE. 3. TO ADVANCE THE EDUCATION OF THE UK PUBLIC IN ISSUES AFFECTING AFRICA, INCLUDING BUT NOT BY WAY OF LIMITATION THE SUBJECT OF 'FAMINE' AND ASSOCIATED DANGERS, BY PUBLIC LECTURES AND OUTREACH PROJECTS AT SCHOOLS, COLLEGES, UNIVERSITIES AND OTHER VENUES.
