Trustees Report

Objectives

To relieve poverty and distress, preserve and protect good health, and advance the education and employment of BME communities in the United Kingdom. We provide advice, information, and assistance to empower local people, improve lives, and help them overcome barriers to independent learning, employment, and preventing homelessness, particularly among BME communities, including refugees and asylum seekers.

Trustees' Report for the year ended 31 Aug 2021

Introduction This report covers the activities and service provision of I Serve for the year ending August 2021. It includes summaries of services provided, with statistics to illustrate our achievements. This year has been marked by development and change, as we have continued to build on our existing good work.

Structure, Governance, and Management

Legal Structure Established in 2003, I Serve operates as a registered Charity (No. 1110682).

Organisational Structure The board of trustees is composed of a minimum of five trustees, with no upper limit. The board meets regularly to discuss development, finance, and effective operations and project delivery. Trustees are responsible for policy formulation, legal compliance, and pursuing the charity's objectives.

Induction and Training of Trustees New trustees are briefed on their legal obligations under charity law, the governing document, the committee and decision-making process, the business plan, and recent financial performance. They receive publications from the Charity Commission, including guidance on charities and public benefit. Trustees are committed to staying informed about developments in charity governance under the Charities Act.

Trustees' Responsibilities Trustees are tasked with identifying and reviewing risks to which the charity is exposed and ensuring appropriate controls are in place to provide reasonable assurance against fraud and errors. They oversee the preparation of financial statements and select suitable accounting policies.

Volunteers The charity relies heavily on the voluntary work of trustees and other volunteers for administering funds and community work. This volunteer work, while invaluable, is not reflected in the financial statements.

Financial Review

Reserves Policy The charity currently operates with minimal reserves. The trustees aim to build up the donor base to maintain reserves equivalent to three months' operating expenditure, excluding grant-funded project expenditures.

Principal Funding Sources The charity's primary income sources are donations and grants, including funding from the European Union, British Council, and Ecorys.

Core Values

- **Impartiality:** Decisions are based on objective criteria, free from bias, tribalism, prejudice, or preferences.
- **Credibility:** We earn respect and trust through programs with tangible outcomes, sharing lessons learned and achievements.
- **Transparency:** We ensure timely and reliable disclosure of our financial performance.
- **Commitment:** We are committed to long-term efforts to resolve tribal conflicts and social inequality and promote tolerant and inclusive societies.

Strategic Priorities 2020-23

- **Encouraging Dialogue:** Creating spaces for dialogue to build cohesive and harmonious societies by connecting people from different clans, tribes, and nations affected by tribal conflicts.
- **Fostering Tolerance:** Organizing seminars, reconciliation conferences, trainings, and events to challenge hate speech, recognize racism and radicalization, and promote understanding and tolerance.
- **Young Influencers:** Training 80 young leaders over two years to become role models and influence positive community changes.
- **Advocacy:** Initiating campaigns to advocate for marginalized communities, formulating recommendations for stakeholders, and working with affected communities.
- **Mental Health Program:** Providing knowledge and skills to young workers to support multidisciplinary teams and non-formal education practices in mental health.
- **Research:** Collaborating with academics and universities to identify the root causes of poverty and developing publications to better serve communities and address tribal differences.

Achievements 2020/2021

- **Employment Program:** Over 200 individuals aged 16-30 participated, developing interpersonal, practical, and life skills, enhancing their visibility within the community, and raising awareness of mental health maintenance.
- **Mental Health Program:** Supporting young workers to work in multidisciplinary teams with health professionals.
- **Housing Related Support:** Prevented hospital admissions, prolonged lives, signposted to specialist services, and offered hope to those with nowhere else to turn.
- **Tolerance Program:** Encouraged tolerance among young people, helping over 80 participants understand intolerance, labeling of migrants, refugees, and marginalized groups.

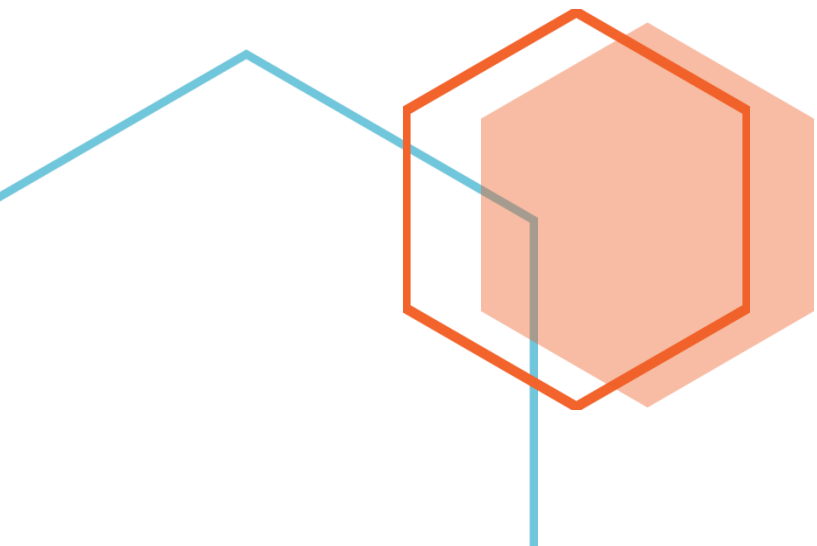

Governance and Management

Legal structure

I Serve have been established on 2003 when a constitution was adopted, I Serve operates as a registered Charity (No. 1110682).

Organisational Structure

The board of trustee is not subject to maximum trustees but there must always be a minimum of five trustees. The board meets regularly to discuss development, finance and to facilitate effective operations and the delivery of projects. The trustees are responsible for policy formulation and ensuring that the organisation complies with its legal obligations and pursues its objectives.

Induction and training of trustees

New trustees are invited to a trustee meeting to brief them of their legal obligations under the charity law, the content of the governing document, the committee and decision making process, the business plan and recent financial performance of the charity. A number of publications from charity commission are provided including the guidance on charities and public benefit. Trustees are aware of their responsibilities to keep abreast of development in relation to the governance of charities under Charities Act.

Trustees' responsibilities

The trustees have a duty to identify and review the risk to which the charity is exposed and to ensure appropriate controls are in place to provide reasonable assurance against fraud and errors.

Volunteers

Use of volunteers the charity is dependent on the voluntary work of the trustees and other volunteers in administering its funds and carrying out its community work. As this work has no tangible value this is not recognized in the financial statement

Financial Review Reserves policy:

The charity currently operates with minimal reserves. The trustees are endeavoring to build up its donor base with a view to having reserves of three months' operating expenditure, excluding expenditure coming from grants for projects.

Risk(s) review:

The trustees have recently reviewed the major risks faced by the charity. This has resulted in efforts to look for funds to employ a youth co-coordinator, funding & finance manager in order to increase charity's donor base and to finalize the health and safety review.

Principal funding sources The charity's main sources of income are payments in relation to the supply of donations and grants. The charity received funding from the European Union , British Council and Ecorys

Our core values

Impartiality - We believe to base our decisions on objective criteria, rather than on the basis of bias, tribalism, prejudice or preferences.

Credibility - We believe to earn respect and trust through our programmes with tangible outcomes by sharing lesson learnt and achievements.

Transparent -We believe too timely and reliably disclosure I Serve financial performance.

Commitment - We believe to achieve societies free from tribalism and inequalities take time. That's why we make long-term commitments to people to resolve tribal conflicts and social inequality and promote tolerant and inclusive societies.

Our strategic Priorities 2019-22

Encouraging Dialogue - Creating space for dialogue is essential in order to build cohesive and harmonize societies. We connect people from different clans, tribes, nations, affected by the same tribal conflict, enabling them to talk about tribalism and its impacts. Through dialogue we are able to build confidence and trust, collaborations between the different communities.

Foster Tolerance - We will work with partners to organise seminars, reconciliation conferences, trainings and events. These challenge existing hate speech, to provide tools to recognize racism and radicalization stereotypes and promote understanding, tolerance awareness of peaceful ways to resolve conflicts. They help both outsiders and tribal communities better understand the complexities of each situation.

Young Influencer - Over the next Two years, we will train 80 young leaders to become role models, influence change that benefits their communities and the wider society, to become bridgeheads



enabling other young people to follow in their footsteps and to provide strategic leadership that ensures the voice and needs of their communities are represented at all levels of public decision-making.

Advocacy - We will undertake number of initiatives and campaigns to advocate for the communities we serve including marginalized groups to build understandings to the challenges they face, We do this by formulating recommendations to stakeholders by working with effected communities and individuals.

Our Mental Health program: Through the actions of Mental Health Education, we will provide a set of knowledge and skills to young workers so as to enable them to work in multidisciplinary teams in the network with health professionals, bringing in very institutionalized contexts, tools and practices of education non-formal in supporting young people with mental illness.

Research - We will collaborate with academics and universities to identify the root causes of poverty,. Through the findings of the researches, we develop publications for schools, policy makers, public bodies and institutions to enable them better serve those communities and counter the misuse of tribal differences.

Achievement 2019/2020

In 2019/20, I Serve undertook a number of projects, initiatives and campaigns. The projects and initiatives we have been working on this year are as follows:

- Over 200 individual 16-30 participated (Erasmus Program) Through these activity participants developed many skills which will enhance their visibility within the community. These included inter-personal skills, practical skills such as planning, organisational, life-skills including teamwork, communication and leadership skills. They also enhanced coping skills and became more aware of ways to maintain positive mental health.
- **Our Mental Health program:** Through the actions of Mental Health Education, we want to provide a set of knowledge and skills to young workers so as to enable them to work in multidisciplinary teams in the network with health professionals, bringing in very institutionalized contexts, tools and practices of education non-formal in supporting young people with mental illness.
- **Housing Related Support:** Through the support offered, we have prevented hospital admission, prolonged lives, signposted to specialist services at an early stage and offered hope to these people who have had nowhere else to turn
- **Tolerance Program:** Encouraged tolerance among youngsters, to prevent hate speech, to provide tools to recognize racism and radicalization and to understand how they occur,– over 80 young people took part of this project and gave young people a better understanding of intolerance, labeling of migrants, refugees and marginalized groups.
