I have been appointed to the position of independent examiner for Ramsey St Mary's Village Trust.

As the clerk/ financial officer for Ramsey Welfare Charities I have knowledge of charity accounting.

I confirm that I have no direct connection to Ramsey St Mary's Village Trust.

The charity is eligible to have an independent examination as their income is over the threshold of £25,000 but under the higher threshold of £250,000.

Ramsey St Mary's Village Trust is a small charity and generally the annual income is well under the lower limit of £25,000. However following the building of a number of new properties in the village recently the village became entitled to CIL payments from Huntingdonshire District Council(HDC).

The charity were awarded a grant from Huntingdonshire District Council, reference CIL2020/036, of £47,136.00 to construct a vehicle access and a car park to serve Ramsey St Mary's community recreation ground.


I have viewed the work, which was carried out by L4 Civil Engineering. The invoice for £43,087.26 for the work was received 22<sup>nd</sup> September 2022. This amount was paid on 13<sup>th</sup> October following receipt of the same amount from HDC on 3<sup>rd</sup> October.

I have seen the agreement from Huntingdonshire District Council, the invoice from L4 Civil Engineering Ltd and the minutes of the trustee's meetings relating to the work. All documentation is in order.

I have checked the full annual accounts for the charity for 2022 and found them to be in order.

I am fully satisfied that all information is genuine and accurate.
