## NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 31 DECEMBER 2022

### 1. ACCOUNTING POLICIES

#### **Basis of Preparation**

The financial statements of the charity, which is a public benefit entity, have been prepared in accordance with the Charities Act 2011 on a Receipts and Payments basis.

The financial statements are presented in sterling which is the functional currency of the charity.

#### **Fixed asset investment**

Fixed asset investment is stated at the trustees' valuation.

#### **Fund Accounting**

Income which can only be used for restricted purposes, and its related expenditure, is accounted for as restricted funds. All other income and expenditure is accounted for as general funds.

#### **Taxation**

No provision is made in the financial statements for taxation as the Trustees are of the opinion that all of the Trust's activities are of a charitable nature and therefore outside the scope of taxation.

### 2. RELATED PARTY TRANSACTIONS

The fixed asset investment represents a holding of unquoted shares in WCR Group Limited, a company controlled by W J Record.

3. Neither the Trustees, nor any persons connected with them, have received any remuneration or expenses during the year.
