Objects: The Charity's objects (Objects) are for the benefit of the public generally in the Area of Benefit to: Provide activities and/or facilities that promote physical and mental health and social integration amongst members of the community. For the purpose of Article 4 the term facilities shall include land, buildings, equipment and organized activities.

The charity provides activities that enable people to improve their physical, mental and social health, feel integrated within their community and develop skills that will benefit them throughout life.
