Both project managers have visited the boatyard regularly to monitor the progress and quality of the restoration work being carried out. Talks about the Restoration of Susan and the significance of the Navigation in the development of Chelmsford have been given to local interest groups via the internet and Zoom. Recordings of some of these talks can be viewed at any time by accessing the library on the main IWA website. Articles and progress reports have been published in magazines and newsletters produced by local organisations.

Achievements against objectives set	Para 1.41	The original estimate for the Restoration of Susan dated 03 August 2010 was £100000. Since then, a change in government legislation resulted in registered charities being unable to reclaim the VAT that had been paid. This increased the cost of restoration by £30000. Removal of the outside planking revealed that additional timbers needed to be replaced. This plus inflation increased the final estimate to £245000. The total money raised by 05 April 2022 was £238767.
Performance of fundraising activities against objectives set	Para 1.41	Fundraising has proved to be more difficult than expected because of the effects of the COVID19 pandemic and the current economic climate of our country. Many grant giving trusts are now unable to support heritage projects because of the increasing needs for social welfare work.



