British Friends of Orr Shalom Annual Report for 2023

During the year we received substantial donations from two long standing supporters of Orr Shalom which were forwarded to Orr Shalom. We also continued to receive monthly donations from the Embrace A Child initiative which generated £3,660. We are hugely grateful to our supporters.

We have held discussions with Orr Shalom in Israel to find innovative, different, ways of raising funds which do not rely upon holding events. The time necessarily required and the cost associated with organising events is, we find, disproportionate to the sums raised albeit that it raises awareness. We are agreed that we need to pool our resources with Orr Shalom to achieve more together.

At the time of writing Israel has seen and is continuing to see the most horrific attacks on its civilians which have resulted in more deaths than at any time since the Holocaust. The resultant events unfolding are devastating for both Israelis and Palestinians. More children than ever require trauma therapy, care, and much more besides. We shall be working with Orr Shalom to try to make a small difference to some children's lives.

We started the year with a bank balance of £6,248. Our overall income for calendar year 2022 was £36,600. We sent a total of £33,500 to Orr Shalom in Israel in 2022 leaving a reserve carried forward of £9,358.




