The trustees who are also directors of the charity for the purposes of the Companies Act 2006, present their report with the financial statements of the charity for the year ended 31 March 2023. The trustees have adopted the provisions of Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019).

OBJECTIVES AND ACTIVITIES

Objectives and Activities

The Charity is constituted as a company limited by guarantee, and is therefore governed by a memorandum and articles of association.

ACHIEVEMENT AND PERFORMANCE

During the year, grants of £862 (2022: £580) were made for building projects. Other significant donations were made for Poor, Needy and Elderly £nil (2022: £49,207), Other donations and grants £89,057 (2022: £17,602). Full details of the charity's performance are shown on page 4 of the accounts. In the opinion of the trustees, the charity has performed well during the year.

FINANCIAL REVIEW

During the year, the charity received donations and investment income totalling £104,997 (2022: £48,504) and paid out grants, donations and other expenses totalling £91,991 (2022: £69,513). The net surplus after charging overheads was £13,006 (2022: £21,009 deficit) and this is carried forward to the following year.

STRUCTURE, GOVERNANCE AND MANAGEMENT

The charity is a company limited by guarantee and it is registered with the Charities Commission under the registration number of 1112670.





Basis of preparing the financial statements

The financial statements of the charitable company, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Companies Act 2006.
