Objects: OBJECT 1: UNDER THE RECREATIONAL CHARITIES ACT 1958- TO PROMOTE, PROVIDE OR ASSIST IN THE PROVISION OF FACILITIES FOR THE PUBLIC AT LARGE WITHIN THE UNITED KINGDOM FOR RECREATION OR OTHER LEISURE TIME OCCUPATION OF INDIVIDUALS WHO HAVE NEED OF SUCH FACILITIES BY REASON OF THEIR YOUTH, AGE, INFIRMITY OR DISABLEMENT, FINANCIAL HARDSHIP OR SOCIAL OR ECONOMIC CIRCUMSTANCES IN THE INTERESTS OF SOCIAL WELFARE AND WITH THE OBJECT OF IMPROVING THE CONDITION OF LIFE OF SUCH INDIVIDUALS.OBJECT 2: RELIEF OF FINANCIAL HARDSHIP- THE RELIEF OF FINANCIAL HARDSHIP EITHER GENERALLY OF INDIVIDUALLY BY PROVIDING OR MAKING GRANTS OF MONEY FOR PROVIDING OR PAYING FOR ITEMS, SERVICES OR FACILITIES FOR THE RELIEF OF THE POOR, OR PROMOTING THOSE OBJECTS.

Activities: Raising funds for therapeutic breaks and other therapeutic support for individuals and families in need of it for reasons of financial hardship or illness or disability.
