Objectives, Activities, Achievements & Performance

<p>Summary of the purposes of the charity as set out in its governing document</p>	<p>To manage the Old School Hall for the benefit of the community of Llandyssil. To facilitate the renovation and improvement of the Hall better to meet the needs of current users by improving the facilities, to provide sustainability and to attract new users and greater community involvement.</p> <p>To encourage and provide access for all in the community to engage in stimulating creative, social, leisure, educational and health-promoting activities and support mental and physical well-being.</p> <p>To develop and encourage the sharing and development of talents, to learn new skills, which could include sharing the skills of members of the local community or by inviting creative people into the community. To ensure that the Constitution, Health and Safety, Environmental, and Safeguarding Policies including Equal Opportunities are supported both in principle and in action.</p> <p>Expenses Policy: The Trustees have during 'Lockdown' approved and introduced an Expenses Policy.</p> <p>Meetings: The Trustees have met regularly and safely during the period of Lockdown. However, it was not possible to hold an AGM or to meet with the wider community via the internet, Zoom etc., as many residents do not have access to the internet.</p>
<p>Summary of the main activities in relation to those purposes for the public benefit, in particular, the activities, projects or services identified in the accounts.</p>	<p>The Charity provides a place where the community can socialise, learn and stay both mentally and physically well. We organise a wide range of social activities e.g. coffee morning, quizzes, talks, Film and Race nights etc. In addition the Hall is hired at a very rate economic to groups such as Line Dancers, Yoga, Pilates, Craft, Women's and Gardening Groups etc. The Hall is used by the Statutory Sector for meetings, community consultation and for National & Local elections. In addition we organise the annual Dragonfest in September, a day of entertainment for everyone, which is our biggest fundraiser. We also manage and run a Llandysill Website and produce a quarterly newsletter which is delivered to every home.</p> <p>Village Survey: The Trustees distributed a Village Survey asking all residents what they wanted to 'happen' in the Village Hall. We were disappointed with the response but did receive some suggestions which we are in the process of introducing.</p> <p>During Lockdown: The Trustees erected an additional notice board to inform the community of the help available to them in terms of shopping, deliveries of food and prescriptions. We also contacted local businesses asking them to deliver essential items to the Village. Information was published on our Website and in the Newsletter. In addition, we have set up an email contact list to let people know what was happening. We hope to extend this list in the coming year.</p> <p>The Old School Hall Renovation: During Lockdown The Trustees took the opportunity to</p>

	<p>renovate the Old School Hall, this included: Internal and External Painting. Purchase of additional cleaning equipment, Hoover, floor scrubber, waste bins, etc. Removal of unwanted items. Deep cleaning the Hall. Carrying out a Covid Risk Assessment and purchasing items that would protect the public. New internal and external Notice Boards.</p> <p>Caretaking and Cleaning: The Trustees had a contract with the Caretaker who works on a self-employed basis. It was agreed that we change this job description to that of taking bookings, opening & closing the Hall, removal of rubbish and maintaining the outside areas, grass cutting etc. When we reopened it was agreed to allocate the internal cleaning of the Hall to another contractor, who would ensure that the Hall be sanitised after each booking. This arrangement has worked well but adds to our costs considerably.</p> <p>Old School Hall Picture Gallery: It was agreed that Lockdown provided the ideal opportunity to decorate the walls of the Hall with pictures and photos depicting the rich history of our community.</p>
Statement confirming whether the trustees have had regard to the guidance issued by the Charity Commission on public benefit	<p>The Trustees are aware of their responsibilities in regard to the Charity Commission.</p> <p>Trustees Information Pack: We produced an Information Pack for both new and prospective Trustees in February 2021.</p>

Additional information

Policy on social investment including program related investment	This issue has been discussed many times at meetings, however, it has been decided not to pursue this any further, especially as our reserves are diminishing due to Lockdown.
Contribution made by volunteers	The huge contribution made by our many volunteers cannot be over-estimated. Llandyssil is an isolated area with no bus service, no village shop, no village pub and above the national average of older people. In fact, we depend entirely on our volunteers to run many activities.
Other	The decision to close the Hall due to the Coronavirus Pandemic was made by the Trustees at the end of March 2020. The Trustees then appealed for additional volunteers to help provide direct services to the Community. Happily, many people came forward offering assistance with shopping, prescriptions etc.

Coronavirus	The Pandemic has meant that we have been unable to open from March 2020. The Hall is relatively small and

	cannot be used safely. This has meant that we lost all rental income and have been unable to carry out any fundraising activities.

Review of the charity's financial position at the end of the period	At the end of the period we had in excess of £42,461.07 in the current, savings and Lottery accounts. (we successfully applied for £14,000 Coronavirus Grant Aid via Powys County Council)
Statement explaining the policy for holding reserves stating why they are held	We were aware that we needed to carry out extensive and costly internal and external work and to purchase much needed equipment for the Hall. We plan to use some of our reserves to improve the Hall during the shutdown period.
Amount of reserves held	£30,000 as at September 2021
Explanation of any uncertainties about the charity continuing as a going concern	In our last report we aired concerns over the shortage of Trustees. We are pleased to report that we have now recruited 2 new Trustees.

The charity's principal sources of funds (including any fundraising)	Rental income, fundraising events including Dragonfest. However, during the period we have been unable to rent the Hall or to carry out any fundraising events (with the exception of the Llandyssil Lottery).
