**INDEPENDENT EXAMINER'S REPORT TO THE TRUSTEES OF TRINITY AMATEUR OPERATIC SOCIETY
for the year ended 31 May 2024**

I report on the accounts of the Charity (registration number 1113493) for the year ended 31 May 2024, which are set out later on in this report.

Respective responsibilities of trustees and examiner

The charity's trustees are responsible for the preparation of the accounts.
