Activities: The charity's objects are the protection, conservation and enhancement of the environment and heritage of that part of north-west Oxfordshire known as the Enstone Uplands and District. The charity aims to contribute to the Local development Plan process, to monitor all planning applications and to develop working relationships with environmental and conservation groups.
