FOR THE BENEFIT OF THE PUBLIC AND IN PARTICULAR FOR THE BENEFIT OF THOSE MEMBERS OF THE PUBLIC WHO ARE BOSNIAN OR OF BOSNIAN DESCENT LIVING IN THE UNITED KINGDOM WITHOUT DISTINCTION OF RACE, POLITICAL, RELIGIOUS OR OTHER OPINIONS BY ASSOCIATING VOLUNTARY ORGANISATIONS AND MEMBERS OF THE PUBLIC IN A COMMON EFFORT TO RELIEVE POVERTY, TO ADVANCE EDUCATION BY PROVIDING AND ASSISTING IN THE PROVISION OF FACILITIES FOR PRE-SCHOOL AND SCHOOL EDUCATION AND SO AS TO ENABLE BOSNIANS OR THOSE OF BOSNIAN DESCENT TO GAIN EMPLOYMENT AND INTEGRATE THEM INTO SOCIETY, TO PROVIDE AND ASSIST IN THE PROVISION OF FACILITIES FOR RECREATION AND LEISURE TIME OCCUPATION IN THE INTERESTS OF SOCIAL WELFARE AND WITH THE OBJECT OF IMPROVING THE CONDITIONS OF LIFE OF MEMBERS OF THE PUBLIC AND TO PROMOTE EQUALITY AND DIVERSITY BETWEEN BOSNIANS AND PERSONS OF OTHER ETHNIC OR RACIAL GROUPS.2. THE FUND SHALL BE NON-PARTY IN POLITICS AND NON-SECTARIAN IN RELIGION
