"LEARNING DISABILITY" MEANS ANY DEVELOPMENTAL DISABILITY OF THE MIND AND ANY ASSOCIATED CONDITION HOWSOEVER CAUSED AND WHETHER MILD, MODERATE OR SEVERE.

**Activities:** The Mowbray Gateway Club provides a safe place for adults with learning disabilities and additional needs to get together to enjoy social ,leisure and sporting activities.
