**Objects:** A) TO PROMOTE AND ASSIST THE WORK AND PURPOSES OF THE CHURCH OF ENGLAND FOR THE ADVANCEMENT OF THE CHRISTIAN RELIGION IN THE UNITED KINGDOM AND TO ORGANISE AND PROVIDE FUNDS IN AID OF THE WORK OF THE CHURCH IN FURTHERANCE OF THE OBJECTS HEREINAFTER CONTAINED.B) TO MAINTAIN THE DOCTRINE AND WORSHIP OF THE CHURCH OF ENGLAND AS SET FORTH IN ITS HISTORIC FORMULARIES.C) TO EXTEND ASSISTANCE IN THEIR PAROCHIAL OR OTHER WORK TO CLERGY WHO ARE IN SYMPATHY WITH THE PRINCIPLES OF THE CHURCH OF ENGLAND TO MAKE PROVISION FOR NECESSITOUS CLERGY, THEIR WIDOWS, CHILDREN, OR OTHER DEPARTMENTS; AND IN OTHER WAYS TO SET FORWARD, AID, OR MAINTAIN IN WHOLE OR IN PART WORKS OF PIETY AND CHARITY IN CONNECTION WITH THE CHURCH OF ENGLAND AND THE MEMBERS THEREOF.

**Activities:** Trustees are involved in the affairs of the Church of England, primarily the making of parochial appointments. Trustees also administer a number of smaller charitable trusts.
