Governing Document

The Charity is governed in accordance with the constitution dated June 1996 which was subsequently amended and approved by the members at the general meeting held on 11 February 2020.

Objects of the Charity

The objects of the Charity are the preservation, repair, maintenance and improvement of the building, fixtures and fittings of the Parish Church of St Mary and All Saints' Checkley in the Diocese of Lichfield.

Policies of the Charity

In furtherance of the objects of the Charity the trustees may:

- Raise funds by any lawful activity or means and receive contributions by way of subscriptions or donations but may not undertake permanent trading activities.
- Make grants to the clergy, churchwardens and the Parochial Church Council of Checkley Church for the purpose of the object of the Charity.
- Invest monies not immediately required as thought fit and proper.

It is considered appropriate that the grants of money are made for specific projects that are undertaken by or on behalf of the Church. Some of these projects require large capital sums and the monies may therefore be accumulated over a period of time before being applied to the project.

Activities and future plans

The Coronavirus Pandemic has again caused severe disruption to the fundraising activities of the Friends of Checkley Church during the past 12 months, and it has not been possible to hold any fundraising activities.

However, it is pleasing to report that the membership numbers have increased to 89, the highest that it has been for at least a decade. We have also been fortunate to have received a large bequest from the Will of our late secretary, Margaret Johnson. There are no immediate plans to spend the money, but it is good to know that we now have reserves should the need arise.

Despite the lack of fundraising The Friends have still been able to assist the Church with donations made towards an upgrade of the audio/visual system, £1,668, and to the repair of the tie-rods for the south aisle stonework, £3,855.

If you are not yet a member of "The Friends of Checkley Church" but would like to help with the fund raising, the subscription is £5 for the year. All money raised goes to the maintenance of our beautiful church. Please contact our treasurer, James Wood for more details. His address is shown above.

1. Fundraising Events

Due to the covid pandemic no fundraising events took place during 2021. In 2020 there was a joint the Mary, Queen of Scots Evening which was a joint fundraising event with Croxden PCC which earned a net surplus for The Friends of £698.

2. Legacy

During the year a legacy amounting to £70,585 was received from the Estate of the late Mrs Margaret Johnson.

2. Other Monetary Assets

At 31 December 2020 and 2021 the charity had no other monetary assets other than those shown at the foot of the Receipts and Payments Account.

3. Funds Raised for Charities

Most years a Village Christmas Night is held to raise funds for selected charities. Regrettably, due to the Coronavirus Pandemic, no Village Night could be held in December 2021.

4. Basis of Accounting

These accounts have been prepared on a Receipts and Payments basis which recognises income and expenditure as the cash transaction takes place. No adjustment has been made for accruals or prepayments within these accounts.
