Notes to the Financial Statements for the year ended 31 December 2023

1. Accounting Policies

Accounting Convention

The financial statements have been prepared under the historical cost convention, modified by the depreciation of fixed assets, and in accordance with the Statement of Recommended Practice entitled "Financial Reporting Standard 102".

Company Status

The Company (company no 5676444, charity no 1115278) is a company limited by guarantee. The members of the Company are the Directors named as Trustees on Page 1 of the Report of the Trustees, to which these statements are attached. In the event of the Company being wound up, the liability in respect of the guarantee is limited to £1 per member of the Company.

Depreciation

The fixed asset (a piano situated in Priors Hall, Winchester) is depreciated at 5% per annum.

Income

All incoming resources are included when the Company is legally entitled to the income and the amount can be quantified with reasonable accuracy.

Resources expended

All expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all costs related to the category. Where costs cannot be attributed directly to particular headings they have been allocated to activities consistent with the use of resources. Governance costs are those relating to the Company's compliance with constitutional and statutory requirements.

Reserves

Restricted funds are to be used for specified purposes as laid down by the donor. Expenditure meeting these criteria is identified to the fund, together with a fair allocation of support costs. Unrestricted funds are made up of donations and other income received or generated for the furtherance of the objects of the Company without further specified purpose, and are available as general resources.

2. Staff Costs

There were no staff costs incurred in the year. No remuneration or expenses were paid to Directors nor to the Independent Examiner.

Basis of Independent Examiner's Statement


