### **Trustee Annual Report, YE 31 March 2021**

#### **STRUCTURE & MANAGEMENT**

##### **Charitable Incorporated Organisation**

Together for Sheffield was registered by the Charity Commission on 24th of June 2006 as Sheffield Cross Links. On November 13<sup>th</sup> 2019 the declaration of trust was amended and the charity was renamed 'Together for Sheffield'.

##### *Governance and management*

The charity is governed by its trustees, the minimum number at any one time being three. The trustees comprise of professionals, church leaders and philanthropists from across Sheffield.

The charity employs a Chief Executive Officer and an Operations Director. Furthermore there are plans to hire a Communications and Events Manager in the next financial year. Day to day running of the charity is carried out by this team alongside a growing network of volunteers and contractors.

##### *Public benefit*

The trustees have given due regard to guidance published by the Charity Commission in respect of public benefit when fulfilling the objectives of the charity.

##### *Objectives*

The object of the charity is for the public benefit - the advancement of the Christian faith in Sheffield, through facilitating meetings and gatherings and the sharing of information resources across the churches in the Sheffield area. Providing charitable covering for city-wide Christian initiatives.

#### **ACTIVITIES**

This year of activity for Together for Sheffield has been a year of significant growth and development.

*Finances* – During 2020/2021 the Charity continued to receive from key donors as well as running a successful crowdfunding campaign to support the 'Arise Sheffield' project. We have not seen the downturn in donations that many have experienced throughout the Covid pandemic.

*Office* – The charity has established an office space for meetings and day to day work in Stannington, Sheffield. Throughout the various lockdown periods, employees and team members chose to work remotely from home offices, or in a hybrid manner.

*Unity work* - The charity continues to facilitate and manage the budget of multiple initiatives that fit under its banner.

*City wide initiatives*- The foundation of our work is the person of Jesus Christ. We are unapologetic in our allegiance to him. We observe that he moves towards the marginalised, and therefore we seek to do the same.

##### *Together for Food Provision Network*

In response to the Covid-19 pandemic, the Together for Food Provision Network was launched at the end of March 2020. This is attended by food aid providers, Sheffield City Council representatives, advice agencies and other relevant agencies from across the city.

The network seek to tackle food insecurity in Sheffield by:

1. Fostering cohesion and cooperation between different food aid networks, local authority and related agencies in Sheffield.
2. Addressing the source of food poverty and inspiring best practice through themed weekly discussions.
3. Supporting coordination of city-wide emergency food provision (e.g. especially during Covid-19 pandemic).
4. Working as a collective to have a greater impact through lobbying local government and messaging, e.g. collecting supply/demand statistics.

#### *Sharing resources and information*

Together for Sheffield's sharing of resources and information across churches, charities, and groups in the city, has led to a number of charitable partnerships as well as employment due to connections made. Meanwhile, the CEO of the charity has been invited several times to share via radio about social action, city wide work and Jesus.

*Together for Schools* - Over 1300 care packages have been sent to teachers across Sheffield to thank them for their hard work during the pandemic.

*Sheffield Business Leaders Network* - Has continued to meet online throughout the pandemic.

*Together in Prayer* - This network has continued to grow and is putting plans in place for cross-city gatherings. The aim of this network is to connect Christians across the city who pray, with relevant prayer requests from those of all faiths and none.

*Arise Sheffield* - A city wide prayer and action initiative was launched with support from across denominations in Sheffield. Over 1200 people across 150 churches in Sheffield took part and this initiative helped gain a new level of recognition for the Charity.

*Kickstart* - TFS has become a Gateway for the Kickstart Scheme in Sheffield, in addition it has developed a unique training programme to run alongside the scheme, to improve employment prospects and provide mentoring.

#### **Plans for future periods**

The plans for 2021/2022 will involve a continued focus on Social Action, Empowering Leaders and Evangelism. We hope to continue the growth and momentum the charity has achieved this year.

#### **Thanking volunteers**

Finally on behalf of the trustees, we would like to thank the volunteers who worked through a particularly difficult year. Without their vision, contribution and support we would not be able to support those in our city who need it most.
