Objects: THE TRUSTEES MUST APPLY THE INCOME OF THE CHARITY IN FURTHERANCE OF ADVANCING THE EDUCATION AND TRAINING OF YOUNG WOMEN IN LESOTHO, IN PARTICULAR BUT NOT EXCLUSIVELY BY:-(I) WORKING IN PARTNERSHIP WITH PARENTS IN ANY WAY DEEMED CHARITABLE IN LAW;(II) CONTRIBUTING PRIMARILY TOWARDS SECONDARY EDUCATION SCHOOL FEES AND SUBJECT TO AVAILABILITY OF FUNDS, FURTHER EDUCATION;(III) SUPPORTING WOMEN IN THEIR ROLE AS CARERS BY CONTRIBUTING TOWARDS RESOURCES TO ENHANCE THIS ROLE AND RAISING AWARENESS OF THE PARTICULAR DIFFICULTIES FACED BY WOMEN IN LESOTHO, IN GAINING ACCESS TO SCHOOL OR ADVANCED EDUCATION AND THE IMPACT THIS HAS ON COMMUNITIES AS A WHOLE

Activities: Educational support: Educare works in partnership with families to support girls complete high school education. The charity pays part of the school fees and the family pays the rest. This way families retain a stake in their child's education. This support is aimed at bright young women to enable them to gain access to university level education or better job opportunities.
