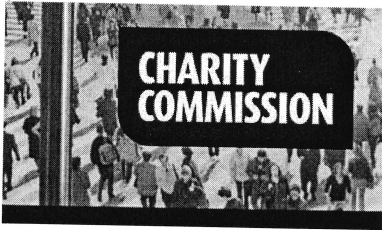

The above period was an unusual year for our Rotary Club and the receipts to the Charity Trust Fund registered with the Charity Commission. Previously we have not reached the threshold of £25,000 receipts. However in the above year we had a number of exceptional fund raising events for a registered charity, Class Rooms in the Clouds, Charity No. 1170522, <https://www.citcnepal.org/>. This is a charity that funds schools and teachers in rural areas of Nepal. As a Club we ran a number of sponsored events and the majority of the funds raised came through "GiveasYouLive". These are restricted funds and linked to a Global International Rotary Grant Application which is progressing through the application process. Rotary International will match the funds raised by our Club. It is anticipated that the grant application will be processed in this financial year and the restricted funds for this project transferred to Nepal.

Otherwise, our receipts and payments were similar to our usual activity. A copy of the accounts for the above period are attached.


Independent examiner's statement
