Review of the charity's financial position at the end of the period	Para 1.21	Details of Income and Expenditure are given on the Statement of Financial Activities within the financial statements. Total incoming resources decreased by £112,740 to £161,990 (2019: £274,730). The allocation of the charity's expenditure decreased by £22,654 to £248,480 from the previous year (2019: £271,134). The total unrestricted funds as at 31 December 2020 amounted to £121,085 (2019: £207,575).

Amount of reserves held	Para 1.22	The trustees consider that given the nature of the work of the charity and assuming that the charity's activities continue at the current levels, this should equate to approximately six months of the resources expended, which during 2020 amounted to approximately £124,000. This should provide adequate working capital for the charity's core costs. The free reserves at 31 December 2020 are £121,085 (2019: £207,575) and the trustees are satisfied that this level of reserves is sufficient to meet the needs of the charity.

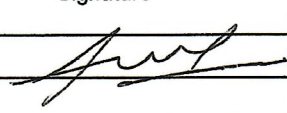
