Activities: The Association provides help to those in need by reason of being sick, housebound, aged or disabled. We provide a voluntary car service for transport to clinics, hospitals, health centres, dentists and other medical facilities; a visitor service for lonely or housebound; assistance in the collection of prescriptions.
