TO ADVANCE EDUCATION AND TRAINING OF SUCH PERSONS; AND C. TO RELIEVE THE UNEMPLOYMENT OF SUCH PERSONS.

We primarily work with children and young people in sport and creative arts and with the wider community in regeneration, skills training, empowerment and advocacy issues. We also specialise in housing and the social housing environment.
