TO SECURE THE MAINTENANCE AND DEVELOPMENT OF A COMMUNITY HALL AND TO EQUIP AND MANAGE THE SAME WHETHER ALONE OR IN COOPERATION WITH ANY LOCAL AUTHORITY OR PERSON OR BODY) IN FURTHERANCE OF THESE OBJECTS; C. TO PROMOTE SUCH OTHER CHARITABLE PURPOSES AS MAY FROM TIME TO TIME BE DETERMINED.
